Permits are not transferable between persons or locations, except to an immediate family member. **Permits are valid July 1 – June 30 the following year.** Permit fees are not prorated for partial license years. Pierce County Public Health Department may inspect premises at any reasonable time. Missing information may delay the issuance of your permit. You are not permitted to operate until Pierce County Public Health Department conducts an inspection. The undersigned hereby certifies that this is a true, complete and accurate application for the establishment permit under Wis. Stat. 97.30.

*All facilities shall have an inspection annually.

*Note: Permit renewal payments not received by **July 15th** will be charged a **\$250** late fee.
