

**APPROVED MINUTES OF  
PIERCE COUNTY BOARD OF SUPERVISORS  
Tuesday – November 12, 2024 • 9:00 a.m.**

**1a)** Meeting called to order by Chairman J. Aubart at 9:00 a.m., in the County Board Room at the Pierce County Courthouse & via Zoom.

**2a)** A quorum was established with roll call by County Clerk J. Feuerhelm acknowledging 16 supervisors present & 1 excused (N. Maxwell).

**2b)** **Adopt Agenda:** Motion by J. Kosin/S. Bjork to adopt the agenda as presented; motion carried unanimously.

**3)** **Pledge of Allegiance to the Flag** led by Supervisor A. Claflin.

**4)** **Public Comment on Issues Not Related to Agenda Items:**  
• Resident K. Converse requested assistance with getting a more accurate count of deceased veterans throughout the County. He also expressed concern about kiosks for jail inmates & the responsiveness of jail staff.

**5)** **Presentation:** F. Schelfhout shared information regarding the State of Wisconsin's efforts to work "diligently to formally designate the approximately 250 miles of the Mississippi River Trail (MRT) which generally follows the Wisconsin Great River Road, Highway 35". A formal resolution supporting such will be sought in the future, once local municipal resolutions are adopted.

**6)** **Public Hearing on 2025 County Budget:** Chairman J. Aubart opened the public hearing for the 2025 Pierce County Budget at 9:30 a.m. Chairman J. Aubart called for questions or comments on the 2025 Budget. No comments were presented. Chairman Aubart declared the public hearing on 2025 Pierce County Budget closed at 9:31 a.m.

**7a)** **Resolution No. 24-24 Authorization Approving Alteration of County Board Supervisory Districts 7 & 8 Pursuant to City of River Falls Annexation of Property in the Town of River Falls.** Motion by M. Kahlow/S. Bjork to suspend the rules to waive reading of resolution; motion carried unanimously. Corp Counsel B. Lawrence explained that the City of River Falls annexed some property from the Town of River Falls subsequent to the 2020 census redistricting. The County has two options in that it can alter the Supervisory District, or it could deny the City's request & they would need to create a new aldermanic district. He further explained that because the current description of the Supervisory District states the boundary to be the City limits, the legal description for the district in the County's ordinance would not change. Motion by M. Kahlow/D. Bergseng to approve Resolution 24-24 as presented; motion carried unanimously by voice vote.

**7b)** **Resolution No. 24-25 Claims for Listing Dogs.** Motion by M. Kahlow/S. Bjork to suspend the rules to waive reading of resolution; motion carried unanimously. Motion by M. Kahlow/R. Wood to approve Resolution 24-25 as presented; motion carried unanimously by voice vote.

7c) **Resolution No. 24-26 Care of Soldiers' Graves.** Motion by M. Kahlow/S. Bjork to suspend the rules to waive reading of resolution; motion carried unanimously. Motion by M. Pittman/M. Kahlow to approve Resolution 24-26 as presented; motion carried unanimously by roll call vote.

Pittman indicated that though opposed to the increase for library reimbursement he was in favor of the budget overall. Motion to approve carried unanimously by roll call vote.
