In consideration of being permitted the use of a neighborhood vehicle or utility terrain vehicle on streets of the City of Pinckneyville, Perry County, Illinois, Releasor, for himself/herself and his/her personal representatives, assigns, heirs, and next of kin, releases, waives, discharges, and covenants not to sue the City of Pinckneyville, Perry County, Illinois, its officers, agents, and employees, all hereinafter for convenience referred to as "Releasees", from all liability to the Releasor, his/her personal representatives, assigns, heirs, and next of kin, for all loss or damage, or any claim or damage therefor, on account of injury to the person or property, or resulting in the death of Releasor, whether caused by the alleged conditions of the City streets or the negligence of any party resulting from, or occurring by reason of, Releasor's operation of, or occurring while the Releasor is operating, a neighborhood or utility vehicle on roadways under the jurisdiction of the City of Pinckneyville, Perry County, Illinois.

Releasor agrees to indemnify Releasees, and each of them, from any loss, liability, damage, or cost Releasees may incur due to the operation by Releasor of a neighborhood or utility terrain vehicle within the corporate limits of the City of Pinckneyville, Perry County, Illinois.

Releasor agrees that this release, waiver, and indemnity is intended to be as broad and inclusive as permitted by the laws of the State of Illinois, and if any portion of this release is held invalid, it is agreed that the balance will, notwithstanding, continue in full force and effect.

Releasor, being of lawful age, in consideration being permitted to operate a neighborhood or utility terrain vehicle on roadways under the jurisdiction of the City of Pinckneyville, Perry County, Illinois, does for himself/herself, his/her personal representatives, assigns, heirs, and next of kin, hereby release and forever discharge Releasees of and from any and every claim, demand, action, or right of action, of whatsoever kind or nature, either in law or in equity, arising from or because of any bodily injury or personal injury, known or unknown, death and/or property damage resulting, or to result, from any accident which may occur as the result of Releasor's operation of a neighborhood or utility terrain vehicle within the corporate limits of the City of Pinckneyville, or any activities in

connection with such use, whether by negligence or other cause.

Releasor further states that he/she has carefully read the above Release, knows the contents of the Release, and signs this Release as his/her own free act. Releasor further acknowledges that the terms of this Release are contractual and not a mere recital.
