## **Committee Reports**

<u>Councilman Blass</u> – Councilman Blass reported that he attended the Friends of the Library's Teddy Bear Picnic on June 10. Children were able to make a stuffed animal and decorate a t-shirt for their animal to wear. Mrs. Forte, as always, did a great job with the children.

This Thursday, June 25, the Pitman Recreation Commission and the Friends of the Grove are sponsoring a

Family Picnic from 5:00 p.m. - 8:30 p.m. on the grounds around the Grove Auditorium. The evening will conclude with a concert performed by the Hobo Band.

The Pitman Memorabilia Museum was open on Saturday, June 13, at which time Councilwoman Higbee and Councilman Blass received the donation of a C. W. Kersey lard tin from the Dole Family. Mr. Kersey was a butcher in Pitman, and in the early 1900's, hogs would be brought by train and then taken to his slaughterhouse located on Delsea Drive.

The Museum will be open again this Friday during the Fourth Friday event, from 5:30 p.m. to 7:30 p.m.

The Pitman Board of Education will meet this Wednesday, June 24, at 7:30 p.m. in the Pitman High School Library.

<u>Councilman Razze</u> – Councilman Razze congratulated Parade Grand Marshal Gene Shoemaker, and thanked Ed Ewan for his many years of service in the armed forces, and to the Borough of Pitman. He read the following report:

Approximately two-thirds of the parade participants have received emails with their line up information. Notification of the remaining participants will be finished by tonight. The total number of registrations is just under what we had last year, but more than in prior years.

The Economic Development Committee met last week, and among some of the topics discussed was a potential new tenant for the bakery, directional signage for parking to be going up around town, as well as some additional aesthetic projects to take place around town.

Chamber of Commerce President Lisa Morgey and I were invited by Jeff Sanders to a networking event called Dare Living Services, which was held on the deck of the Battleship New Jersey. I was with a group of developers and investors from around the region who were looking to invest in South Jersey. The topic of the panel discussion for the evening was Crowd Funding, which is the latest and greatest way to raise capital for projects. A lot of great ideas were shared at this event.

Earlier today I attended the TRICO Joint Insurance Fund meeting. There was a lot of business discussed, but the one main thing that jumped out at me was that they are looking at their largest dividend ever. Approximately \$1.125 million will be returned to the members of the fund.

Fireworks tickets are now available. We request a donation of \$3.00 per ticket to view the fireworks from within Alcyon Lake Park. We are limited to selling only 200 tickets. Tickets may be purchased at Borough Hall, Pitman Cards and Gifts, Investors Bank, and Main Street Investments. Also, I am hoping that I can count on members of Council on the Fourth of July to assist in any way.

Councilman Pierpont – Councilman Pierpont read the following report:

The Public Works Department is busy painting crosswalks and yellow curbs along Broadway, Pitman, and Ballard Avenues. Last week we utilized a work crew from the New Jersey Department of Corrections to get some of the crosswalks painted, and we will schedule more help as it becomes available.

The flowerbeds at the intersection of Broadway and Laurel Avenue, and Hazel and Montgomery Avenues were weeded and mulched.

The Highland Terrace paving project will be finished this week. Soft spots were repaired in the undercoat, and a finish coat of asphalt is next. This is a big improvement in the road surface and it also repaired the dip at the intersection of Columbia Avenue.

The abandoned property at 223 W. Holly Avenue was mowed by employees of our Public Works Department using our equipment and overtime man-hours.

The trash/bulk and recycling numbers for the period of June 8 - June 19 are as follows:

Ten loads of trash collected for a total of 132.9 tons

Ten loads of recycling collected for a total of 49.3 tons

Nine loads of bulk trash were collected

Nineteen loads of brush were collected

Forty yards of leaves were delivered to Smith Orchards for disposal

Ten loads of various mulch was delivered to Borough residents

A Borough dump truck was left at five different locations on various days for yard debris collection

<u>Councilwoman Higbee</u> – Councilwoman Higbee reported that an online reverse auction for electricity supply services for the Borough of Pitman will be held tomorrow at 11:00 a.m.

On June 11, the Historic Commission held their monthly meeting. Nine applications were submitted, and all were approved, some with minor changes to the original applications.

<u>Council President Kelley</u> – Council President Kelley reported that the Borough's Code Enforcement Officer continues to cite properties in the Borough for poor lawn maintenance and other issues. If no action is taken by the homeowner, he may authorize the Borough's Public Works Department to mow. A lien is then placed on the property in the amount of the labor that was paid to the workers who performed the service. This is an ongoing project, and will be reflected in some of the ordinances Council will be discussing this evening.

The Borough's Green Team will meet this Thursday night. A guest speaker will discuss the creation of bike paths throughout town.
