There was also discussion about the possibility of the commercial district no longer being part of historic. Also, there was discussion about the fence at 178 North being overturned by Borough Council.

• Roy Duffield, Zoning Officer submitted a list of zoning permits that had been applied for and open issues that he was addressing.

Mrs. Kelley stated that the garage on S. Broadway looked as though they had added exterior steps. She believes that the board had discussed that building not having steps. Roy stated that he would get the address and check it out.

There was then discussion of fencing issues within the Borough and the requirements of the current fence ordinance.

#### **Economic Development Committee:**

Chairman Aspras read a report submitted by Mr. Owen. There were questions previously about the Theater Ave. bollards. Chairman Aspras reported that they can only be removed for an emergency by emergency management personnel. Mrs. Stech reported that there are currently big orange blockades at the end of Theater Ave. and half of the way down to the park. They are very unattractive. But they

will stop traffic from coming down. Chairman Aspras stated that he would take that back to the EDC. He further reported that more Historic signs were put up and some of the planter signs will be replaced.

He then reported that Mayor Johnson and some members of Council would like to see the uptown business district removed from the Historic District.
