### **Police Department**

The School Resource Officers, Sgt. Leach & P/O Stefanopoulos have asked to remind everyone that school is back in session, and to please drive safely.

The members of the Pitman Police Department and Chief McAteer would like to thank Mayor and Council and all the residents for a fabulous 9-11 Ceremony. It is obvious that all First Responders receive much support from Mayor and Council and all the residents which we are very grateful for.

The entire PPD will receive Autism Awareness Training this month. This training will help the PPD to better assess and handle calls involving Autistic persons. Chief McAteer has made the training mandatory for all PPD officers and he has also invited the Pitman Fire Companies to attend.

Detective Nick Barbetta was nominated for the International Association of Chiefs of Police 40 Under 40 International Award. This award recognizes 40 Law Enforcement Personnel (in various positions) all Under the age of 40 that have accomplished a feat that is unusual, commendable, and brings awareness to the Law Enforcement profession. Det. Barbetta is the first person/officer to ever be nominated for the award from the PPD. Although he was not selected, his nomination remains current and will be considered in coming years.

Active Bystander for Law Enforcement (ABLE) is training with the aim of creating a police culture in which officers routinely intervene as necessary to prevent misconduct, avoid police mistakes, and promote officer health and wellness.

On August 31 there was a road failure on Elwood Avenue that the Streets and Roads crew had to excavate and repair.

Last week, Public Works employees applied a silicone based material to the McCowan Memorial Library's flat roof to help extend the life of the roof and to seal a small leak.

Pitman Public Works employees helped our neighbors in Wenonah after they were struck by a tornado. We had a loader there for several hours helping to clear roads and our two generator powered light fixtures were used overnight.

**Walt Madison 152 West Avenue** – Mr. Madison asked Council to recognize the owner of the Broadway Bakery who has daily been taking donuts to Mullica Hill for the volunteers and workers who are assisting in the tornado clean-up.

**Mark Papadopoulos 143 Glen Lake Boulevard** – Mr. Papadopoulos stated that Glen Lake is in “disarray” due to a crack in the dam, potholes in the street, raised sidewalks, and overgrowth along the banks. He said that the dam walls looks like it is going to fall and that the lake is not retaining water due to the crack in the dam. He stated his opinion that momentum for clean-up cannot get off the ground due to the change in Council Liaison every year or so.

Councilwoman James replied that she has been in contact with Mrs. Papadopoulos and understands the concerns about the property maintenance and the shoreline. She said that she is not aware of Mr. Papadopoulos’ statement that weeds were cut along one shoreline, and nothing else has been done, and said that she will follow up with the Director of the Parks and Recreation Department. Councilwoman James said that she has been to the lake several times in response to neighbor complaints and that she and Council President Blass will be meeting with the Borough Engineer to get an estimate on what needs to take place with the dam so that the Borough can budget for the repair.

Mr. Papadopoulos said that his complaint is that the residents have been asking for years to have this all taken care of, and it hasn't been done.

Councilwoman James said that she has been the Park and Recreation Liaison for just this year, and that she has commented and met on numerous occasions with people at the lake. She said that she would be happy to come out again and figure out what is going on. Also, the Shade Tree Commissioner has been out there and had tree people come and look at the area where the tree is growing in the wall of the dam, and this has been addressed. She said that she will certainly welcome the opportunity have another conversation with the Parks and Recreation Director and respond back to Mr. Papadopoulos on the discussion. Councilwoman James said that she cannot speak on what happened in the past but will take responsibility for it now and to make sure the concerns of the residents are addressed.

**Harry McCleish, 128 Glen Lake Avenue** - Mr. McCleish said that he agrees with the comments made by Mr. Papadopoulos about the conditions at the lake and surrounding areas. He said that he has been a resident at Glen Lake for eighteen years and said that no routine maintenance occurs, and that there seems to be a lack of caring from Council and Borough employees. He said that over the years there have been numerous meetings with Borough Officials and employees with no results coming from the meetings. He said that no upkeep outside of grass cutting has been done at the lake since the last meeting on October

24, 2020. Mr. McCleish asked when was the last time our elected officials have been to the lake? He said that Council should be following up with the department supervisors' performance.

Mr. McCleish showed photos to Council of how the lake looked in the past and the conditions now, noting specifically what he referred to as lack of care and proper maintenance, no trimming around the lake, and two trees that are dead and have not been removed.

Mayor Razze said that he recalled the discussion at the meeting last October where it was agreed that the weeds would be cut away and that the area around the trees would be maintained. However, Environmental Commission and Shade Tree guidelines the Borough can no longer clear cut at the lake.

Mr. McCleish asked Councilwoman Rudley and Councilwoman James who gave permission to have the work done on the Longmere side of the lake, pointing out that the area cleared is in Glassboro. Mr. McCleish commented on Councilwoman Rudley being responsive when he reached out to her with concerns and that the employees he observed were all good workers.

Councilman Weng asked if it was Mr. McCleish's opinion that what is needed is a large clean-up of the area overall? Mr. McCleish said that to get it back to where it was, that is what would be needed. He said that due to the lack of ongoing care, routine upkeep has become a mayor project.

Why do council members change their department after only one year, this is not good for management.

**Stephanie Zeitz, 300 Lincoln Avenue** – Ms. Zeitz said that she submitted variance paperwork for a fence and that it was her understanding that it would be discussed tonight, but it never came up on the agenda. She said that she was told by an employee in the Construction Office that it would be reviewed on September 13<sup>th</sup> at 7:00 p.m. She said that there has been a lot of paperwork done and a large amount of money spent in fees and notifying neighbors of their plans leading up to this point, and they have been in attendance for three hours waiting to be called on.

Councilman Fitzpatrick said that he would check to see if this is on the Planning and Zoning Board agenda for their next meeting and get in touch with her. Ms. Zeitz said that she followed the instructions she was given and that she should not have to readvertise the application and re-notify the residents on the 200 foot list again due to an error of the Borough.

Solicitor Krachun requested to document for the Council Meeting Minutes that Ms. Zeitz was present at this meeting and that no one is in attendance to respond to their variance request notification. He said that he will also pass this information on to the Planning and Zoning Board Solicitor to make him aware. As well.

Mayor Razze assured Ms. Zeitz that Mr. Krachun will check with the Planning and Zoning Board Solicitor to see if the fact that no one arrived at this meeting tonight to express concerns can help her move forward with her application, and to seek guidance on how to proceed going forward.

**Steve McKay, 108 Glen Lake Avenue** – Mr. McKay said that there were two fountains at the lake in the past and they are now none. He said that the fountains are important to the health of the lake and that he would like to see both working again.
