**1) Application 2063 Robert Bosch PUD Amendment**

Jana Radtke, Comm. Dev. Dir./Planner, reviewed the request and the recommended conditions for the PUD amendment which would include construction of a temporary modular building to be used as transitional space while a Phase 2 permanent building is built on the site.

John Mirsky, Andrew Wolf, and Kim Lindsay of Robert Bosch LLC and Gerald Philo of Harley Ellis Devereaux Project Management answered questions. The discussion included traffic flow onto Haggerty and Five Mile Roads, requirements of the PUD, additional language in the conditions, and drafting an agreement to establish steps that will take place if conditions are not met.

Moved by Mr. Mann, seconded by Mr. Edwards, to postpone Application 2063, Robert Bosch PUD Amendment, until the Board of Trustees regular meeting of December 13, 2011. Ayes all.

**2) Modification to Consent Judgment for Plymouth Square Plaza**

Mrs. Radtke and Mr. Anulewicz reviewed the request and plans for redevelopment. The applicant proposes to include the Big Boy and Bank of America sites into the Consent Judgment area. Plans include the expansion of the existing Kroger store, relocation of some existing on-site retail, and redevelopment of the Bank of America site into a Kroger kiosk gas station.

Adam Crain, Kroger Project Manager, Rich Cragdale, Sr. Manager of Kroger of Michigan and a representative of the owners of the property addressed the Board and answered questions.

Attorney Cronin indicated a new signature page is needed which shows places for the Supervisor and Clerk to sign on behalf of the Township.

Moved by Ms. Arnold, seconded by Mr. Mann, to approve the Stipulated Third Amendment to the Consent Judgment and Tentative Site Plan for the Plymouth Square Plaza, located southwest of Sheldon and Ann Arbor Roads, and authorize the Township Supervisor and Clerk to sign said document, subject to the Township Attorney receiving sufficient evidence that Allstate Development Enterprises LLC has title to the Big Boy parcel. Ayes all on a roll call vote.

**3) Ordinance Addressing Floodplain Management  
Ordinance Number C-2011-08  
First reading**

Attorney Cronin indicated this National Flood Insurance Program model ordinance is required by FEMA with an effective date of February 2, 2012 in order for Township residents to continue to be allowed to buy flood insurance.

Moved by Ms. Arnold, seconded by Mr. Edwards, to approve the first reading of Ordinance No. C-2011-08, the Floodplain Management Ordinance. Ayes all on a roll call vote.

**4) Petition for Special Assessment Ballot Proposal**

Mr. Cronin reviewed the court proceedings regarding the petitions and the Township's filing of an interlocutory appeal. He received an opinion from John Bauckham, a legal expert with the Michigan Townships Association, who reviewed validity of the "Petition for Special Assessment Ballot Proposal" and the validity of any ballot question requested to be submitted to the township electors by said petition. Special assessment procedures are controlled by PA 33 of 1951.
