2) Request for Board Action - Agreement to Assign DWSD Agreement to GLWA

Mr. Jim Fausone of the Board of Water Commissioners gave a presentation on the recent lease agreement between the Great Lakes Water Authority (GLWA) and the City of Detroit Water and System. The proposed agreement is the City's request for Plymouth Township to consent to the City's assignment of its rights and obligations under the Water Service Contract to the GLWA.

Moved by Mr. Curmi and seconded by Mr. Edwards to approve the assignment of the Wholesale Customer Water Service Contract from the City of Detroit Water and Sewer Department to the Great Lakes Water Authority. Ayes all.

3) Review of Equitable Sharing Program Audit

Mr. Joe Heffernan of Plante and Moran and Board members reviewed the findings of the Department of Justice in their audit of the Department of Justice Equitable Sharing Program Fund, commonly known as Federal Drug Forfeiture Fund.

The Board recessed briefly at 9:24 p.m. and returned to session at 9:28 p.m.

4) Discussion - Board vacancy

Board members reviewed their options for filling the vacancy on the Board for the remainder of Trustee Arnold's term. If no replacement is found within 45 days of her passing, the County Clerk calls for an election.

Suggestions were made to accept resumes with interviews for three chosen candidates; make an appointment, possibly of someone who has formerly served as Supervisor and on the Board or of someone currently serving on the Planning Commission or Zoning Board of Appeals; or to offer the post to the next highest vote-getter in the 2012 primary election.

It was agreed to return on Tuesday, October 27, at 6 p.m. with all options on the table.

K. SUPERVISOR AND TRUSTEE COMMENTS

Mr. Curmi had questions regarding ES&A status and start-up of the one-man recycling trucks. Mr. Doroshewitz reiterated asking for those who were invited to the fireworks party and was not pleased that he received the list of donor companies. He also had questions regarding how to place items on the agenda. Ms. Conzelman urged people to vote on the Schoolcraft College millage issue on November 3.
