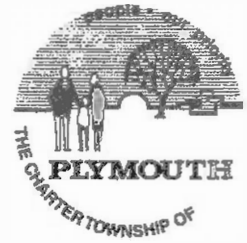



I am familiar with Roberts rules in your bi monthly meetings


