2) APPROVAL OF THE OCTOBER 12, 2020 AGENDA
Members unanimously approved the agenda.

3) ENACTMENT OF THE CONSENT AGENDA
a) Approval of the August 20, 2020 Meeting Minutes
Members unanimously approved the minutes of the regular meeting of August 20, 2020.

4) BOARD MEMBER COMMENTS – There were none.

5) NEW BUSINESS

a) Demo without permits –*Jack Dempsey*

J. Dempsey informed members of the passage of Ordinance 1016, Amendment 26, by the Board of Trustees which deals with his concerns about having a proper demolition process. This ordinance provides for sanctions for unpermitted demolition.

D. Cebulski suggested the possibility of using the funds from the sanctions for historical purposes.

b) Sculptures at St. John’s –*Dennis Cebulski*

D. Cebulski reported on his research with Dale Carlson, co-author of “Carlotto Carducci, a Field Guide to Detroit’s Architectural Sculptures” concerning the sculptures done at St. John’s by Carducci. Also working with Carducci was Andrew Malia, a mosaic artist.

d) Historic Resources Survey – *Wendy Harless*

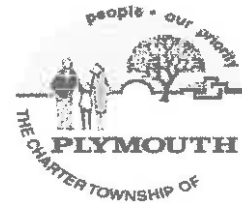
