The program is set up on a first-come, first-serve basis. Only completed application packets will be reviewed.

ELIGIBILITY

You must be a homeowner with your primary residence located in the City of Red Bluff in need of repair or rehabilitation to apply for this program.

Find the number of people in your household on the chart below. If the total income of ALL the adults is at or less than the income listed you may be eligible.

This information is preliminary. You must document **ALL** income. Income will be counted for **ALL** adults in the household, all individuals 18 years and older. PROGRAM LOAN TERMS AND DETAILS

Loan Terms:

- 2% interest rate
- ♦ 30 year loan term

The OOR loan program is offered to homeowners with incomes that fall at or below the limits on page 2. Homes must be in need of major rehabilitation or have a significant health and safety code violation. Rehabilitation projects may include lead based paint inspection and removal, roof replacement, energy efficiency improvements, and much more. Please contact our office for further details regarding your potential needs.

At the project's completion the home must comply with all local and state health, safety, and building codes.
