Proponents for the proposed expansion of homeless services at 1445 Vista Way have requested that City Council approve a Resolution allowing on-street parking adjacent to their facility in the Airport Industrial Park, see attached Exhibit A. City Council, by resolution, can change parking regulations from time to time, see Exhibit B. If approved by Council, proponents will not seek to implement on-street parking allowance until the new facility is in operation. Should expansion of services not proceed the new regulations will not be valid.

**RESOLUTION NO.**

**RESOLUTION ESTABLISHING LIMITED PARKING IN A NO PARKING ZONE ON A  
PORTION OF VISTA WAY**

**WHEREAS**, Section 13.26, of the Red Bluff City Municipal Code authorizes the City Council, by resolution, from time to time, as traffic conditions warrant, change or remove existing zones; and

**WHEREAS**, "No Parking" is considered one of these zones; and

**WHEREAS**, the City has received a request from the proponents for the proposed Navigation Center at 1445 Vista Way, Red Bluff CA to allow restricted on-street parking adjacent to the proposed facility; and

**WHEREAS**, restrictions include passenger vehicles only, no truck parking, limited to the hours of 7:30 a.m. to 5:30 p.m.; and

**WHEREAS**, the City finds that traffic conditions at this location justify allowing restricted on-street parking;

**NOW THEREFORE, BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF RED BLUFF:** hereby allowing restricted on-street parking on the south side of Vista Way beginning 15 feet east of the existing driveway for 1455 Vista Way, extending 120 feet to the east where it would terminate 15 feet prior to the driveway at 1445 Vista Way, resuming 15 feet east of the existing mailbox and continuing 80 feet to the east where it would again terminate 15 feet prior to the existing fire hydrant.

The foregoing resolution was adopted at a regular meeting of the City Council of the City of Red Bluff held on April 16, 2019, by the following vote:

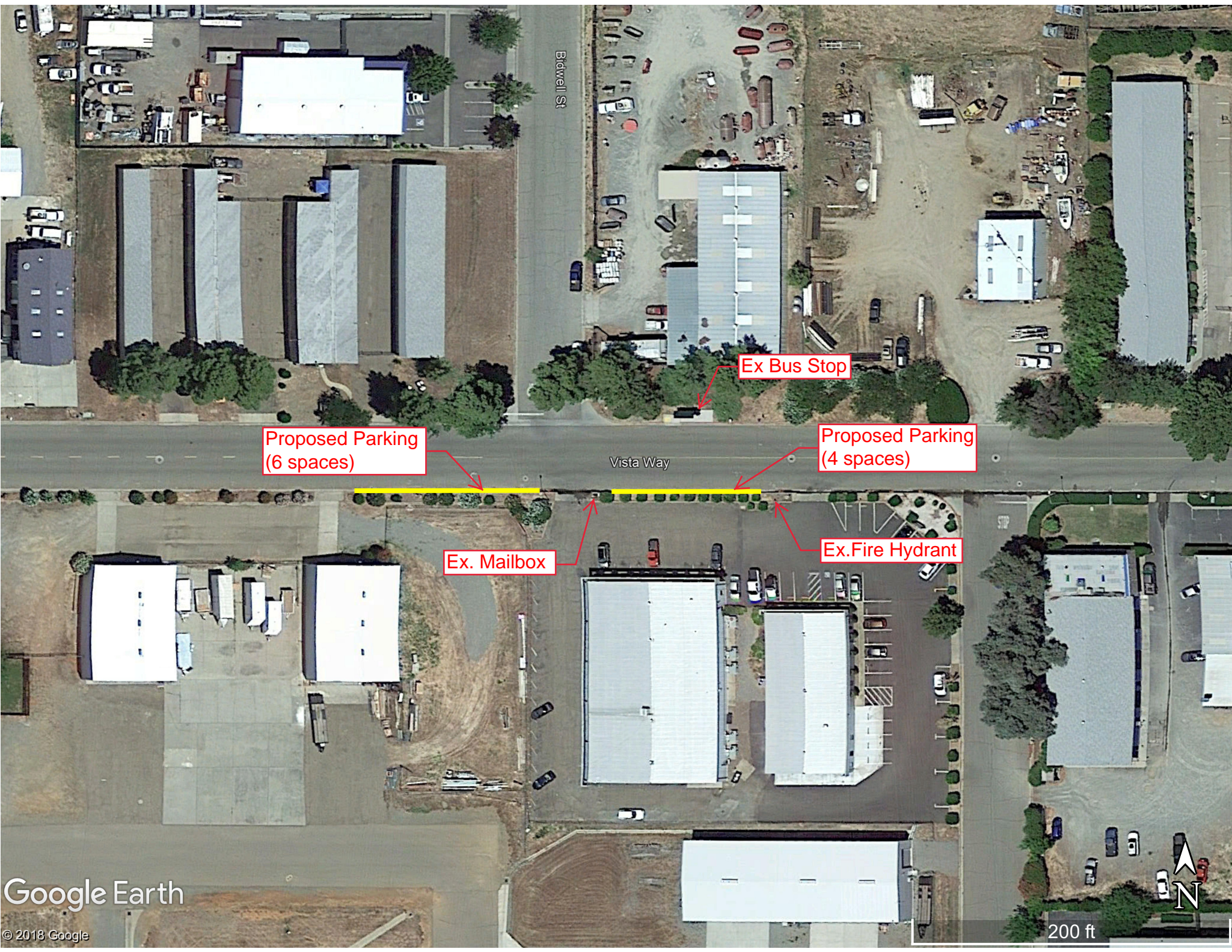

## Red Bluff, CA Code of Ordinances

### **§ 13.26 CHANGING REGULATIONS GENERALLY.**

The City Council may, by resolution, from time to time designate as traffic conditions warrant additional parts of the public streets of the city to be zoned as herein provided and it shall be the duty of the Director of the California Department of Transportation to cause the same to be painted in the color designated by the City Council. The City Council may, by resolution from time to time, as traffic conditions warrant, change or remove existing zones.
