On November 25th, the City received an Opportunity to Comment letter for a "proposed" charter school to be located at 1600 Monroe Street, Red Bluff, see attached **Exhibit A**. Currently, the site operates as Lava Charter School and has previously operated in the same capacity as Sacramento Discovery School, under private sponsorship, since 2008. Conversations with Antelope Elementary School District staff reveal that the District has been operating utilizing the site since 2016 but is now in the process of purchasing the property from private ownership. Subject: Proposed Charter School Located Within Nautical Two Miles of a Runway (Education Code 17215)

Antelope Elementary School District in Red Bluff, California, has notified the California Department of Education (CDE) that it is proposing a site for future use as a charter school to be known as Lassen-Antelope Volcanic Academy. This proposed charter school location will serve 125 students in grades 5-8. Lassen-Antelope Volcanic Academy is located in Tehama County. The site address is 1660 Monroe Street, Red Bluff, CA 96080. Coordinates to the center of parcel # 029-131-16-1 is (40°11'01.64"N, 122°14'42.73"W). The school district is planning on purchasing both parcels 029-131-16-1 and 029-131-12-1.

The Red Bluff Municipal Airport is located at Airport Blvd Red Bluff, CA 96080 and is 1.6 nautical miles to the south west of the proposed site. Therefore, the site is located within two nautical miles of an airport runway.







