#### WELCOME MESSAGE FROM THE CHIEF

The Red Bluff Police Department is a full-service Police Department that is currently staffed with twenty-five sworn police officers and ten civilian employees. The Department is divided organizationally into two Divisions. These Divisions are the Operations Division and the Support/ Special Services Division. The Operations Division consists of the Uniformed Patrol Unit. Our Volunteers In Police Service (VIPS) program continues to be a valuable asset to the Department and our community. We look at strengthening our volunteer program(s) in the future years. This unit is also managed from the Operations Division of the Department.

The Support/ Special Services Division consists of the Investigations Unit, Dispatch Unit, Records Unit and the Community Service Officer Unit. The purpose of the Police Department is to provide for the safety and security of the citizens of Red Bluff. Our goal is to maintain a well equipped and well trained department that can provide a high level of service. The Members of the Police Department are committed to providing "Service with Integrity."



The Red Bluff Police Department remains committed to providing a high level of quality service to the citizens of Red Bluff. With the assistance of our community partners and allied agency partners, as well as State Grants, we have reacquired two police officers positions. This has brought us to within just one position of our 2009 sworn staffing levels. Finally, after several years with this position vacant we are able to assign an officer to the Tehama Inter-Agency Drug Enforcement (TIDE) Task Force.

During 2014 the Red Bluff Police Department had a very busy and challenging year. There were significant increases in calls for service as well as increases in crime that certainly challenged our Department. We enhanced our School Resource Officer Program by adding a part-time School Resource Officer working in the Elementary Schools. I am very proud of the staff at Red Bluff PD. They work diligently every day to enhance the security and safety of our community.

Most importantly, the voters approved a ¼ cent sales tax increase focused on supporting public safety. With this increased funding we will begin gradually increasing the sworn and non-sworn staff to assist in providing better police services to our community. We are very grateful to the citizens for this support and will work hard to insure that this money is used to increase the safety and security of our community.

As you read through these pages, it will reflect the high level of activity and challenges as well as the quality and professionalism of the members of the Red Bluff Police Department. Our City is divided into (5) Areas of Responsibility, each headed by a Patrol Sergeant. There is a map on our website that identifies the jurisdictional boundaries of each Area of Responsibility. Each Sergeant is available to respond to questions or concerns about crime and law enforcement services in our city, and your Area of Responsibility. #### **OPERATIONS DIVISION**

CAPTAIN KYLE SANDERS

The Operations Division is predominately comprised of patrol officers and supervisors whose primary function is to deliver initial police services to the community 24 hours a day. These uniformed personnel provide police response to calls for service as well as the initial response to an emergency or report of a crime. Other personnel within the Operations Division include two fulltime School Resource Officers (SRO's), one part-time SRO, traffic officer, and one Community Service Officer. The VIPS (volunteers) also fall within the Operations Division. All of these fine professionals deliver initial and follow up police services to the community seven days a week.

This division accounts for most of the Department's measurable workload and is the most visible as they are usually the primary contact for persons seeking police services.

All personnel within the Operations Division worked persistently throughout 2014 to address a year filled with challenges. These men and women routinely made sacrifices for the betterment of the Department and to improve the quality of life within the City of Red Bluff.

#### TRAFFIC OFFICER PROGRAM

The City of Red Bluff suffers from a significant collision rate and for many years has had one of the highest rates of vehicle versus bicycle collisions when compared with similarly sized communities. Methods to reduce

collisions include both education and enforcement. The Department is committed to improving traffic related safety and through most of 2014 a fulltime traffic officer was designated to focus on such efforts.

The below chart demonstrates traffic collision statistics and shows that 2014 saw an overall decrease in our collision rate.

An Office of Traffic Safety (OTS) grant to assist our agency in costs associated with traffic enforcement efforts was acquired in 2013 and was awarded for the period of October 1, 2013 through September 30, 2014. The grant award totaled \$131,825.00 and provided funding for one fulltime police officer, overtime, equipment, and training. The following is a breakdown of the grant funding allotments:

#### **K9 Program**








#### **COMMUNITY ORIENTED POLICING PROGRAMS**

#### **SWAT**



The Tehama Inter-Agency SWAT Team consists of personnel from the Red Bluff Police Department, Tehama County Sheriff's Department and Corning Police Department. The members train 12 times annually, meeting once each month on average for training.


#### **SCHOOL RESOURCE OFFICER**

The Red Bluff Police Department School Resource Officer position is an integral part of our community policing philosophy.

During 2014 a transition in the Red Bluff High School Resource Officer took place due to SRO Aaron Murray advancing to a detective assignment. Detective Murray transitioned to the detective role at the conclusion of the school year in June 2014 and

Officer Heidi Thomas took over the SRO role beginning at the start of school in August 2014. The SRO spends countless hours communicating with school staff, parents, students and citizens who live in the area of Red Bluff High School. The high school SRO remained quite busy throughout 2014 not only in the community policing aspect but also in the enforcement of violations committed by students at Red Bluff High School and the extension schools of the Red Bluff Union High School District.

# SRO Baxter

#### G.R.E.A.T. PROGRAM

In January 2014 Gang Resistance Education and Training (GREAT) Officer Sean Baxter began teaching the GREAT curriculum to all 7<sup>th</sup> grade classes at Vista Preparatory Academy (VPA). The following are a few key points regarding the GREAT program:

#### **Evidence Based Program**

A nationwide long-term study (2006 - 2012) of the GREAT Program found the following statistically significant positive effects:

- > 39% reduction in odds of gang joining one year post program.
- > 24% reduction in odds of gang joining four years post program.
- > More positive attitudes toward police.
- > Less positive attitudes about gangs.
- More use of refusal skills.
- Less risk taking.

#### **GREAT Classes**

- > GREAT Officer Baxter taught GREAT classes to all 7<sup>th</sup> grade VPA classes beginning in January 2014:
  - ✓ Each class was 1 hour a day, 1 day a week for 13 weeks.
  - ✓ 7 classes taught weekly.
  - ✓ 190 7<sup>th</sup> grade students received the training.
  - ✓ The classes assist students to:
    - ♣ Define their role in the school / community.
    - Levelop goals and methods to attain those goals.
    - Develop decision making skills.
    - ♣ Develop effective communication skills.
    - Develop effective refusal skills.
    - ♣ Develop effective anger management skills.
    - Develop effective resolution techniques.

GREAT Officer Sean Baxter began his duties at VPA on 12/2/2013. While not fulfilling his duties teaching or preparing for the GREAT Program, Officer Baxter performs the role of School Resource Officer focusing primarily on VPA, but also protecting the surrounding areas including two other nearby public schools.

### SUPPORT / SPECIAL SERVICES DIVISION

LIEUTENANT DAN FLOWERDEW

The Support/Special Services Division is comprised of several units that include Investigations (Detectives), Records, Community Service Officers (CSO), and Dispatch. While each of these units vary greatly in the scope of work performed, all are vital to the mission and goals of the Red Bluff Police Department. The Support/Special Services Division is managed by Lt. Dan Flowerdew.

Although the Units within the Support/Special Services Division have been adversely affected by the struggling economy, they are united in their commitment to providing quality services to the City of Red Bluff.

#### **INVESTIGATIONS**

During the calendar year of 2014, the Investigations Unit was comprised of two assigned detectives; Detective Scott Curtis and Detective Aaron Murray. Detective Murray was assigned to the unit in June 2014 and from January 2014 to June 2014 Officer Matt Coker and Officer Heidi Thomas were temporarily assigned to the Investigations Unit on a temporary rotation status.

A total of <u>124</u> cases were assigned to the Investigations Unit for follow-up during this year and <u>120</u> cases were cleared. The cases ranged from child molestations, rapes, robberies, assaults with deadly weapons, burglaries and homicide investigations. A breakdown of investigative cases assigned to detectives can be found in the below chart. Also due to staffing levels, Detectives have assisted patrol throughout this year to help fill patrol shifts. In 2013, <u>95</u> cases were assigned to Detectives which means, in 2014, case assignments to Detectives were up by 30.52%. In 2014, the complexity of the assigned investigative cases is very time consuming and due to only having two assigned Detectives they simply cannot investigate every case. This has caused Lt. Flowerdew to scrutinize the potential investigative cases. Some of those cases did not meet the priority level of other cases therefore those cases were either reassigned to patrol or simply not worked. This is very unfortunate but a necessity at this time. Furthermore many of the runaway cases have been assigned to the School Recourse Officers; cases which would normally be investigated by a Detective.




#### **INVESTIGATIONS (CONTINUED)**

Detective Curtis also took  $\underline{18}$  initial investigative reports and Detective Murray took  $\underline{31}$  initial investigative reports.

A total of  $\underline{35}$  sex related investigations,  $\underline{1}$  homicide investigation,  $\underline{2}$  assaults with deadly weapons cases and  $\underline{49}$  missing persons cases were assigned for detective follow-up. These types of cases involve an extraordinary amount of time to investigate as well as a great deal of investigative knowledge, skill and experience to do so effectively.

Detective Curtis is in charge of coordinating and scheduling the Red Bluff Police Department sexual offender program sex registration compliance checks. This program is funded by the Shasta County SAFE Grant and is overseen by Lt. Flowerdew in regards to Red Bluff Police Department overall activity and equipment acquisitions.








#### **COMMUNICATIONS CENTER**

RECORDS / COMMUNICATIONS MANAGER CINDEE SPURGEON



The Communications Center is the primary PSAP (Public Safety Answering Point) for the City of Red Bluff. This means that all 911 calls originating in the city are routed to the center, including wireless calls. The dispatcher's primary responsibilities include answering seven 911 emergency telephone lines, 4 business telephone lines and several other inter-department telephone lines that must be routed properly. They keep track of all on-duty police officers, detectives, sergeants, community service officers, and other miscellaneous personnel. They monitor Red Bluff PD's primary radio channel along with other radio channels such as the Tehama County Sheriff's Department, the Red Bluff Fire Department and Public Works so they are aware of incidents that may require police assistance. They use a Computer Aided Dispatch system to

input calls for service and to keep track of on duty units. They prioritize these calls for service and dispatch appropriate unit(s) to in progress or cold calls. Besides answering emergency phone calls and radio dispatching, RBPD dispatchers inquire and update into CLETS databases, complete data entry on pawns, citations and other miscellaneous paperwork, and also scan documents into cases and incidents.











#### **RECORDS UNIT**



During 2014, the Records Unit processed 7,459 written reports and supplements. They review each report for statistical and routing accuracy, create working files for patrol and detectives and prepare all paperwork sent to the Court, District Attorney's Office and allied agencies.

In addition to the reports, Records staff is also responsible for answering records-related phone calls, assisting citizens at the front counter, processing records requests from citizens, criminal justice agencies, insurance companies and others, processing all traffic, criminal and parking citations, pawn slips, handling bicycle registrations, completing paperwork associated with sex, arson, narcotic and gang registrations, and a myriad of other duties.





#### **COMMUNITY SERVICE OFFICERS**


#### 2014 ANIMAL CONTROL FUNCTIONS & RESPONSIBILITIES

### Case Highlights

The following represents <u>only a small percentage</u> of the hard work and dedicated service provided by the professional staff at the Red Bluff Police Department. These case highlights are provided to demonstrate the various types of cases handled by RBPD personnel and is not intended to represent all significant cases, but rather to provide a snapshot of a small number of cases handled during 2014.

<u>January 19, 2014 / Sexual Abuse</u> - After communicating via the internet, a 31 year old male traveled from southern California to meet a 14 year old girl at a local hotel and engaged in sexual activity. A lengthy investigation ensued and the suspect is awaiting trial on multiple sex related charges.

<u>January 19, 2014 / Vehicle Pursuit</u> - Officers attempted to stop a GMC truck on Aloha Street near Jackson Street due to a disturbance call. The driver failed to yield and fled east on Aloha Street. Speeds up to 60 miles per hour were reached and the driver was caught and arrested.

<u>January 22, 2014 / Vehicle Pursuit / DUI</u> – A call was received about a possible DUI driver on Monroe Street near Hwy 36. An officer located the vehicle, which immediately fled at a high rate of speed. The vehicle was pursued through residential streets and the officer lost sight of it. It was located running and abandoned.

January 25, 2014 / Brandishing - Dispatch received a 911 disturbance telephone call where it was reported a male adult was in possession of a loaded firearm at a local hotel. A male adult had exited a motel room with a handgun and began yelling at motel guests in the area. The suspect telephoned Dispatch and advised he had a gun and he would shoot anyone who came to his door. The suspect eventually exited his motel room and was arrested.

<u>February 1, 2014 / Transporting Marijuana</u> – An Officer conducted a traffic stop on Antelope Boulevard at Rio Street. During a search of the vehicle, officers located over 100 pounds of processed marijuana. The occupants were arrested.

<u>February 3, 2014 / Brandishing</u> — While shopping at a local store, a man made unusual statements and threatened to shoot somebody. He went to his vehicle and retrieved a firearm, which he began pointing at people in the parking lot. Officers contacted and arrested the man.

<u>February 3, 2014 / Sending Harmful Matter to a Minor</u> – The Red Bluff High School SRO received information that a teacher was reportedly having an inappropriate relationship with a minor student. Investigators learned the teacher had sent inappropriate text messages to a 17 year old female and he was subsequently arrested.

<u>February 4, 2014 / Death Investigation</u> - Officers responded to Philbrook Avenue regarding a male who was on fire in a wheel chair. A citizen extinguished the fire and medical personnel began treating the victim who ultimately succumbed to his injuries. It is believed the fire may have been caused by a lit cigarette.

February 5, 2014 / Vehicle Theft — A citizen reported seeing two suspicious men leaving Tucker's Automotive in a Honda Accord and it was discovered they had just stolen the vehicle from the business. The vehicle was located on I-5 south of town and the two occupants, both from Vallejo, were arrested.

<u>February 28, 2014 / Stabbing</u> - St. Elizabeth Hospital reported they were treating an adult male who had been stabbed while at a party on Walbridge Street. His injuries were serious, but not life threatening.

March 9, 2014 / Robbery / Kidnapping / Vehicle Pursuit - Officers responded to Sandy Way for a domestic disturbance wherein a male battered his girlfriend and stole her car keys. As officers arrived, the suspect fled the area in a sedan with the victim in the vehicle with him. The suspect failed to yield and fled north on I-5 at speeds exceeding 100 miles per hour. At times he drove the wrong way on I-5 to include the off-ramps and onramps in an attempt to evade pursuing officers. He was eventually arrested.

March 9, 2014 / Child Abduction / Runaway — After communicating via the internet, a male from Tennessee came to Red Bluff and picked up a 13 year old runaway girl. Utilizing technology, RBPD Detectives were able to track and locate the suspect and juvenile as they traveled. Ultimately, they were caught in Illinois. The FBI became involved and Federal charges are being filed.

<u>March 27, 2014 / Sex Offense</u> - Officers received information that a 19 year old male was involved in a sexual relationship with a 15 year old female. The victim and suspect indicated they had been communicating via social media and then began a consensual sexual relationship. The male was arrested.

<u>March 29, 2014 / Assault with a Deadly Weapon</u> — An officer responded to St. Elizabeth Hospital regarding a an adult male who had been struck in the head with a hammer somewhere in Red Bluff. The victim was unable to provide a detailed statement to officers before being transported to Mercy Hospital via ambulance for serious, but not life threatening injuries.

April 4, 2014 / Robbery / Assault with a Deadly Weapon — A person reported a male known to him entered his residence while he was sleeping and began attacking him. The suspect hit, kicked and choked the victim and demanded payment for the \$40.00 he owed for heroin. The victim was struck with a frying pan and was forced to give the suspect money.

<u>April 5, 2014 / K9 Drug Find</u> – An Officer conducted a traffic stop and used his K-9 partner "Many" to sniff the vehicle for narcotics. K-9 Many alerted to the odor of narcotics and the vehicle was searched. Several hypodermic needles, drug paraphernalia and 1.5 grams of heroin were located.

<u>April 22, 2014 / Possession of Meth / Resisting an Officer</u> – An Officer was patrolling a residential neighborhood due to recent thefts and conducted a bicycle stop. The bicyclist refused to stop and attempted to speed away. The bicyclist was eventually stopped and taken into custody. He was arrested for five outstanding warrants and was found to be in possession of Methamphetamine and a Billy club.

<u>May 3, 2014 / Grand Theft / Counterfeit Money</u> - Officers were sent to a local hotel for a report of a theft in progress. Officers contacted two men who were attempting to leave the area. It was determined the men were attempting to steal an air conditioning unit and they possessed counterfeit \$20.00 bills. Both were arrested.

<u>May 4, 2014 / Rape</u> - Officers responded to the hospital and contacted the victim who reported an ex-boyfriend had raped her by force. Officers located the suspect who was ultimately arrested.

May 13, 2014 / Felony Vandalism - A Red Bluff youth was arrested at Red Bluff High School and charged with felony vandalism. The investigation began in April when school officials contacted the School Resource Officer regarding a vandalism that occurred on a school bus. As the investigation continued, several other locations were found with similar graffiti. Since February 2014, at least 20 other Red Bluff locations were identified and the estimated costs of damages exceeded \$4,300.00.

May 16, 2014 / Battery of an Officer / Criminal Threats / Domestic Violence - Officers were sent to an apartment complex for a report of a domestic disturbance in progress. Upon arrival, officers contacted the male who was carrying two large sticks and he verbally challenged officers to fight. The male violently erupted and punched an officer in the face resulting in a minor injury. It was learned the suspect had battered his live-in girlfriend and threatened to kill her during the process.

<u>June 9, 2014 / Murder</u> - Officers responded to Mina Avenue for a male who had been stabbed. The victim succumbed to his wounds despite being transported to the hospital via ambulance. The investigation resulted in the arrest of a 35 year old man who recently pled guilty in court.

June 12, 2014 / Vehicle Theft / Pursuit - Officers learned of a vehicle theft that had just occurred. A short time later, an Officer located the vehicle traveling on Antelope Boulevard. The suspect eventually fled and a vehicle pursuit ensued. The 18 year old suspect, who was captured, had just been released from jail prior to the theft.

July 2, 2014 / Counterfeit Money / Burglary / Conspiray / Etc. — On 7/2/14 an Officer received information regarding a male adult passing counterfeit bills at a local business. The Officer received additional information of the location where the counterfeit money was being manufactured as well as of where the altered access cards were being manufactured. On 7/4/14 the officer located and arrested the suspect. On 7/5/14, four additional persons were arrested for multiple felony charges relating to manufacturing and passing forged access cards along with manufacturing counterfeit money.

<u>July 14, 2014 / Felon in Possession of a Firearm / Violation of Restraining Order</u> - Officers responded to a report of a domestic violence restraining order violation. The victim reported her estranged husband, who is currently restrained from contacting her, kept driving past her residence in his vehicle. Officers responded to the area and located the suspect nearby. The officers located a handgun along with drug paraphernalia inside his vehicle.

<u>July 15, 2014 / Robbery / Conspiracy</u> - Officers responded to a report of a robbery in progress on Franzel Road. Two men had forced their way into a residence and battered a male resident and robbed him of his wallet. The victim was struck with a chair and a metal bar several times. One of the suspects was arrested and the other was identified.

<u>July 25, 2014 / Rape / Sodomy</u> – A 17 year old female reported to friends she had been raped in a local hotel room by a 38 year old male acquaintance who had recently been released from a California state prison and placed on active Post Release Community Supervision (PRCS) in Tehama County. He was located and arrested the next day.

August 4, 2014 / Armed Standoff - A 9-1-1 report of a male inside a residence armed with a firearm and intending to harm himself was received. Officers located the residence and were contacted by a relative who confirmed the male was upset and had armed himself with a shotgun. The male's wife was inside the residence with him, trying to calm him down. The female exited the residence and was moved to safety. The officers made telephone contact with the subject and after a lengthy discussion, he agreed to exit the residence unarmed. The subject was detained.

August 5, 2014 / Sexual Assault - St. Elizabeth Hospital called to report a sexual assault. Officers responded to the hospital and interviewed the 18 year old female victim who reported being sexually assaulted by an acquaintance. The male was subsequently arrested for forced oral copulation, false imprisonment, and sexual battery.

<u>August 7, 2014 / Barricaded Subject</u> - A female at a local apartment complex got into a verbal argument with her 43 year old son who subsequently armed himself with a large knife, threatened to harm himself and barricaded himself in his bedroom. Officers responded to a 911 call for help and encountered the male armed and in a very agitated and volatile state. After negotiating for over two hours, the male came out of his room and was detained without incident.

August 26, 2014 / Prowling / Carrying a Loaded Firearm, Possession of Drug Paraphernalia — At about 02:46 A.M., a resident called 911 to report seeing flashlights in Reeds Creek behind a vacant residence on Aloha Street. Officers found a male hiding near the creek wearing a black shirt, black hat, black gloves, and a black bandanna. The male dropped a pistol and was also armed with a large machete. The male was arrested for the above listed charges.

<u>August 27, 2014 / Stolen Vehicle / Possession of Drugs for Sale</u> - A report that a reported stolen vehicle was traveling through Red Bluff was received and officers began searching for it. Officers located the stolen vehicle that was occupied by two individuals. Both occupants were arrested and found to be in possession of a controlled substance for sale.

<u>September 24, 2014 / Possession of a Stolen Vehicle / Possession of Drugs / Parole Violation</u> — A citizen reported he was following his vehicle that he had reported stolen previously. Officers spotted the vehicle traveling eastbound on Antelope Blvd. and then conducted a felony vehicle stop. The driver was arrested for Possession of Stolen Property, Possession of a Controlled Substance, Violation of Parole and a misdemeanor warrant.

<u>September 25, 2014 / Attempted Murder / Robbery</u> - Officers were dispatched to a local hotel for a report of an attempted robbery with a gunshot fired. It was learned a 14 year old male juvenile and another juvenile confronted the victim as he was smoking a cigarette outside. One suspect pointed a gun at the victim and demanded his wallet. The victim struggled for the gun and a round discharged into the ground near the victim. One of the suspects was located and arrested nearby.

<u>September 30, 2014 / Vehicular Homicide / DUI Causing Death</u> - Red Bluff Police Department received multiple 911 calls regarding a traffic collision on Antelope Boulevard where it was reported that a vehicle struck two pedestrians. Officers learned an adult female drove a vehicle that struck two pedestrians near the sidewalk. One of the pedestrians (18 year old female) was pronounced dead at the scene and a male was severely injured. The driver submitted to several field sobriety tests and was arrested.

October 4, 2014 / Assault with a Deadly Weapon / Vandalism / Possession of paraphernalia - Two adult women got into an argument that escalated quickly and a physical fight started. During the fight, one hit the other several times in the head with a large rock. One party then broke the other's vehicle windshield with a rock. Narcotics paraphernalia were found on one of them.

October 7, 2014 / Hit and Run with Injury - Officers received a report of a traffic collision involving a juvenile on a bicycle wherein the vehicle had fled the area. Officers learned that an 11 year old male was riding a bicycle in the crosswalk and was struck by a pickup. The juvenile was transported to St. Elizabeth Hospital with minor injuries.

October 15, 2014 / Manslaughter - Officers were dispatched to a report of a disturbance and a "man down" on Jackson Street. Officers located an unconscious man on the ground. The man later died due to head trauma. The investigation resulted in the arrest of a 26 year old male who had struck the male with his fists and feet.



October 19, 2014 / Discharge of a Firearm / Resisting an Officer - Dispatch received several reports of gunshots fired on Main Street. Three men fled the area as officers were arriving in the area and a foot pursuit ensued. One of the men discarded a handgun into some bushes and all three men were subsequently apprehended. Officers learned two groups of men (some claiming gang membership) engaged in an argument and one of the men discharged up to 6 rounds from a handgun in an unknown direction.

October 29, 2014 / Child Endangerment / Possession of a Concealed Firearm / Resisting an Officer – An officer observed a male whom he knew to have several arrest warrants. The male had his three year old child with him and ran from the officer carrying the juvenile in his arms. The man eventually stopped and discarded a loaded handgun. He was arrested.

November 7, 2014 / Suspicious Circumstance - Officers were dispatched to a home on Aloha Court regarding a suspicious circumstance. They found a 57 year old female bleeding from numerous facial and head wounds. She was unresponsive and was unable to provide any information regarding the incident. She was flown to Mercy Hospital.

November 13, 2014 / Robbery - Officers responded to the Tacos El Gallo Giro food truck regarding an armed robbery that had just occurred. Officers learned a male adult had entered the food truck, pointed a small gun at the employee and demanded she give him the businesses' money. Once he received the undisclosed amount of money, he ran from the area.

<u>December 5, 2014 / Stabbing</u> - Officers contacted an 18 year old male stabbing victim who reported he had been stabbed by two adult men wearing dark clothing. He sustained serious but non-life-threatening wounds and was transported by ambulance to St. Elizabeth Hospital. It is believed this incident was gang related.

<u>December 18, 2014 / Vandalism / Attempted Grand Theft</u> - Officers responded to American West Bank regarding a vandalism and learned during the night a male adult attempted to steal currency from the drive through ATM machine. The suspect was unsuccessful in obtaining any money; however, the suspect did cause considerable damage to the ATM.

<u>December 29, 2014 / Domestic Violence / Barricaded Subject / K9 Use</u> - Officers were called to the scene of a domestic disturbance wherein a male choked his girlfriend. The male barricaded himself in his bedroom and was thought to be armed with knives. Red Bluff Police K-9 "Many" was introduced to the scene and the suspect was warned if he did not surrender the police K-9 would be sent in to assist in his apprehension. Shortly after, the suspect surrendered.

<u>December 29, 2014 / Display Imitation Firearm / Possession of Drug Paraphernalia</u> - Dispatch received several 9-1-1 calls reporting a man walking on Oak Street near Washington Street with an unknown type of long gun/rifle. Officers observed the suspect carrying what appeared to be a black assault rifle. Upon a closer inspection of the rifle it was determined to be an air soft type rifle with the orange safety tip completely covered with black tape. Officers located drug paraphernalia.






