Message from the Chief

On behalf of the men and women of the Red Bluff Police Department, we are pleased to present our 2015 Annual Report. This report provides comprehensive information and statistics on a wide variety of subjects including crime, staffing, and units within the Department. We hope this report provides insight into the invaluable personnel we have along with the variety and volumes of work they dealt with during 2015.

A year of transition is the best way to describe Red Bluff Police Department during the past year. With the retirements of Chief Nanfito (May 15, 2015) and Lieutenant Dan Flowerdew (December 21, 2015), the end of 2015 saw an entirely new administrative team being formed. Kyle Sanders vacated the Captain's role and became Chief on June



2, 2015. Quintan Ortega promoted from Sergeant to Captain on September 15, 2015 and Matt Hansen promoted from Sergeant to Lieutenant on December 22, 2015. The new administrative team comprises a total of 43 years of service to the City of Red Bluff and looks forward to giving many more in the years to come.

Your police department employs some of the finest sworn and civilian staff in law enforcement today; men and women who serve our community with pride and integrity each and every day. These personnel are devoted public servants who constantly strive to make Red Bluff a great place to live. They are fully committed to providing a high level of quality service to the citizens of Red Bluff as well as those who visit our City.

As you explore this report, I would encourage you to take a moment to examine our "10 Year Statistical Comparison" section that will provide a snapshot of the crime in our City as well as insight into our agency and some of the statistical data associated with our work. As you read through these pages, it will reflect a high level of activity and multitude of challenges as well as demonstrate the quality and professionalism of the members of the Red Bluff Police Department.

As you examine the report and statistical data, you may notice a sharp spike in certain crime classifications during 2015. While a number of crime categories remained relatively flat, simple assaults increased by 28% and larceny increased by 17.6%. These two crimes were primarily responsible for the overall 12.6% increase in our Part 1 Crimes. California as a whole is experiencing rising crime, particularly in property related crimes. It is believed, and research appears to be validating, that these increases in crime can be correlated to laws such as Assembly Bill 109 (enacted 10/1/2011) and Proposition 47 (enacted 11/4/2014) that have changed the way we address crime and the consequences for criminal behavior. These laws have led to thousands of individuals remaining on our streets who formerly would have been incarcerated for the crimes they commit.

Despite these statistics, your police department is filled with honorable members who are motivated to work with you to combat crime and disorder. We look forward to working together in partnership with the members of our community to truly make Red Bluff a great place to live.

OPERATIONS DIVISION





The Operations Division is predominately comprised of patrol officers and supervisors whose primary function is to deliver initial police services to the community 24 hours a day. These uniformed personnel provide police response to calls for service as well as the initial response to an emergency or the report of a crime.

Other personnel within the Operations Division include two fulltime School Resource Officers (SRO), one traffic officer, and two full-time and one parttime Community Service Officer. The Volunteers in Police Services (VIPS) also fall within the Operations Division. All of these fine professionals deliver

initial and follow up police services to the community seven days a week.

The Operations Division accounts for most of the Department's measurable workload and is the most visible in the community as they are usually the primary contact for persons seeking police services. All personnel within the Operations Division worked persistently throughout 2015 to address a year filled with challenges. These men and women routinely made sacrifices for the betterment of the Department and to improve the quality of life within the City of Red Bluff.

TRAFFIC OFFICER PROGRAM

Due to staff shortages facing the Red Bluff Police Department, Traffic Officer Murgia was re-assigned to the Patrol Division during the majority of 2015. The goal of the Red Bluff Police Department is to assign Officer Murgia back to his traffic duties once some police officer vacancies are filled.

Even with Officer Murgia working a rotating patrol schedule, he still participated in several traffic related events during the year.

- April 25, 2016: Officer Murgia assisted the Tehama County Public Health with a bicycle safety event and bicycle rodeo.
- May 27, 2015 & June 24, 2015: Officer Murgia assisted the Tehama County Public Health with a car seat inspection.
- October 22, 2015: Officer Murgia rode his patrol motorcycle to Bend Elementary School and participated in Read Across America.
- During 2015, Officer Murgia and other RBPD staff provided approximately 100 bicycle helmets to children who needed them.
- Officer Murgia also completed a comprehensive collision investigation manual for newly hired police officers.

K9 PROGRAM








COMMUNITY ORIENTED POLICING PROGRAMS

The Police Department divides the City of Red Bluff into five different geographical regions (Areas of Responsibility) and designates each area with a sergeant and one or two officers for community oriented policing purposes. Each Area of Responsibility participates in Neighborhood Watch meetings and the Random Citizen Contact (RCC) program. The RCC program consists of an officer contacting a citizen randomly for no other reason than to connect with them and interact positively outside of a call for service.



The above chart demonstrates the Department's goal and efforts toward reducing the annual costs of special event related overtime. SWAT



The Tehama Inter-Agency SWAT Team consists of personnel from the Red Bluff Police Department, Tehama County Sheriff's Department and Corning Police Department. The members train 12 times annually, meeting once each month on average for core competency training.

During 2015, the team conducted a variety of training, which included the following:

SCHOOL RESOURCE OFFICER

The Red Bluff Police Department School Resource Officer position is an integral part of our community policing philosophy.


During the 2015 school year, SRO Heidi Thomas assisted with many special events including Special Olympics, Career Day and the Fraud Fair. She has become a part of the School Attendance Review Board or SARB, attending SARB monthly meetings

and providing input regarding truant Red Bluff area high school students. SRO Thomas attended the bi-annual School Safety Meetings with the Red Bluff Union High School District and monthly safety meetings with High School Administration. She worked with SRO Baxter and Tehama County Juvenile Probation to monitor and take enforcement action on juvenile gang members attending Red Bluff schools. She also does countless hours of counseling students and educating staff members.


SRO Thomas applied for and obtained the grant for the Every 15 Minutes program in October/November 2015. She has been working closely with CHP, TCSO, Student Government, St. Elizabeth Hospital ER, St. Elizabeth Ambulance, Hill Towing and Red Bluff Fire in planning the E15M event.

For the 2015 school year SRO Thomas took 314 reports and made 177 arrests.



G.R.E.A.T. PROGRAM



Officer Baxter has been the GREAT Program Instructor at Vista Preparatory Academy since December of 2013. Officer Baxter has taught the GREAT Program for five semesters of instruction and has instructed over 400 students in the program so far.

Between January 1, 2015 and December 31, 2015 SRO Baxter has taken 78 criminal reports.

Of those 78 criminal cases only 4 of them included cases originating from incidents that took place at Vista Preparatory Academy.

There were NO Gang related incidents during the Spring and Fall 2015 semesters at Vista Preparatory Academy. This is one indication of the success the GREAT Program is having.

SRO Baxter taught the GREAT (Gang Resistance Education and Training) classes during the Spring and Fall 2015 semesters to all of the Vista 7th Grade classes.

- GREAT classes go for 13 weeks each semester- 1 class a week- 1 hour class times
- 190+ Seventh grade students completed the GREAT program during the 2015 time period- For a total of over 400 students who have completed the GREAT Program with SRO Baxter at this time (not including the 120 who have completed the GREAT classes already in 2016).
- There are a total of 7, seventh grade classes at Vista
- Three classes were taught in the Spring 2015 semester
- Four classes were taught in the Fall 2015 semester
- Each of the seven classes planned/ organized and completed a "Making Vista a Better Place Project."
- Projects included: Positive posters, positive T-shirts, Red Ribbon Week events, Assisting the special needs classes with projects, landscaping and campus improvements proposals.

GREAT classes include educating the students in the following life skills:

- The truth about gangs and violence
- How gangs and violence can affect their future
- Defining their roles in the school/ community
- Develop goals and methods to attain those goals
- Develop decision making skills
- Develop effective communication skills
- Develop Effective refusal skills
- Developing skills and ways to deal with peer pressure
- Develop effective anger management skills
- Develop effective conflict resolution techniques





In addition to teaching GREAT classes, SRO Baxter has partnered with staff at Vista Preparatory Academy, the SRO at RBHS, Tehama County Probation, the Tehama County DA's office and the Tehama County Gang Taskforce to monitor and take enforcement action on active known juvenile gang members attending Red Bluff area Schools. The following is an estimation of know/ suspected juvenile gang members in the Red Bluff area:

- √ 27 students claim Northerner/ Norteno (Red)
- √ 28 students claim Southern/ Sureno (Blue)
- √ Numerous hang-a-rounds on both sides
- √ Includes both Male and Female juveniles All under 18 years of age

As well as teaching his GREAT lessons and working on gang enforcement, Officer Baxter has taught several Gang awareness trainings to community organizations and teachers in the Red Bluff Unified Elementary School District.

Officer Baxter has also become a certified ALICE active shooter instructor. Along with District staff, Officer Baxter has begun the process of implementing the ALICE program into the Red Bluff Elementary Schools.

In addition to his SRO duties, Officer Baxter has also worked closely with the Investigations Unit at the Red Bluff Police Department during 2015 and authored four search warrants.



There have been many changes in the Red Bluff Police Department in 2015 and the Support Services Division is no exception. A transition in management of this Division occurred in December when Lt. Dan Flowerdew retired and Sgt. Matt Hansen was promoted to Lieutenant and assigned to the Division.

INVESTIGATIONS

During 2015 Detective Curtis and Detective Murray tested for Sergeant. Detective Curtis was promoted to Sergeant in May and Detective Murray in December. Sgt. Curtis was immediately assigned to the patrol unit and Sgt. Murray remains RBPD's only detective until staffing increases and a suitable replacement is selected.

During the calendar year of 2015, Detective Murray was assigned 95 cases to investigate. When the cases were more complex Detective Murray utilized the help of senior patrol officers. Of these 95 cases:

- 25 were sex crimes
- 38 were missing persons investigations
- 14 were property crimes
- 2 stolen vehicle investigations
- 6 violent crimes




Detective Murray assumed the responsibility of coordinating and scheduling the Red Bluff Police Department sexual offender program sex registration compliance checks. This program is funded by the Shasta County SAFE Grant and is now overseen by Lt. Hansen in regards to Red Bluff Police Department's overall activity and equipment acquisitions.

The Red Bluff Police Department investigative unit participates in the Northern California Regional Child Abduction Response Team. This specialized team of experts can be called upon to respond to help investigate and locate missing children. The team performed a mock exercise in December in Red Bluff in preparation for a second exercise, which upon completion, will certify the team as the first of its kind in California.




COMMUNICATIONS CENTER

RECORDS / COMMUNICATIONS MANAGER CINDEE SPURGEON

The Communications Center is the primary PSAP (Public Safety Answering Point) for the City of Red Bluff. This means that all 911 calls originating in the city are routed to the center, including wireless calls. The dispatcher's primary responsibilities include answering seven 911 emergency telephone lines, 4 business telephone lines and several other inter-department telephone lines that must be routed properly. They keep track of all on-duty police officers, detectives, sergeants, community service officers, and other miscellaneous personnel. They monitor Red

Bluff PD's primary radio channel along with other radio channels such as the Tehama County Sheriff's Department, the Red Bluff Fire Department and Public Works so they are aware of incidents that may require police assistance. They use a Computer Aided Dispatch system to input calls for service and to keep track of on duty units. They prioritize these calls for service and dispatch appropriate unit(s) to in progress or cold calls. Besides answering emergency phone calls and radio dispatching, RBPD dispatchers inquire and update into CLETS databases, complete data entry on pawns, citations and other miscellaneous paperwork, and also scan documents into cases and incidents.

RECORDS UNIT



During 2015, the Records Unit processed 7,164 written reports and supplements. The Records Unit is staffed with one Records Specialist and a Records Manager. They review each report for statistical and routing accuracy, create working files for

patrol and detectives and prepare all paperwork sent to the Court, District Attorney's Office and allied agencies.

In addition to report review and dissemination, Records staff is also responsible for answering records-related phone calls, assisting citizens at the front counter, processing records requests from citizens, criminal justice agencies, insurance companies and others, processing all traffic, criminal and parking citations, pawn slips, handling bicycle registrations, completing paperwork associated with sex, arson, narcotic and gang registrations, and a myriad of other duties.






2015 ANIMAL CONTROL FUNCTIONS & RESPONSIBILITIES



EMPLOYEE AWARDS AND RECOGNITION



Case Highlights

The following represents <u>only a small percentage</u> of the hard work and dedicated service provided by the professional staff at the Red Bluff Police Department. These case highlights are provided to demonstrate the various types of cases handled by RBPD personnel and is not intended to represent all significant cases, but rather to provide a snapshot of a small number of cases handled during 2015.

January 10, 2015 - Attempted Murder, Assault with a Deadly Weapon, and Mayhem

Officers responded to the 1700 block of Scottsdale Way regarding a disturbance and stabbing. Officers located two stabbing victims. During the investigation it was learned several Hispanic juveniles approached the victims who were seated in a vehicle and attacked them. Several arrests were later made in connection with this case.

February 16, 2015 - Make a False Police Report - SWAT Incident

Red Bluff Police received a telephone call from "Joe" who stated he stabbed the resident on Delphinium Street and was holding the rest of the family hostage. The caller additionally told the dispatcher if the police were called he would shoot the officers and he claimed to have a shotgun. When officers arrived they contacted the other residents of the 4-plex apartment building who were evacuated for their safety.

Because of the reported circumstance, and the apparent lack of cooperation from the occupants inside of the apartment in question the InterAgency SWAT team was deployed. A SWAT team negotiator was able to contact a resident inside the apartment by telephone. SWAT later removed the occupants and cleared the apartment. After interviewing the occupants the investigators determined the residents were the victims of a false police report. No criminal charges were filed.

March 9, 2015 - Shooting at an Inhabited Dwelling

Officers responded to the Red Bluff Meadow Apartments, located at 850 Kimball Road, regarding a window being shot out. The victim told the officers at about 3:50 AM she heard several gunshots being fired near her apartment. The victim's 12 year old daughter woke up with glass from her bedroom window on her bed. The victim then discovered a bullet hole in the window, less than a foot from where her 12 year old was sleeping at the time. The bullet traveled through the youth's bedroom where it struck the door frame to the closet. Officers checked the apartments further and discovered a downstairs apartment had also been struck twice by bullets. No injuries were reported during this incident and the suspects are unknown.

March 19, 2015 - Plane Crash

Red Bluff Police dispatch received a 911 call from one of the occupants of a plane that reportedly crashed at the Red Bluff Airport. Red Bluff Police and Fire Department units responded to the scene and found the four occupants of the plane had extricated themselves from the wreckage. The plane experienced a mechanical failure on one of the brakes causing the plane to continue off of the runway down a 30 foot embankment. The occupants sustained minor injury.



March 30, 2015 - Burglary/Attempted Arson

Officers from the Red Bluff Police Department responded to the Tehama Country Visitor's Center regarding an alarm activation. When officers arrived, they discovered a window on the east side of the building had been shattered. While checking inside, officers saw the hatch to the attic was not properly seated and appeared to have been tampered with. In the attic, officers located a 22 year old male lying down between two rafters. The suspect was arrested and in his possession officers found a camp stove propane tank with an attached torch inside of it. Over the past several months, the police department has received several alarm calls from the Visitor Center. On some of those calls, there was evidence of a break in. There has also evidence of attempted arson.

May 14, 2015 - Residential Burglary, Attempted Car Theft, and Providing False Identification to Police

A resident at the Brickyard Creek Apartments called to report a male adult was trying to steal his car. The resident reported seeing the man leaving his apartment through the front door. The resident noticed the keys to his vehicle were missing from the kitchen counter. The suspect entered the resident's car, but was stalled by the resident until police arrived. The 22 year old suspect was booked at the jail.

July 19, 2015 - Arson/Disorderly Conduct/Vandalism/Poss. of a Destructive Device

Officers responded to 1125 Union Street for a 27 year old female who had thrown a Molotov cocktail at the residence and throwing bricks at the windows. Neighbors extinguished the fire, which caused minor damage. Officers located the female walking in the area and she was arrested and booked at the Tehama County Jail.

August 20, 2015 - Robbery and Assault with a Deadly Weapon, Burglary

Officers responded to the 1100 block of Franzel Road regarding a robbery that resulted in the two adult occupants sustaining minor injuries. The victims were sitting inside their living room when an acquaintance suddenly entered their apartment through the front door. The acquaintance had a pistol in his waist band and then pushed both victims into the kitchen. The acquaintance struck the male with the handgun and slapped the female victim while demanding money. The male victim gave the acquaintance an undisclosed amount of cash and the acquaintance fled the apartment.

August 23, 2015 - Violently Resisting Arrest and Battery on a Peace Officer

Officers responded the city park for a fight in progress. An officer arrived on scene and was approached by a 17 year old involved in the fight. The juvenile charged at the officer while the officer was seated in his patrol car. The juvenile threw several punches at the officer through the open driver side window. The officer was struck at least twice before he was able to drive forward and break contact with the suspect. The suspect then ran in an attempt to get away, but the juvenile was caught and arrested without further issues.

September 10, 2015 - Possession of a Firearm, Drugs and Drugs for Sale

A Red Bluff Police Department patrol officer conducted a traffic stop on Luther Road. The officer conducted a search of the passenger who was on parole and located 25.3 grams of methamphetamine. The officer found a loaded 357 revolver in the vehicle, which was confirmed to have been stolen.

September 26, 2015 - Domestic Battery, Discharge a Firearm in a Negligent Manner.

Officers responded to a domestic disturbance at 1237 Aloha Court where the victim reported her 79 year old husband threatened to kill her while holding a shotgun inside their residence. A struggle ensued over the

weapon when the husband fired one shot into the ceiling. The victim fled the residence after she was slapped by her husband. The husband was arrested and booked into jail.

October 4, 2015 - Burglary, Obstruct/Resisting a Peace Officer, and Battery on a Peace Officer

Officers were sent to a burglary alarm at Owens Healthcare on South Main Street. When officers arrived they saw the suspect being chased by a witness. The 23 year old suspect was fleeing from the business near the railroad tracks. Officers tackled the suspect near Montgomery Road and attempted to apprehend him. The suspect resisted and elbowed officers as they were trying to gain control of him. The suspect was arrested and officers found stolen items from the business within his pockets. One officer was injured during the arrest and was later treated and released from the hospital.

October 5, 2015 - Possession of Weapon(s) on School Grounds and Altered Imitation Firearm

Red Bluff Police Department received information from Red Bluff High School administration of a student possibly in possession of a firearm. Upon arrival, officers immediately located and detained a student matching the description provided by witnesses. A pellet gun altered to resemble a semi-automatic handgun was located in the 17 year old male's backpack, along with a knife with a locking blade. The minor, who has a criminal history and self-proclaimed gang affiliation, was arrested.

November 6, 2015 - Mental Health Detention

Red Bluff Police Dispatch received a 911 call from a resident at the Villa Columba apartments at 760 Main Street. The 66 year old resident requested police respond to his apartment. The caller advised he was armed with firearms and intended to shoot the police upon their arrival. The resident also mentioned there was another man that needed immediate help inside his apartment but would not elaborate on the reason. Officers arrived and with the help of deputies from the Tehama County Sheriff's Office surrounded the resident's apartment and began negotiations with him. Officers were finally able to get the resident to open his back sliding door and exit the residence where he was taken into custody. The apartment was then checked for injured persons and the resident was interviewed. The Officers determined the resident was delusional as a result of a mental illness. The resident was detained for a mental health evaluation. There were no injuries a result of this incident and no firearms were discovered.

December 11, 2015 - Brandish a Firearm

A 19 year old male reported he and his friend where sitting in his car inside of the Main Street Auto Spa parking lot where they were approached by two men. One of the men knocked on the driver's side window and was holding a semi-automatic pistol. The 19 year old quickly drove away to the police department to report this incident. The suspects were not located.

December 19, 2015 - DUI Collision

Officers responded to a collision on Walnut Street near Baker Road where a 52 year old driver collided into two power poles, causing most of the west side of Red Bluff to lose power. The driver was intoxicated and subsequently arrested for DUI with a BAC of .30%. The area of Walnut Street between Hailey Lane and Baker Road was closed for the entire night as PG&E worked on the downed lines to restore full power.

December 25, 2015 - Felony Evading, Resisting/Delaying Officer/Arrest Warrants

A Red Bluff Police officer made a traffic stop on the 100 block of Sale Lane. As the officer approached the vehicle, the 39 year old driver suddenly sped away. The officer then pursued the vehicle, which reached speeds over 100 mph. Sheriffs' deputies subsequently took over the pursuit, which ended after the driver failed to make a sharp turn and drove off the roadway in the City of Tehama. The two vehicle occupants fled

the vehicle, but were arrested. It was later learned that the driver was on Post Release Community Supervision in Shasta County and had cut his ankle monitor off prior to this case.


10 Year Statistical Comparison
