PALOS VERDES PENINSULA REGIONAL CONTRACT LAW ENFORCEMENT MINUTES TO MEETING ON THURSDAY, MAY 12, 2022

I. CALL TO ORDER

A meeting of the Palos Verdes Peninsula Regional Law Enforcement was called to order by Chair Zuckerman at 9:47 a.m. via Zoom.

IV. APPROVAL OF MINUTES

A. MINUTES OF FEBRUARY 10, 2022

Motion by Member Bradley to approve the minutes. Member Dieringer presented edits to the minutes.

Member Bradley motioned to approve the minutes as amended and Member Dieringer seconded the motion.

Minutes were adopted without objection.

VI. <u>NEW BUSINESS</u>

A. INTRODUCTION OF LOMITA SHERIFF'S STATION CORE TEAM

Los Angeles County Sheriff Captain James Powers introduced Lomita Sheriff's Station's new Community Resource (CORE) deputies, Deputy Darlene Lopez-Beltran and Deputy Ben Russell.

Chair Zuckerman thanked Deputy Lopez and Deputy Russell for joining the meetings and invited them to introduce themselves.

Deputy Lopez will be focusing on Rolling Hills and sharing Rancho Palos Verdes with Deputy Russell. Deputy Russell has been a deputy for three years at Lomita Station and will be focusing on Rolling Hills Estates and sharing Rancho Palos Verdes.

Chair Zuckerman thanked Deputy Lopez and Deputy Russell.

B. QUARTERLY LAW ENFORCEMENT/TRAFFIC/COMMUNITY OUTREACH REPORT (LOS ANGELES COUNTY SHERIFF'S DEPARTMENT)

Captain Powers summarized the traffic statistics for the first quarter of 2022. Captain Powers highlighted the three vehicle-versus-pedestrian fatalities: two in Rolling Hills Estates (January and February) and one in Rancho Palos Verdes (March). Captain Powers is looking into preparing an informational/awareness bulletin to help provide pedestrian safety education.

Captain Powers reported that a new motorcycle deputy has been hired following the previous deputy's retirement. Traffic enforcement has therefore increased.

Captain Powers summarized the crime statistics for the first quarter of 2022, emphasizing residential burglaries and larceny thefts being of concern. Grand theft autos were down but also of concern.

Captain Powers summarized the crime map for Rancho Palos Verdes, highlighting that there were no patterns but that the Station is focusing on residential burglaries, larceny thefts, and grand theft autos.

Captain Powers thanked the cities for their investments in public safety technology.

Captain Powers summarized the crime statistics for Rolling Hills Estates, highlighting the larceny thefts and the increase in residential burglaries. He also reported on a larceny theft from a business in the Peninsula Center the prior day, that the employees were prompt in reporting the incident and deputies were able to locate the vehicle and three suspects were arrested.

Captain Powers reported that aggravated assaults across Los Angeles County have increased, due to domestic violence, in part, and potentially due to financial difficulties.

Captain Powers summarized the crime statistics for Rolling Hills, reporting no crimes during the first quarter.

Captain Powers addressed that although a few emergency response times around 10 minutes, there was no cause for concern and that response times remain within the guidelines of the target range (7 minutes for emergency calls, 20 minutes for priority calls, and 60 minutes for routine calls).

Chair Zuckerman asked if quarantine and remote work also contributed to aggravated assaults. Captain Powers agreed, noting that at the start of lockdown, aggravated assaults increased significantly.

Member Alegria left the meeting at 10:00 a.m.

Chair Zuckerman asked if the pedestrian fatalities occurred outside of crosswalks. Captain Powers confirmed that the first incident was at Palos Verdes Drive North and Dapplegray Ln, where there are no crosswalks. Captain Powers noted there may have been other contributing factors regarding the individual. The second incident was on Indian Peak Rd. near Hawthorne Blvd. and while there was a crosswalk nearby, Captain Powers does not believe it was used. The third incident was on Hawthorne Blvd. in Rancho Palos Verdes and Captain Powers did not know if there was a crosswalk.

Chair Zuckerman expressed concern regarding the traffic accidents and asked if there was anything that could have been done to prevent them. Captain Powers shared that all three vehicle drivers were driving within the guidelines of the law.

Chair Zuckerman thanked Captain Powers for his report.

Member Dieringer asked if domestic violence victims receive additional services following a call to the Station. Captain Powers shared that every domestic violence call they respond to, they provide a pamphlet with resources. Due to levels of confidentiality, LASD cannot follow up to know what actions, if any, survivors take with the information provided to them.

Member Dieringer asked, following up from the last meeting where businesses were not reporting thefts to LASD if that dynamic has shifted. Captain Powers reported that during the holiday season, there was a lack of cooperation based on corporate policies and procedures. Station detectives and LASD Major Crimes Bureau have been following up with corporate offices regarding these thefts and procedures, and they have been seeing more cooperation with businesses.

Member Dieringer asked about a "Fire" listed in the emergency response calls on March 24. Captain Powers responded that he would look into the incident.

Chair Zuckerman asked regarding confidentiality, if a regular patrol car is used in a domestic violence call. Captain Powers affirmed that patrol cars are dispatched. Chair Zuckerman commented that marked cars may deter individuals from reporting. Captain Powers clarified that when someone calls in, they are asked if they would like to be contacted, but if deputies are responding to a home, they are typically in marked vehicles. While the Station has unmarked vehicles that are deployed in certain capacities, it is not a routine practice.

C. QUARTERLY MEDICAL TRANSPORT RESPONSE TIMES REPORT (RHE)

Acting Assistant Chief Brian Bennett provided a summary of total incidents and response times in each of the cities. Chief Bennett explained that the majority of incidents with response times outside of the target range were due to a secondary unit coming into the city, particularly into Rancho Palos Verdes, where the incident was further away and through tight streets. Average response times were about normal, call volume was down slightly from last year.

Chief Bennett shared that they are working on additional training to address some of the longer response time periods which were the result of not properly indicating when a unit was on scene (hitting the "on scene" button in their computer).

Regarding Member Dieringer's question on the fire call on March 24, Chief Bennett reported that he did not recall a fire in March but that he would also look into the incident.

Chief Bennett thanked Captain Powers and the deputies for keeping the community and firefighters safe and for their continued collaboration.

Member Dieringer asked a question regarding report notation on what "Unit did not arrive and/or One Scene (arrival) time is null" and "On Scene (arrival) Time = Clear Time" means. Chief Bennet explained that did not arrive indicates a good intent call where the reporter called in and then called back to say they did not need a fire department response. Chief Bennet further clarified that when on scene time and clear time are the

same, it indicates an error on their side when the "on scene" button is not selected upon arrival to the scene

Member Dieringer asked regarding the call categories if it indicates what the call came in as, rather than an actual event, such as "Fire, Explosion." Chief Bennet confirmed that calls are classified as they are reported, in broad categories that do not necessarily represent what firefighters find.

Member Dieringer asked for examples of service calls and special/other incident types. Chief Bennett explained that an example of a service call is a lift assist, where they help someone get back in bed, or a water leak. Engine companies do not use lights and sirens for these calls, they typically have longer response times but are not required to be within the same time limit as other calls. Chief Bennet explained that special/other incidents are a non-emergent call that doesn't fit into any of the other categories.

Member Dieringer requested that required times be included in the report for reference and requested copies of exceedance calls. Chief Bennet shared that he would send the record of exceedance calls.

Captain Powers thanked Chief Bennett for his kind words and remarked that the partnership is mutual and that it is important that they work well together. Captain Powers also shared that they responded to the fire call on March 24, but there was no fire – the resident was having a barbeque and a neighbor saw the smoke.

D. FUTURE MEETING FORMAT DISCUSSION

Chair Zuckerman noted that the discussion from the Peninsula Public Safety Committee covered this item and Regional Contract Law Committee meetings would also continue virtually.





2nd Quarter Average Response Times






ROLLING HILLS 2nd Quarter Average Response Times






