### I. CALL TO ORDER

A meeting of the Palos Verdes Peninsula Regional Law Enforcement was called to order by Chair Dieringer at 9:16 a.m. via Zoom.

### V. OLD BUSINESS

# A. UPDATE ON REGIONAL CONTRACT LAW CITIES LOGO ON SHERIFF'S VEHICLES (RPV).

Administrative Analyst Bright informed the committee that the City of Lomita approved the design of the logos.

Councilmember Schmitz motioned to approve the logos and Mayor Zuckerman seconded the motion.

### VI. <u>NEW BUSINESS</u>

### A. QUARTERLY LAW ENFORCEMENT/TRAFFIC/COMMUNITY OUTREACH REPORT (LA COUNTY SHERIFF'S DEPARTMENT)

Captain Powers suggested the report be summarized.

Councilmember Schmitz agreed that summarizing was adequate.

Captain Powers explained the traffic statistics and reported there were no fatalities to report this quarter, although there was an increase in traffic collisions. He explained that the enforcement activity report will be postponed due to his Motor Officer being out on medical leave, and the cities will not be billed due to the item being suspended. Furthermore, he explained that due to the MOU requirements within his department such staff member cannot be replaced until the status of the medical leave is provided. Captain Powers continued with his report stating that the averaged event index correlates with all numbers, and informed the committee that there were a couple of DUI arrests. He also explained his presentation and what each icon represented.

biggest crime reported in the Peninsula area were regarding vehicle robberies and other theft activity, especially by hiking trails. He also explained how aggravated assaults have increased during the COVID pandemic, and reiterated the importance of being patient. Lastly, Captain Powers explained that crime rates increased and there have been a couple of bizarre situation that have occurred. There were some robberies that occurred because of communicate done via the Facebook market page, and another instance where an individual was hiking the trails at 2:00 am and his watch got stolen.

Mayor Zuckerman had a couple of questions regarding electric motorized bicycles, California regulations pertaining to them, and asked if Captain Powers had any guidance regarding this matter.

Captain Powers informed Mayor Zuckerman that he was aware electric bicycles could increase in speed, but would research the State laws, and apply such laws and any other laws pertaining to regular bikes if needed.

Councilmember Schmitz logged off at 9:31 am.

Mayor Pro Tem Bradley expressed his appreciation for the presentation and maps prepared by Captain Powers and his team, as it allows him to visualize the statistics.

Mayor Zuckerman asked if the GIS system will be used to attain the necessary data.

Captain Powers informed the committee that the department will no longer use the current system to collect data as they have been using previously, but are researching an alternative option. He further explained that they might become reliable on using the GIS system.

Mayor Dieringer asked if trespassers are arrested even if the D.A.'s office in the Peninsula are not prosecuting such matters. She also explained how RH has drafted its own ordinance in regards to trespassing, so trespassers can be prosecuted by City Attorney means.

Captain Powers stated his staff are instructed to make arrests regardless if such cases do not get filed.

# B. EVALUATION OF WESTMED/ McCORMICK AMBULANCE RESPONSE TIMES (RH).

Senior Management Analyst Ball explained that initially the committee were receiving noncompliance ambulance response time reports from McCormick, and proceed to explain the categories, and committee's decision for McCormick to cross reference their reports with that of the Los Angeles County Fire Department (LACoFD). Lastly, he proceeded to report out the number of reports given, and expressed how the goal of such item is for staff to be assigned to report any performance issues and make recommendations as appropriate instead of McCormick.

Mayor Dieringer expressed how having staff evaluate the data and show the committee their analyses will be helpful, but it is also helpful to have those calls reported out to see the location of where McCormick provided services too, and determine if there are any repeated offenders. Furthermore, she explained that it is also helpful to see the data between the ambulance and the fire department arrival, and to have information available, such as any concerns when the first responders arrived, if patients that needed assistance were transported in a timely manner, and any other available information to make their services better. Mayor Dieringer stated that it is not to include every single call as reported before, but at least for reports to have some information that can open and allow for questions from the committee.

City Clerk Sandoval expressed there was no quorum for any action to be taken on the item.





**3rd Quarter Average Response Times** 



# **ROLLING HILLS** 3rd Quarter Average Response Times





#### RECOMMENDATIONS

- 1. Receive a report from staff, the Los Angeles County Fire Department and McCormick on ambulance response times.
- 2. In lieu of receiving listing of all ambulance calls and response times, the Los Angeles County Fire Department and or McCormick will provide brief quarterly reports on response trends, operational adjustments and recommendations to improve ambulance response times.

### BACKGROUND

At the August 12, 2021 Committee meeting, staff recommended that the Committee direct staff to evaluate the ambulance response times with McCormick and the Fire Department. Staff also recommended the Committee to direct staff to report on performance issues with recommendations to improve response times, if appropriate.

The Committee did not take action on staff's recommendations at the August 12, 2021 meeting. Commenting on staff's recommendations, Committee member Bea Dieringer expressed her desire to continue to have call for service data from McCormick and to have the information crossed referenced with response times with the Los Angeles County Fire Department. Committee member Dieringer added that the data is necessary

REGIONAL LAW CONTRACT COMMITTEE AMBULANCE RESPONSE TIME NOVEMBER 18, 2021 6-B to see if patients are transported in a timely manner and to allow for questions from the Committee.

In July 2021, Rolling Hills staff worked with McCormick and the Los Angeles County Fire Department to prepare ambulance response time reports for the August 2021 Committee meeting. McCormick and the Los Angeles County Fire Department both expressed that the reports are labor intensive and that per McCormick's contract with the Los Angeles County Emergency Medical Services (EMS) Agency, McCormick is not required to provide the data to the Peninsula Cities.

In preparation for this report, staff found that in 2015, McCormick noted to the Committee that the response time data was provided as a courtesy to the group.

February 12, 2015 Palos Verdes Peninsula Regional Law Enforcement Committee Minutes MC CORMICK AMBULANCE REPORT/OVERIVEW OF SERVICES

Joe Chidley, McCormick Ambulance provided an overview of their services to the South Bay, including the Palos Verdes Peninsula, which is in EOA Zone 7 and served through a contract with the County of Los Angeles. He stated that the current contract is a 10-year contract and began in 2006. <u>He commended that during the term of their contract they have been open in providing the response time data for the Palos Verdes Peninsula area and continue to work on ways to improve the response times in the area on the South side of <u>Peninsula</u>. He reviewed the compliance data for EOA Zone 7 for 2014 that shows the response time is continually over 94% in compliance at eight minutes or less...</u>

...Discussion ensured concerning the response times for the portions of the Rancho Palos Verdes on the South side of the Peninsula. Member Brooks commented that the City of Rancho Palos Verdes recognizes the need for improved service in that area given the influx of people visiting the area along Palos Verdes Drive South recently and asked Mr. Chidley for McCormick's help in addressing the need for an ambulance substation in that area. Mr. Chidley reviewed McCormick's current efforts in addressing the service needs of that area including posting an ambulance in that area during peak times. Further discussion ensued concerning adding a substation on the South side of the Peninsula with Trump National being identified as an optimal location. In response to Member Hill, Mr. Chidley commented that McCormick would be willing to put a facility in if an area was made available. Discussion ensured concerning possible locations and facilities.

In reviewing Committee meeting minutes dating back to 2006, the Committee received brief statistical reports from McCormick followed by discussion on recommendations to

improve response times. The below excerpt is from the November 17, 2009 meeting minutes.

November 17, 2009 Palos Verdes Peninsula Regional Law Enforcement Committee Minutes MC CORMICK AMBULANCE REPORT

Mike Henderson of McCormick Ambulance reviewed the quarterly ambulance statistics, by city for the time period from July through September 2009. He noted that during this time period, there were no calls over 15 minutes. He further stated that the overall response time for the region was good with most calls being responded to in less than five minutes which is below the target response time of 8 minutes 59 seconds, in the Portuguese Bend Area of Rancho Palos Verdes mostly due to where the units are responding from. <u>Member Long asked Mr.</u> Henderson what he would recommend as a mechanism to improve response times in that area. Mr. Henderson suggested that possibly a trailer could be located on the Rancho Palos Verdes City Hall campus, at McCormick's expense, to help improve response time.

The minutes to the May 11, 2017 Committee meeting discussed that beyond the compliance measure of responding within 8 minutes and 59 seconds per call, McCormick also reported that if the aggregate response times were to fall below the 92% threshold, penalty fees are imposed per McCormick's agreement with the Los Angeles County EMS.

May 11, 2017 Regional Committee Law Enforcement Minutes REPORT WITH COMPARISON OF AMBULANCE RESPONSE TIME COMPLIANCE ACROSS COUNTY

Administrative Analyst Ruiz presented comparisons of McCormick response times based on data provided by the County of Los Angeles including the agreement by and between the County of Los Angeles and Westmed Ambulance, 2016 Los Angeles County EMA Agency Response Time Audit Summaries for all Exclusive Operating Areas (EOA), and 2016 McCormick Ambulance quarterly reports for the Peninsula region...

#### ...<u>McCormick representative Daniel Perez clarified that if their response</u> times were to fall below the 92% threshold, penalty fees are imposed per the agreement. To date McCormick has never been assessed a fine...

#### DISCUSSION

In reviewing Committee meeting minutes from 2006 and beyond, the purpose of presenting statistics on ambulance response times is to identify trends, systemic

REGIONAL LAW CONTRACT COMMITTEE AMBULANCE RESPONSE TIME NOVEMBER 18, 2021 6-B problems with ambulance service in the Peninsula, and to discuss possible solutions to improve response time, if necessary.

McCormick and the Los Angeles County Fire Department reported to staff that in recent months, the wait time to discharge a patient at the hospitals are causing ambulance units to standby for over an hour. This issue has hindered the ability for McCormick to response to subsequent calls and units from other areas for support. Ambulance personnel are to report these issues to the nearby Los Angeles County Fire Department Battalion Chief. The Los Angeles County Fire Department Battalion Chiefs have been dispatched to hospitals to work with medical care professionals to discharge patients to free up ambulance units so that the ambulances can respond to other calls.

The operational difficulty outlined above cannot be easily deduced from line stats on calls for service. The Los Angeles County Fire Department and or McCormick personnel can discuss and inform the Committee on this operational difficulty and discuss the effectiveness of the dispatched Battalion Chiefs or other measures to overcome the difficulty.

### CONCLUSION

Review line-by-line data to determine if McCormick has met the compliance measure of responding within 8 minutes and 59 seconds is already being performed by the Los Angeles County EMS Agency as a part of McCormick's contract. Additionally, if McCormick's overall compliance rate by year falls under 92%, McCormick will be fined by the contracting agency.

In lieu of receiving listing of all ambulance calls and response times, the Committee would have more impactful data by having the Los Angeles County Fire Department and or McCormick provide brief quarterly reports on response trends, operational adjustments and recommendations to improve ambulance response times.
