CALLED WORK SESSION:

Call to Order: The June 22, 2019 Called Work Session was called to order by Mayor David L. Jordan at 4:42 pm.

Discussion:

- A. **Election Schedule for 2019:** City Clerk handed out a schedule for the upcoming election cycle with dates and deadlines for needed forms. Qualifying is Aug 26 to Aug 28. 3 Council Seats up for Re-Election. Election date will be November 5, 2019.
- B. **Royston Elementary School Discussion:** Possibility of School Board building a new elementary school outside Royston City Limits. Comparison of some alternate proposed sites within the city limits. The council agreed a meeting with the new School Superintendent was warranted. A meeting with the Franklin county school board also recommended. The City needs to present some options to the school board. Mayor Jordan brought up conferring with John Barstow about creating a plan to present to the board. City Manager will contact the School Superintendent to set up a meeting. Also need to address putting up a fence to close school grounds at night for safety purposes.
- C. **Issues to be addressed in future meetings- Andrea Grant:** The City Attorney handed out a list of items that had been discussed in the past but never completed. These items need to be added to future Work Session or Meetings.
