Dear Salem Neighbors,

I hope this letter finds you and your family off to a good start for the New Year. Here are the latest updates:

#### LANDFILL

As we said in our last newsletter, Advanced Disposal has withdrawn the request to have an area for future expansion. We learned in February of this year that Advanced Disposal assumed control of the gas system. With the system now under Advanced Disposal's control, they are working with the EPA and the DQ to put in place additional improvements to the gas collection system as soon as possible. Hopefully, this will put an end to the concerns about odors.

#### USD (Gotfredson & M-14)

In November, the Board of Trustees approved a proposed Lease Agreement with the Ypsilanti Community Utilities Authority (YCUA) to reserve sewer capacity in the YCUA wastewater collection system and wastewater treatment plant. This agreement allows the Township to reserve sewer capacity with YCUA until such time as the developers actually construct the necessary sewer system for the USD. The first developer in the USD, Salem Springs (Schostak Brothers) has agreed to pay the costs of reserving the YCUA capacity from the end of this year until the developer has determined how it will finance the construction of the sewer and water utilities. By entering into this agreement, it assures that the Township will have available the necessary sewage capacity from YCUA when it is ultimately needed for the USD and it also satisfies the requirement of Township Master Plan to have public utilities service the USD area.

In addition to the Lease Agreement with YCUA, the Township engineers have also developed engineering and design standards for the utilities in the USD and these standards have been adopted by the Township. All construction costs for the infrastructure for the USD public utilities will be paid for by the developers and property owners in the USD and not by the Township.

It appears that the first major development in the Urban Service District will be the Salem Springs large residential development of 370 acres north of Joy Road between Napier and Gotfredson. The Township Board recently extended the PUD Ordinance for this



development provided that Salem Springs must have a Development Agreement acceptable to the Township approved and finalized by January 31, 2019.

The extension of the PUD Ordinance is further conditional upon Salem Springs having a plan in place to finance the public utilities for the USD and approved by December 31, 2018. An amended Area Plan for the Salem Springs residential development was submitted to the Township in January. Anyone wishing to review this plan can do so at the Township office.

In closing, please feel free to reach out to me anytime. It has been my pleasure to meet with and talk to some of you about questions or concerns you have had. I look forward to hearing from you in the future.

## TREASURER'S UPDATE

The Township, in particular the Treasurer's office, has been overwhelmed with calls regarding the substantial increase in their winter taxes in the Plymouth and Northville school districts. I regret that this explanation comes after the 2016 winter tax season has come to a close, but for those that did not contact the Township, an explanation is sill required.

A two (2) mill Wayne County Regional Education Service Agency Enchantment passed on the November 8 ballot by the greater Wayne County voters. The revenue raised by the mileage is being collected by the Wayne County Regional Educational Agency and will be distributed to all local Wayne County Public Schools based on pupil membership count. The 2.00 mill ad valorem tax will be imposed for six years to provide additional funds to enhance other state and local funding for the local Wayne County Schools.

The proposal was only on the ballot for the residents that reside in the Plymouth and Northville school districts. Even though the voters in those school districts rejected the proposal, residents are still required to pay the increased taxes since those school districts are in the Wayne County School system.


Two other November ballot proposals that were passed have some residents questioning the legality of the proposals based on several newspaper articles. This office is required by law to collect and distribute all taxes that are imposed by our taxing authorities. However, I felt it was my responsibility to obtain an explanation as to their legality and report back to all Salem residents.

Article 9, Section 31 of the Michigan Constitution states that units of government are prohibited ONLY from levying a tax not authorized by law or charter when that section of the Constitution was ratified. The two mileages were authorized by State law before this section of the Constitution was ratified and, therefore, the County may levy these mileages without the vote of the people. These mileages have been contested by the United Michigan Foundation that claimed that "a vote of the people was required" was rejected by the Court of Appeals and the case was dismissed.

The Washtenaw Board of commissioners decided to set aside the court's decision and put these mileages on the November 8 ballot. Voters approved a levy for Roads at .5 mil and for Veterans' at .1 mills. These are now voted mileages and do not have to pre-date the Michigan Constitution.

The Township has benefited from the non-vote .5 mill that was imposed for the past two years. Curtis Road was improved the first year and Six Mile road was repaved through the Hamlet last summer. The Veterans services in Washtenaw County assist veterans, survivors and dependents with a variety of services ranging from help with obtaining VA disability compensation and pensions, to securing federal and local burial benefits.

#### **Ann Arbor School Election - Precinct Consolidated**

For the upcoming May 2, 2017 Ann Arbor School election, in an effort to save taxpayer dollars, we have consolidated the precinct for this election only due to the small number of electors in this school precinct. Citizens who reside in the Ann Arbor school system will vote at the Northfield Fire Station #2. It is located at 2727 E. North Territorial Rd., Whitmore Lake, MI 48189. It is the fire station on North Territorial just west of Sutton Rd., on the North side of North Territorial.

## **Inside Michigan Politics - 2016 Public Acts**

The Michigan Legislature introduced many new issues that were signed into law during the end of 2016. The following is a partial list of 2016 public acts that may impact townships throughout Michigan.

- PA 25: Property Tax Assessment Rolls: Allows assessor to maintain assessment rolls electronically.
- PA 55: Recycling Requirements: Creates registration and reporting requirements for recyclers of material from residential and commercial waste.
- PA 111: Traffic Sign Vandalism: Prohibits and prescribes graduated penalties for a person who willfully and maliciously damages, destroys or removes a traffic control device.
- **PA 236: Crimes:** Provides for the recovery of certain costs for prosecution of an intentional false report of a public threat.
- PA 380-381: Underground Storage Tanks: Modifies requirements for cleanups and financial responsibility of underground storage tanks and provides alternative mechanisms to protect against exposure to environmental contamination.
- PA 437: Landfill RDDP Permit Term: Extends authorized term for landfill research, development and demonstration projects from 12 years to 21 years.



## ASSESSING OFFICE

I have been working on your 2017 property assessment. Your assessment, by State law is suppose to reflect half of what your home would have sold for on December 31, 2016. Each year the County Equalization Department looks at the sales of homes in our Township, and compares the prices with the values I put on your house for 2016. This year they have told me that my values need to increase by 8% for 2017. This doesn't mean your taxes will go up 8%, because you are now protected by the taxable value increase, which for this year is .9%.

Look for your "Notice of Assessment" in the mail. It will say "this is Not a Bill" on the top. Read over it carefully because if you feel your value is too high, the only time you can appeal it is on the days and times I have posted below. The Notice will have an estimate of how much your taxes will go up for 2017. Bring something with you that supports your opinion of your home value, maybe you had an appraisal done in the last year, or maybe you just bought it for a much lower price.



# Easter Brunch Casserole

## **Ingredients**

- 4 cups frozen shredded hash brown potatoes, thawed
- 1 pound bulk pork sausage, cooked and drained
- 1/2 pound bacon strips, cooked and crumbled
- 2 cups (8 ounces) shredded cheddar cheese, divided
- 1 cup biscuit/baking mix

- 1 medium green pepper, chopped
- 1 green onion, chopped
- 4 large eggs
- 3 cups 2% milk
- 1/2 teaspoon Lawry's Seasoned Salt

#### **Directions**

- 1. In a large bowl, combine the potatoes, sausage, bacon, green pepper and onion; stir in 1 cup cheese. Transfer to a greased 13x9-in. baking dish
- 2. In another bowl, whisk eggs, milk, baking mix and salt until blended; pour over top. Sprinkle with remaining cheese. Refrigerate, covered, overnight.
- 3. Preheat oven to 375°. Remove casserole from refrigerator while oven heats. Bake, uncovered, 30-35 minutes or until a knife inserted near the center comes out clean. Let stand 10 minutes before cutting. Makes 12 servings
