Additional charges will be made for extra work caused by underground problems not made known to Show Me Petroleum Equipment Company LLC prior to submitting this proposal, including but not limited to hidden rocks, cave-ins and excessive water (such extra work shall be paid by customer upon submission of Show Me Petroleum Equipment Company LLC's bill therefore and shall not be subject to the "Change Order Policy" mentioned below). Show Me Petroleum Equipment Company LLC will not be responsible for settlement of backfill in excavated areas.
