### **RECOMMENDATION**

- Provide staff feedback on the conceptual designs presented for the Aquatic Center renovation project.

### **BACKGROUND**

On November 2, 2022, the City entered into an agreement with HED to design the renovations at the Aquatic Center. City staff has met with HED several times since November to develop conceptual designs of the Aquatic Center. The next step, which is tonight, is a City Council Study session to review conceptual designs and estimated pricing of the Aquatic Center renovations, which will include a presentation from City staff and HED.
