BACKGROUND

The Santa Fe Springs Public Financing Authority (PFA) is a City entity that has periodically issued debt for the benefit of the Santa Fe Springs community. The following is a brief status report on the debt instruments currently outstanding that were issued through the PFA.

Consolidated Redevelopment Project 2006-A Tax Allocation Bonds

Bond Repayment

The former Community Development Commission (CDC) issued a number of tax allocation bonds before it was dissolved by State law effective February 1, 2012 which are administered by the City acting as Successor Agency under the oversight of the appointed Oversight Board. The Successor Agency no longer receives tax increment. Instead, distributions from the Redevelopment Property Tax Trust Fund (RPTTF) are received based on approved obligations. It is anticipated that sufficient allocations from the RPTTF will continue to be made to the Successor Agency to meet ongoing debt service obligations.

Unspent Bond Proceeds

Under an approved Bond Expenditure Agreement, unspent bond proceeds of the former CDC in the amount of approximately \$19 million were transferred to the City in July 2014. The funds are to be spent in accordance with the original bond documents. The unspent proceeds continue to be a source of funding within the City's capital improvement program (CIP).

2016 Bond Refunding

In July 2016, the Successor Agency issued its 2016 Tax Allocation Refunding Bonds, which paid off several bond issuances of the former CDC. The bonds were originally issued through the Public Financing Authority and included the 2001 Series A, 2002 Series A, 2003 Series A, the current interest portion of the 2006 Series A, and 2006 Series B bond issuances.

2017 Bond Refunding

In December 2017, the Successor Agency issued its 2017 Tax Allocation Refunding Bonds, which paid off the 2007 Tax Allocation Bonds of the former CDC. The 2007 Bonds were originally issued through the Public Financing Authority.

BACKGROUND

The Santa Fe Springs Water Utility Authority (WUA) is a City entity that has issued debt for the benefit of the Santa Fe Springs community. The following is a brief status report on the debt instruments currently outstanding that were issued through the WUA.

Water Revenue Bonds, 2013

Financing proceeds available for appropriation at 3/31/2022 None Outstanding principal at 3/31/2022 \$6,890,000

Water Revenue Bonds, 2018

Financing proceeds available for appropriation at 3/31/2022 None Outstanding principal at 3/31/2022 \$1,025,000

In May 2013 the Water Utility Authority issued the 2013 Water Revenue Bonds in the amount of \$6,890,000. The bonds refunded the existing 2003 Water Revenue Bonds (issued through the Public Financing Authority) and provided additional funds for water improvement projects in the amount of \$2,134,339. The funds were restricted for use on water system improvements. In August 2013 the Water Utility Authority Board appropriated the proceeds for the Equipping Water Well No. 12 Project and all proceeds were since used on this project.

In January 2018 the Water Utility Authority issued the 2018 Water Revenue Bonds in the amount of \$1,800,000. The bonds refunded the existing 2005 Water Revenue Bonds (issued through the Public Financing Authority). No additional funds were raised through the issuance of the 2018 Water Revenue Bonds.

The City budget includes sufficient appropriations and adequate revenues are expected to be collected to meet the debt service obligations associated with the 2013 and 2018 Water Revenue Bonds.

BACKGROUND

This report is for informational purposes only. The following is a listing of current active water projects.

Water Well No. 2 Assessment Status Update

Constructed in 1963, Water Well No. 2 has been inactive since 2006 due to a change in water quality requirements from the State Water Board. On July 20, 2021, the City Council approved awarding the contract to General Pump Company Inc. to assess Water Well No. 2. The contractor completed the initial assessment and has submitted to the City their final report, which confirmed only one contaminant, and provided two scenarios for treatment, the report recommends assessing the well's structural condition, which includes an additional, more detailed video log. Staff concurs with performing a gyroscopic/deviation survey and finally a Casing Inspection Thickness Measurement (CITM) survey. The additional authorized work has already begun and should be completed within the next few weeks. Staff is currently investigating cost-effective treatment options that will remove the one verified contaminant and get Water Well No. 2 operational once again to produce safe drinking water.

Water Storage Tank Inspection

The City has two drinking water storage tanks, which were last inspected in 2016. Industry standards suggest water storage tanks be inspected every five years to help ensure a long service life. Staff has contacted several experienced tank inspection companies and received quotes. Staff will schedule the inspection of the water storage tanks without taking them out of service.

FISCAL IMPACT

A total of \$167,000 has been budgeted for Water Well No. 2 assessment. There are sufficient funds available in the Water Utility Division Operation & Maintenance Budget to cover the cost (approximately \$4,000) for the inspection of the City's two water storage tanks.

INFRASTRUCTURE IMPACT

A comprehensive assessment of Water Well No. 2 has provided City staff the information needed to determine that the water well can be rehabilitated and minimal treatment is necessary to meet all drinking water standards. This project has the very likely potential to allow the City to deliver high-quality groundwater and reduce the City's dependence on costly imported water from the Metropolitan Water District of Southern California.

BACKGROUND

At its regular meeting of December 7, 2021, the City Council adopted Resolution No. 9747 authorizing the City Council and all legislative bodies and committees of the City to meet by teleconference. In order to continue holding teleconference meetings pursuant to this new law, an agency is required, at least every 30 days, to make the following findings by majority vote:

- (A) The legislative body has reconsidered the circumstances of the state of emergency.
 - (B) Any of the following circumstances exist:
 - (i) The state of emergency continues to directly impact the ability of the members to meet safely in person.
 - (ii) State or local officials continue to impose or recommend measures to promote social distancing.

On March 4, 2020, the Governor issued a proclamation declaring a state of emergency due to the threat of COVID-19. The California Department of Public Health and the County of Los Angeles Department of Public Health have issued public health orders during this state of emergency for the purpose of reducing transmission of COVID-19. Such orders have included social distancing requirements. The state of emergency continues to directly impact the ability of the members to meet safely in person due to a number of factors, including the high number of daily cases and community transmission and increased transmission of COVID-19 by the Delta variant. The Department of Public Health has stated that the Delta variant is two times as contagious as earlier variants, remains predominant in Los Angeles County, and continues to lead to increased infections.

Accordingly, staff has prepared the attached resolution to continue to authorize remote teleconference meetings and will include on all future meeting agendas such a resolution until such time as the state of emergency ceases, or as otherwise directed by the City Council.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANTA FE SPRINGS, CALIFORNIA, REAFFIRMING THE EXISTENCE OF A LOCAL EMERGENCY DUE TO THE THREAT OF COVID-19

WHEREAS, on March 4, 2020, the Governor of California issued a proclamation declaring a state of emergency due to the threat of COVID-19; and

WHEREAS, on March 13, 2020, the President of the United States issued a proclamation of national emergency, beginning March 1, 2020, due to the COVID-19 outbreak; and

WHEREAS, on March 17, 2020, the City Manager, acting as the Director of Emergency Services, issued a proclamation declaring the existence of a local emergency beginning March 12, 2020, due to the threat of COVID-19; and

WHEREAS, on March 18, 2020, the City Council adopted Resolution No. 9668 ratifying the proclamation declaring the existence of a local emergency, and on April 9, 2020, the City Council adopted Resolution No. 9669 relating to taking action in response to the local emergency; and

WHEREAS, the City Council previously adopted resolutions reaffirming the existence of a local emergency due to the threat of COVID-19 pursuant to Government Code section 8630(c), which provides that the City Council shall review the need for continuing the local emergency at least once every 60 days until the City Council terminates the local emergency; and

WHEREAS, the state of emergency still exists and has not been lifted at the statewide or county level; and

WHEREAS, the Los Angeles County Department of Public Health issued a revised health order on March 23, 2022, which states that Centers for Disease Control and Prevention (CDC) indicators and thresholds measuring community transmission of COVID-19 within the County continue to be at a Substantial level; and

WHEREAS, the health order also states that while the Omicron BA.1 variant is currently the dominant variant in the County, there is a gradual increase in the BA.2 subvariant, which is highly transmissible; and

WHEREAS, COVID-19 continues to pose a threat to the safety of individuals in

Santa Fe Springs and Los Angeles County, and the reasons for declaring a local emergency still exist.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SANTA FE SPRINGS DOES HEREBY RESOLVE AS FOLLOWS:

- 1. The City Council determines that there is need for continuing the local emergency until such time as the City Council declares the termination of the local emergency. The City Council will review the need for continuing the local emergency at least once every 60 days in accordance with Government Code section 8630(c).
- 2. The City Council reaffirms Resolution Nos. 9668 and 9669 relating to the declaration of and response to a local emergency due to the threat of COVID-19, and all parts therein.

BACKGROUND

On March 4, 2020, the Governor of California issued a proclamation declaring a state of emergency due to the threat of COVID-19. On March 13, 2020, the President of the United States issued a proclamation of national emergency, beginning March 1, 2020, due to the COVID-19 outbreak. On March 17, 2020, the City Manager, acting as the Director of Emergency Services, issued a proclamation declaring the existence of a local emergency beginning March 12, 2020, due to the threat of COVID-19. On March 18, 2020, the City Council adopted Resolution No. 9668 ratifying the proclamation, and on April 9, 2020, the City Council adopted Resolution No. 9669 relating to taking action in response to the local emergency. The City Council has continued to reaffirm the existence of a local emergency due to the threat of COVID-19.

Government Code section 8630(c) provides that the City Council shall review the need for continuing the local emergency at least once every 60 days until the City Council terminates the local emergency. The state of emergency still exists and has not been lifted at the statewide or county level. The Los Angeles County Department of Public Health issued a revised health order on March 23, 2022, which states that Centers for Disease Control and Prevention (CDC) indicators and thresholds measuring community transmission of COVID-19 within the County continue to be at a Substantial level. The health order also states that while the Omicron BA.1 variant is currently the dominant variant in the County, there is a gradual increase in the BA.2 subvariant, which is highly transmissible.

The reasons for declaring a local emergency still exist, and therefore, staff recommends that the City Council adopt the attached Resolution affirming the existence of a local emergency in accordance with Government Code section 8630(c).

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANTA FE SPRINGS AFFIRMING THE LEGALLY REQUIRED FINDINGS TO AUTHORIZE THE CONDUCT OF REMOTE TELECONFERENCE MEETINGS DURING A STATE OF EMERGENCY

WHEREAS, on March 4, 2020, pursuant to California Government Code section 8625, the Governor declared a state of emergency; and

WHEREAS, on September 17, 2021, the Governor signed AB 361, which bill went into immediate effect as urgency legislation; and

WHEREAS, AB 361 adds Subsection (e) to Section 54953 of the Government Code to authorize legislative bodies to conduct teleconference meetings without complying with the requirements set forth in Section 54953(b)(3), provided the legislative body makes specified findings and complies with certain requirements; and

WHEREAS, the County of Los Angeles Department of Public Health reports a high number of daily cases and community transmission, as well as increased transmission of COVID-19 due to the Delta variant, which is two times as contagious as earlier variants, remains predominant in Los Angeles County, and continues to lead to increased infections; and

WHEREAS, public health officials recommend social distancing as a protective measure to decrease the chance of spread of COVID-19; and

WHEREAS, at its regular meeting of November 2, 2021, the City Council adopted Resolution No. 9735 authorizing the City Council and all legislative bodies and committees of the City to meet by teleconference; and

WHEREAS, Government Code Section 54953(e)(3) requires an agency to reconsider the circumstances of the state of emergency and make certain findings every thirty days in order to continue to conduct remote teleconference meetings pursuant to Section 54953(e).

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SANTA FE SPRINGS DOES HEREBY RESOLVE that:

- 1. The City Council has reconsidered the circumstances of the state of emergency and finds that the state of emergency continues to directly impact the ability of its members to meet safely in person.
- 2. The City Council and all legislative bodies and committees of the City are authorized to meet by teleconference pursuant to, and in compliance with the requirements of, Government Code section 54953(e).

Approval of Underground Facilities License for Omega OU2, LLC

RECOMMENDATION

Approve the Underground Facilities License for Omega OU2, LLC to operate groundwater containment pipelines along various city streets.

BACKGROUND

The Omega Chemical Corporation Superfund site ("Omega Superfund site") was placed on the National Priorities List in 1999 and extends from Whittier through Santa Fe Springs and into Norwalk. The court mandated remedy requires the construction and operation of multiple groundwater extraction wells to pump contaminated groundwater to the surface, water treatment facilities to remove the contaminants, and pipelines to deliver the treated groundwater to one or more end users. It also requires the construction of new groundwater monitoring wells and the monitoring of new and existing wells. Omega OU2, LLC is the entity responsible for the installation of the extraction wells, water treatment facilities, monitoring wells, pipelines, etc.

The proposed Underground Facilities License would permit Omega OU2, LLC to operate and maintain the groundwater containment pipelines in Hawkins Street, Norwalk Boulevard, Smith Avenue, Matern Place, Geary Avenue, Arlee Avenue, Pioneer Boulevard, and/or Mersin Place. The provisions of the Underground Facilities License include the following:

- 1. The term of the license will be ten (10) years.
- 2. The annual license fee as proposed will be computed by multiplying the sum of four cents times the nominal internal diameter of the pipe expressed in inches, times the number of linear feet of the pipe within the public right-of-way. The total license fee will be \$10,200 per year.
- 3. The City reserves the right to revise the annual license fee following one year's written notice to Omega OU2, LLC.
- 4. Omega OU2, LLC is required to maintain liability insurance consistent with City requirements and name the City as an additional insured.

LEGAL REVIEW

The City Attorney's office has reviewed the Underground Facilities License.

INFRASTRUCTURE IMPACT

The underground facility license includes a provision for relocation of any the Omega OU2, LLC pipelines due to any conflict with any proposed city-owned utility or due to

City of Santa Fe Springs Underground Facilities License

WHEREAS, OMEGA OU2, LLC has requested permission from the CITY OF SANTA FE SPRINGS to install, operate and maintain various pipelines within the public right-of-way of the City of Santa Fe Springs as needed components of a groundwater containment project as part of the Omega Chemical Superfund Site, Operable Unit 2; and

WHEREAS, the Director of Public Works has recommended that the City Council of the City of Santa Fe Springs allow the operation and maintenance of said pipelines subject to the terms and conditions contained herein:

NOW, THEREFORE, the CITY OF SANTA FE SPRINGS, hereinafter referred to as "CITY" does hereby grant a license to OMEGA OU2, LLC, hereinafter referred to as "COMPANY," as follows:

CITY hereby grants to COMPANY a license for a period of 10 (ten) years ("License"), with said period commencing upon recordation of this license, to install, operate, and maintain Groundwater Containment Project pipelines in the locations designated on Exhibit "A", attached hereto, and by this reference, made a part hereof. The Initial Term may be extended by CITY for up to three (3) periods of ten (10) years each commencing upon the expiration of the Initial Term.

- 1. COMPANY shall, during the term of this License, pay to CITY, in lawful money of the United States, and in the manner provided by law, an annual License Fee ("Fee") computed by multiplying the sum of four cents (\$.04) times the nominal internal diameter of the pipe, expressed in inches, times the number of lineal feet of such pipe within the public streets, ways, alleys, or other public places within CITY. In the event that such payment is not made, the City Council of CITY may declare this License forfeited. CITY reserves the right, upon one year's written notice to the COMPANY, to revise the foregoing Fee to any fee or fee basis which is then allowable under the laws of the State of California and of the CITY. If the fee as determined by the CITY is unacceptable to COMPANY, COMPANY shall have the right, upon six months advance written notice to CITY, to terminate this License. Any such change shall be prospective in operation.
- 2. The payment of the annual fee shall be paid by the COMPANY to CITY upon recordation of this license agreement and the anniversary of this date will become the annual date when payment of the annual fee is due.
- 3. Precise location of facilities and technical specifications and requirements for all work done within any public street shall be per approved plans and to the reasonable satisfaction of the City Engineer and the Fire Chief, and in accordance with all applicable ordinances, regulations and standards of CITY. COMPANY shall provide digital copies of "As-Built" drawings of pipelines and related appurtenances to the City Engineer. Digital copies shall be in the form of .pdf and/or .dwg.
- 4. The License provided to COMPANY by this Agreement may be subject to property taxation if a possessory interest is created, and the COMPANY may be subject to the payment of property taxes levied on that interest. If the License is subject to property taxes,

COMPANY shall pay when due all real property taxes for the License. Notwithstanding the foregoing, COMPANY shall pay any personal property tax, real property tax, operational tax, or any other tax or fee which are directly attributable to the COMPANY'S exercise of the License.

- 5. COMPANY shall, during the term of this License, maintain for the benefit of CITY a policy of public liability and to confirm that is consistent with the COMPANY'S insurance program property damage insurance, in amount of not less than \$1,000,000, per occurrence and \$2,000,000 aggregate naming CITY as an additional insured, to the satisfaction of the City Attorney,. This insurance must be renewed annually.
- 6. COMPANY agrees to defend, indemnify, hold free and harmless the CITY, its elected and appointed officials, officers, agents and employees, at COMPANY'S sole expense, from and against any and all claims, demands, actions, suits or other legal proceedings brought against the CITY arising out of or related to the exercise of the License. The defense obligation provided for hereunder shall apply without any advance showing of negligence or wrongdoing by the COMPANY, its employees, and/or authorized subcontractors, but shall be required whenever any claim, action, complaint, or suit asserts as its basis the negligence, errors, omissions or misconduct of the COMPANY, its employees, and/or authorized subcontractors, and/or whenever any claim, action, complaint or suit asserts liability against the CITY, their respective elected and appointed officials, officers, agents and employees based upon the exercise of the License by the COMPANY, its employees, and/or authorized subcontractors under this Agreement, whether or not the COMPANY, its employees, and/or authorized subcontractors are specifically named or otherwise asserted to be liable. Notwithstanding the foregoing, the COMPANY shall not be liable for the defense or indemnification of the CITY for claims, actions, complaints or suits arising out of the negligence or willful misconduct of CITY.
- 7. COMPANY shall not sell, transfer, assign or lease this License to any other party without the written consent of CITY (which consent shall not be unreasonably withheld or delayed), and any such action by COMPANY without the approval of CITY shall constitute a forfeiture of this License.
- 8. COMPANY agrees to relocate said pipeline, or any portion thereof, and bear the full cost thereof, should CITY reasonably determine that relocation is needed to accommodate the installation or modification of any City-owned underground facility, or any such facility owned by another public utility or due to the change of grade, alignment or width of Hawkins Street, Norwalk Boulevard, Smith Avenue, Matern Place, Geary Avenue, Arlee Avenue, Pioneer Boulevard, and/or Mersin Place by the CITY. CITY acknowledges and agrees that the movement of the pipeline to a new location may require the approval of the United States Environmental Protection Agency. Nonetheless COMPANY will relocate the pipeline if required under this section as quickly as it can.
- 9. Should any portion of any public street subsequently be damaged by reason of facilities installed or operated under License, COMPANY shall, at COMPANY expense, repair such damage to the reasonable satisfaction of the Director of Public Works.

- 10. COMPANY agrees to replace within 72 hours of notification by the CITY any and all missing manhole covers, valve covers, pull box lids, etc.
- 11. In the event COMPANY ceases operation at the locations stated above for more than 180 consecutive days, this License shall be forfeited, and all facilities installed under this License shall be considered abandoned, unless otherwise approved by CITY, which approval shall not be unreasonably withheld or delayed. If ceased operation continues for another 185 days, for a total of 365 consecutive days of ceased operation, the pipelines shall be considered abandoned, unless otherwise approved by CITY, which approval shall not be unreasonably withheld or delayed. If no approval from CITY is sought by COMPANY by the 366th consecutive day of ceased operation, CITY will deem the License forfeited and will conduct abandonment of all pipelines in accordance with CITY specifications. Said specifications shall include that all above ground pipes, valves, etc., shall be removed, ends shall be plated after filling pipes with slurry sand, and a fee of one half (1/2) the estimated cost of removal for all pipelines owned by COMPANY shall be paid to the CITY. The COMPANY shall then have no further responsibility for the abandoned facilities, nor shall COMPANY pay any annual fees for such facilities. If these conditions are not satisfied, the proposed abandoned facilities shall be considered as being deactivated and shall remain the responsibility of the COMPANY and shall remain on their records and maps and the annual franchise fees shall be paid. In the event that such payment is not made, the City Council of the CITY may declare said License forfeited and COMPANY shall pay to the CITY all reasonable and necessary costs for removal of all pipelines and appurtenances.
- 12. This License agreement contains the entire agreement between the CITY and the COMPANY with respect to the subject matter hereof, superseding all previous communications and negotiations, and no representation, undertaking, promise or condition concerning the subject matter hereof shall be binding upon the COMPANY unless clearly expressed in this License agreement.



BACKGROUND

Water treatment is defined as any process that improves the quality of water to make it appropriate for a specific end-use. The end use may be drinking, industrial water supply, irrigation, river flow maintenance, water recreation or many other uses, including being safely returned to the environment. Water treatment removes contaminants and undesirable components, or reduces their concentration so that the water becomes fit for its desired end-use. This treatment is crucial to human health and allows humans to benefit from both drinking and irrigation use.

There are seven (7) common methods for water treatment: coagulation/flocculation; sedimentation; filtration; disinfection; sludge drying; fluoridation; and pH correction. The selection of wastewater treatment systems is contingent on a number of factors: (1)The degree to which a method is necessary to raise the waste water quality to a permissible level; (2) The control method's flexibility; (3) The process's cost; and (4) The process's environmental compatibility. The processes involved in removing the contaminants include physical processes such as settling and filtration, chemical processes such as disinfection and coagulation, and biological processes such as slow sand filtration. A combination selected from the following processes (depending on the season, contaminants, and chemicals present in the raw water) is used for municipal drinking water treatment worldwide.

In the City of Santa Fe Springs, water-pumping and treatment plants are only permitted within the M-1 (Light-Manufacturing) Zone, after a Conditional Use Permit (CUP) has first been granted. Such uses are required to obtain a CUP due to the possibility of hazardous chemicals, noise, odors, and aesthetics. It should be noted that the City's Zoning Ordinance currently allows permitted uses from less intensive zoning to locate into to higher intensive zoning. For example, permitted uses within the ML (Limited Manufacturing) Zone are permitted within the M-1 Zone. Likewise, permitted uses within the ML and M-1 Zones are permitted within the M-2 (Heavy Manufacturing) Zone. However, the same consideration is not made for conditional uses. Each zone has a separate list of conditional uses without any consideration to allow conditional uses that are listed in a less intensive zone. As proposed, the City is suggesting that water-pumping and treatment plants be considered as a conditional use within the M-2 Zone.

February 23, 2022 Planning Commission Meeting

At the February 23, 2022 Planning Commission meeting, because the proposed Zoning Text Amendment (ZTA) was legally noticed, staff recommended a continuance of the subject ZTA to the March 14, 2022 Planning Commission meeting. By a vote of 5-0, the Planning Commission moved to continue the matter which provided staff with additional time to refine the report and associated research materials, and allow the City Attorney's office sufficient time to review the materials before they were provided to the Planning Commission for consideration.

March 14, 2022 Planning Commission Meeting

At the March 14, 2022 Planning Commission meeting, the subject Zoning Text Amendment (ZTA) was presented by staff for the commissioners' consideration. After opening the public hearing, the audience had an opportunity to express their concerns towards the subject Zoning Text Amendment. After closing the public hearing, each Commissioner had an opportunity to ask questions and present their concerns regarding the proposal, in which, staff answered all questions and concerns to the best of their ability. 



There may be other conditional uses listed within the ML and M-1 Zones that could also be compatible as a conditional use in the M-2 Zone, but the subject request to specifically add water-pumping and treatment plants to the M-2 Zone was initiated by the applicant, De Maximus, Inc. As proposed, the applicant is suggesting that water-pumping and treatment plants be considered as a conditional use within the M-2 Zone. The requirement of a CUP would allow staff and the Planning Commission the opportunity to evaluate each applicant/operator to ensure that all concerns previously mentioned are adequately addressed.

As with other Zone Text Amendments, staff surveyed the surrounding area to see how other cities classify water-pumping and treatment plants. One of the nearest water treatment facilities is the WRD Albert Robles Center for Water Recycling and Environmental Learning (ARC) located in the City of Pico Rivera. In 2016, the City of Pico Rivera Planning Commission unanimously approved a CUP to allow the Water Replenishment District of Southern California to operate and maintain the ARC facility at 4320 San Gabriel River Parkway, within the IPD, Industrial Planned Development, Zone. It should be noted that surrounding uses immediately adjacent to this facility include residential to the west, the San Gabriel River to the east, and various industrial uses to the north and south. 

WHEREAS, the City of Santa Fe Springs has reviewed and considered the proposed amendment to the text of the City's Zoning Ordinance with the intention of amending Section 155.243, of Title 15, Chapter 155 of the Santa Fe Springs Municipal Code relating to water-pumping and treatment plant; and

WHEREAS, after study and deliberations by the Department of Planning and Development, the City, with the assistance from the City Attorney, has prepared for adoption these amendments to the text of the City's Zoning Ordinance; and

WHEREAS, the proposed Zoning Text Amendment is considered a project as defined by the California Environmental Quality Act (CEQA), Article 20, Section 15378(a); and

WHEREAS, the proposed project meets the criteria for a Categorical Exemption pursuant to the California Environmental Quality Act (CEQA), Section 15061(b)(3) – Activities Covered by General Rule; and

WHEREAS, on February 11, 2022, the City of Santa Fe Springs Department of Planning and Development published a legal notice in the *Whitter Daily News*, a local paper of general circulation, indicating the date and time of the public hearing, and also posted in the Santa Fe Springs City Hall window, the City's Town Center kiosk, and the City's Library; and

WHEREAS, on February 23, 2022, the City of Santa Fe Springs Planning Commission opened and continued the matter to the March 14, 2022 Planning Commission Meeting; and

WHEREAS, the City of Santa Fe Springs Planning Commission has reviewed and considered the written and oral staff report, the testimony, written comments, and other materials presented at the public hearing on March 14, 2022; and

WHEREAS, on March 14, 2022, the City of Santa Fe Springs Planning Commission conducted a duly noticed public hearing and considered public testimony concerning amendments to the text of the City's Zoning Regulations.

NOW, THEREFORE, be it RESOLVED that the PLANNING COMMISSION of the CITY OF SANTA FE SPRINGS does hereby RESOLVE, DETERMINE and ORDER AS FOLLOWS:

<u>SECTION I.</u> The Planning Commission finds that the facts in this matter are as follows:

- 1. The proposed Zoning Text Amendment is consistent with the following goals of the Santa Fe Springs General Plan.
- 2. That the Planning Commission find the pursuant to Section 15061 (b) (3) of the California Environmental Quality Act (CEQA), the proposed amendments to the text of the City's Zoning Ordinance is exempt from CEQA as a "common sense" rule.
- 3. That the Planning Commission finds the proposed amendments to the text of the City's Zoning Ordinance are consistent with the City's General Plan.
- 4. That the Planning Commission recommend that the City Council approve and adopt Ordinance No. 1122, to execute the proposed amendments to the text of the City's Zoning Ordinance.

The intent of the Zoning Text Amendment is to allow for water-pumping and treatment plants as a conditional use activity in the M-2, Heavy Manufacturing, zone.

SECTION II. ENVIRONMENTAL FINDINGS AND DETERMINATION


Pursuant to Section 15061(b)(3) (Activities Covered by General Rule) of the California Environmental Quality Act (CEQA), the Planning Commission hereby finds and determines that the project is categorically exempt, in that the proposed Zoning Text Amendment does not approve any development project. Rather, it clarifies the requirements related to the establishment of water-pumping and treatment plants. Future Conditional Use Permit applications submitted for water-pumping and treatment plants would be subject to CEQA at that time, as those actions would be classified as a project under CEQA. Therefore, the proposed zoning text amendment is not subject to CEQA under General Rule, Section 15061(b)(3) of Title 14 of the California Code of Regulations and no further environmental review is necessary.

SECTION III. PLANNING COMMISSION ACTION

The Planning Commission hereby adopts Resolution No. 208-2022 to determine that the Zoning Text Amendment is Categorically Exempt pursuant to the California Environmental Quality Act (CEQA) Section15061(b)(3), and to recommend that the City Council adopt Ordinance No.1122 to execute the proposed amendments to the text of the City's Zoning Ordinance.

ORDINANCE NO. 1122

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SANTA FE SPRINGS AMENDING SECTION 155.243 (CONDITIONAL USES) OF CHAPTER 155 (ZONING) OF TITLE 15 (LAND USAGE) OF THE SANTA FE SPRINGS MUNICIPAL CODE RELATING TO WATER-PUMPING AND TREATMENT PLANTS WITHIN THE M-2 (HEAVY MANUFACTURING) ZONE

THE CITY COUNCIL OF THE CITY OF SANTA FE SPRINGS DOES HEREBY ORDAIN AS FOLLOWS:

<u>Section 1.</u> Section 155.243 (Conditional Uses) of Chapter 155 (Zoning) of Title 15 (Land Usage) of the Santa Fe Springs Municipal Code is hereby amended to add a new subsection (J)(27) as follows:

§ 155.243 CONDITIONAL USES.

The following uses shall be permitted the M-2 Zone only after a valid conditional use permit has been first issued.

- (J) Also the following:
 - (27) Water-pumping and treatment plants.
- <u>Section 2.</u> Environmental Review. The City Council finds that Section 15061(b)(3) "Common Sense Rule" of the California Environmental Quality Act (CEQA) applies to this Ordinance. This exemption provides that CEQA applies only to projects which have the potential for causing a significant effect on the environment. Where it can be seen with certainty that there is no possibility that the activity in question will have a significant effect on the environment, the activity is not subject to CEQA. The City Council finds that it can see with certainty that the proposed Zoning Code text amendments will not have a significant effect on the environment.
- <u>Section 3.</u> Repeal of Inconsistent Sections. Any provision of the Santa Fe Springs Municipal Code or appendices thereto inconsistent with the provisions of this Ordinance, to the extent of such inconsistencies and no further, are repealed or modified to that extent necessary to affect the provisions of this Ordinance.
- <u>Section 4.</u> Severability. If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this Ordinance, or any part thereof, is held invalid or unconstitutional, such decision shall not affect the validity of the remaining sections or portions of this Ordinance or of Chapter 155, or any part thereof. The City Council hereby declares that it would have adopted each section, subsection, subdivision, paragraph, sentence, clause or phrase in this Ordinance

irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases may be declared invalid or unconstitutional.

<u>Section 5.</u> Attestation. The Mayor shall sign and the City Clerk shall attest to the adoption of this Ordinance. The City Clerk shall cause the same to be posted in at least three (3) public places in the City, such posting to be completed not later than fifteen (15) days after passage thereof. The Ordinance shall become effective 30 days from its adoption.

Request for Out-of-State Travel for an Instructor Lifeguard II to attend a Water Safety Instructor-Instructor Trainer Course in Louisville, Kentucky in June 2022

RECOMMENDATION

Staff recommends that the City Council:

 Approve out-of-state travel for the Instructor Lifeguard II to attend a Water Safety Instructor-Instructor Trainer (WSI-IT) Course in Louisville, Kentucky held on June 20, 2022 through June 24, 2022

BACKGROUND

The Water Safety Instructor (WSI) course is a training course for instructor lifeguards to teach all of the courses presented in the American Red Cross Swimming and Water Safety program. This certification is the gold standard and provides the most comprehensive training for swim instructors. The WSI certification is required for all City of Santa Fe Springs lifeguards. The Water Safety Instructor Trainer (WSIT) Course is a course to be able to certify lifeguards in WSI. By having a staff member certified in WSIT, the staff member will be able to certify the City's lifeguards in WSI, without having to bring a third-party provider to certify the lifeguards, where costs range between \$300-\$400 per attendee. Additionally, by having a WSIT on staff, the City will be able to offer WSI courses for members of the public and surrounding communities throughout the year.

The WSIT certification is good for two (2) years, and can be updated every two (2) years by teaching a WSI course within the timeframe. The last time the City had a staff member with this certification was in 2010. The WSIT courses are not offered frequently as the pre-requisites are immense. Additionally, WSIT courses are rarely offered in the area. Below are some of the requirements to be eligible as a WSIT candidate:

- Be a currently certified, active American Red Cross Water Safety Instructor in good standing.
- Hold current certification in Adult & Pediatric First Aid/CPR/AED.
- Be affiliated with a current American Red Cross Authorized Provider or Licensed Training Provider or be employed as a paid or volunteer instructor of the American Red Cross.
- Have current or prior work experience as a swim instructor.
- Three (3) years teaching experience with at least one (1) American Red Cross course per year and a minimum of eighteen (18) American Red Cross courses over the last three (3) years, having taught since March 2019.

Park Playgrounds Status Update

RECOMMENDATION

This report is for informational purposes only and does not require any action by the City Council.

BACKGROUND

Staff will provide an update on the status of the following three park playground areas: Los Nietos Park, Lakeview Park and Bradwell Parkette.

Los Nietos Park

The Los Nietos Park Playground Improvements were approved at the December 7, 2021, City Council meeting. The purchase of one Miracle Playground Equipment Set and Installation was approved. The equipment has been ordered, but due to the current supply chain, manufacturing, and labor shortage issues, the equipment will not be delivered until July 2022 at the earliest. Staff continues to request updates from the installer as the dates get near. Staff has recommended that the existing playground not be demolished and removed until the new playground has been delivered. This will allow park patrons to still utilize the existing playground until the new equipment is installed.

Lakeview Park

The swing rings at Lakeview Park were originally compromised in August 2021 due to misuse, abuse, and vandalism. In addition, the bushings were wearing out, and the top bracket was compromised, as the welds were failing. In November 2021, the slide was misused, abused, and vandalized as well. As a result of the damages to both items, the playground was deemed unsafe, and a perimeter chain link fence was installed to keep park patrons from accessing the playground equipment. replacement parts were ordered in August 2021 and November 2021, respectively. Delivery of the replacement parts was anticipated for January 2022 but were not delivered. The manufacturer notified the City that the order was pushed back to May 2022. Last week the replacement parts for the swing rings arrived, but the slide bracket still has not been delivered. Staff anticipates receiving the slide bracket in early May 2022 and making the repairs by mid-May 2022.

Bradwell Parkette

The slide at the Bradwell Parkette was vandalized and destroyed in March 2022. It appears that either a bike or skateboard rode on top of the slide and caused the slide to be crushed. The Parkette has been closed to patrons and the slide has been ordered. The manufacturer has received the order and estimates that the slide will be shipped in October 2022 at the earliest.

This repair(s) and improvement(s) to the playgrounds at Los Nietos Park, Lakeview Park, and the Bradwell Parkette will provide recreational opportunities and create a fun environment for park patrons. Due to the age of the equipment, parts are not readily available on the shelf. Furthermore, manufacturers are only making parts when ordered and lumping multiple orders together (not producing single orders), which causes long lead times for replacement parts.

RECOMMENDATION

Proclaim the week of May 1-7, 2021 as "Municipal Clerks Week"

BACKGROUND

This upcoming month of May 2022 will be the 53rd Annual Professional Municipal Clerks Week, initiated in 1969 by the International Institute of Municipal Clerks (IIMC) endorsed by all of its members throughout the United States, Canada, and 15 other countries, the week is a time of celebration and reflection on the importance of the Clerk's office. In 1984 and in 1994, Presidents Ronald Reagan and Bill Clinton, respectively, signed a Proclamation officially declaring Municipal Clerks Week the first full week of May and recognizing the essential role Municipal Clerks play in local government.

Municipal and Deputy Clerks' main function is to serve as the council's foundation. Other duties include, but are not limited to, preparing agendas, taking minutes, maintaining ordinance and resolutions files, keeping the municipality's historical records and service as the clearinghouse for information about the local government. Another important responsibility is administering part or all of the local election functions.

One of local government's oldest positions is the Municipal Clerk. Their duties have expanded over the years and, today, modern technology assist them with their increasing responsibilities. BACKGROUND

On April 10, 1872, J. Sterling Morton proposed to the Nebraska Board of Agriculture that a special day be set aside for the planting of trees, which would be called Arbor Day. Trees play an integral part of the urban landscape by providing aesthetic and environmental benefits to neighborhoods. The City of Santa Fe Springs places great value in maintaining and preserving the more than 7000 trees that make up the City's urban forest. The Arbor Day Foundation has recognized this investment and bestowed upon the City the national designation award of Tree City USA for the 36th consecutive year.

The Arbor Day Foundation is a non-profit, environmental and educational organization of nearly one million members, with a mission to inspire people to plant, nurture and celebrate the benefits of trees. The Arbor Day Foundation, in cooperation with the National Association of State Foresters, and the United States Department of Agriculture Forest Service sponsors the Tree City USA program.
