**1. CALL TO ORDER**

Mayor Rios called the meetings to order at 6:02 p.m.

**2. ROLL CALL**

Present: Councilmembers Rounds, Sarno, Trujillo, Mayor Pro Tem Moore, Mayor Rios

Also present: Thaddeus McCormack, City Manager; Steve Skolnik, City Attorney; Wayne Morrell, Director of Planning; Noe Negrete, Director of Public Works; Dino Torres, Director of Police Services; Maricela Balderas, Director of Community Services; Travis Hickey, Assistant Director of Finance; Mike Crook, Fire Chief; Anita Jimenez, City Clerk

**CITY COUNCIL**

**3. CITY MANAGER REPORT**

The City Manager reported on water conservation and the Governor's mandated reductions. The water board is looking at how this will affect cities. Santa Fe Springs has been directed to reduce water usage by 20 percent. So far, we have reduced by 8.9 percent, so more reductions are necessary. Councilmember Rounds asked if the City's Ordinance would be reviewed for necessary changes. The City Attorney stated that the last action that the Council took was to implement Phase I of the City's Water Conservation Plan, and added the Plan must be brought back to the Council in order to implement a more stringent phase. The City Manager asked the Planning Director if the Ordinance pertaining to residential landscaping would be brought back to Council. Director Wayne Morrell stated that he sent draft language to the City Attorney, but revisions were necessary. The Plan will be brought to Council soon. Councilmember Rounds stated that the City of Los Angeles gives rebates to residents who install synthetic grass and added that he has been approached by residents asking if the City plans to do the same. Director Morrell stated that the Municipal Water District has a similar rebate program. The City Manager suggested that this could be considered by the City Council. Mayor Pro Tem Moore stated that there has been discussion by other entities regarding a tiered rate structure based on usage. The City Manager stated that there is a court case pending to determine the legality of charging based on usage. The City Attorney stated that if the courts decide that it is not legal, the legislature may amend the law to address the issue. Councilmember Rounds asked if the City might be eligible for a rebate for the current project at the Clarke Estate. The City Manager stated that staff would look into this. The City Manager encouraged everyone to attend the first Mayor's Prayer Breakfast on April 16 at 6:30 a.m. at Town Center.

## **EXECUTIVE TEAM REPORTS**

16. Wayne Morrell reported on development activity at the Gateway Plaza at Telegraph and Carmenita; the CVS building will be demolished and a Panera Bread and Raising Cane restaurants are planned to be built by Jan 2016. Councilmember Sarno asked about the status of the Salt and Pepper Restaurant. Director Morrell stated that the designs should be completed next week. He added that the property owner will clean up the landscape. Mayor Pro Tem Moore asked about the status of the Express Pizza. Director Morrell stated that they have gotten a business license, but no location has been selected. Director Morrell stated that the Dickey's BBQ is in plan check.  
Noe Negrete reported that the Clarke Estate reception area 95 % complete and should be right on schedule for completion. As part of the I-5 widening, a traffic signal will be installed at Roseton and should be complete by April 24. Once the signal is operational, Orr & Day Road will be closed south of Florence Ave. A notice will be sent to residents.  
Dino Torres reported on the success of the Every 15 Minutes. Speaker Jason Barber discussed the dangers of drinking and driving to students. Local students participated in a Cesar Chavez Day of Service in Tehachapi today.  
Mike Crook reported on a residential fire last Tuesday on Harvest Ave which involved a detached garage. The homeowner was given a \$100 gift card by the SAVE program. The Fire Department will provide basic hazardous waste training for small businesses who will then be eligible for reduced CUPA fees.

Travis Hickey stated that the City is in the 2<sup>nd</sup> year of a two-year budget and Finance is planning to prepare a new five-year outlook. It is a goal of the Finance Dept. that in years that a budget is not being adopted, the five-year plan will be revised.

Maricela Balderas thanked Council for their attendance at the Easter Egg Hunt. Approximately 650 participants also attended. The Family & Human Services staff secured a donation from Melrose Baking Company to provide bread on a daily basis for the senior program.

Mayor Pro Tem Moore stated that he was very impressed by the cooperation between the City of Downey's Fire Dept. and Santa Fe Springs.

Councilmember Rounds also expressed his admiration of the cooperation between the two Fire Departments. He commended the Police Services staff for the Every 15 Minutes program and agreed that the Easter Egg Hunt was a great event for residents.

Councilmember Trujillo thanked the volunteers for their support of the City.

Mayor Rios commended Dino Torres for the Every 15 Minutes program.





Purchase of Forty (40) sets of Firefighter Turnouts, Helmets, and Related Safety Equipment for the Members of the Department of Fire-Rescue

### RECOMMENDATION

That the City Council approve the purchase of forty sets of firefighter turnouts, helmets, and related safety equipment from Municipal Emergency Services, INC. in the amount of \$114,330.11.

### BACKGROUND

Members of the Santa Fe Springs Department of Fire-Rescue utilize specialized safety equipment on a daily basis in responding to a wide variety of emergency incidents. A key component of this equipment is the firefighter turnouts and helmets. Generally, the service life for a complete set of firefighter turnouts and helmet is approximately ten years. The majority of the department's current sets are approaching the end of their useful service life. Recently, the opportunity for replacement of this equipment became available through the 2013 State Homeland Security Grant Program (SHSGP), which is 100% reimbursable to the City.

### PROPOSED EQUIPMENT

More specifically, the proposed safety equipment to be purchased from Municipal Emergency Services, INC. (MES) includes the following:

- 40 Morning Pride Turnout Jackets
- 40 Morning Pride Turnout Pants
- 40 Premium leather/fabric firefighting turnout boots
- 64 Firefighter protective hoods – NFPA 1971 Compliant
- 25 Firefighter Structure Gloves – NFPA 1971 Compliant
- 40 Honeywell EV1 Traditional Firefighting Helmets

The equipment would be customized to match the current Santa Fe Springs firefighting safety equipment specifications. Each set of turnouts is custom fitted to each member, assuring the best fit and maximum protection to our personnel.

### **BACKGROUND**

The Traffic Commission at their meeting of April 16, 2015, reviewed the attached report for the proposed parking restriction. The Commission voted 3 to 0 to recommend to the City Council for consideration and approval of the proposed "Vehicles Over 6000 Pounds" parking restriction on the east side of Pontlavoy Avenue north of Rosecrans Avenue and the provision for a tow-away zone as stated herein.

Staff recommends implementation of the parking restriction as requested by the property owner, Industrial Business Centers, plus the addition of a tow-away zone provision that will facilitate enforcement and deter the disregard of the parking restriction.

**RESOLUTION NO. 9467**

**A RESOLUTION OF THE CITY COUNCIL  
OF THE CITY OF SANTA FE SPRINGS, CALIFORNIA  
RESTRICTING PARKING AND STOPPING OF VEHICLES AND  
ESTABLISHMENT OF A TOW-AWAY ZONE ON PORTIONS OF  
PONTLAVOY AVENUE NORTH OF ROSECRANS AVENUE**

THE CITY COUNCIL OF THE CITY OF SANTA FE SPRINGS DOES HEREBY  
RESOLVE AND ORDER AS FOLLOWS:

Section 1: Pursuant to the provisions of Chapter 75, Schedule II of the City Code, the following locations are designated as places where no person shall stop, stand or park a vehicle weighing in excess of 6,000 pounds at any time and is hereby established as a tow-away zone:

East side of Pontlavoy Avenue beginning at a point 100 feet north of the centerline  
of Rosecrans Avenue to a point 200 feet north of the centerline of  
Rosecrans Avenue

When signs are posted giving notice thereof, any vehicle which is parked or left standing in violation of the provisions of this Resolution, shall be removed pursuant to the provisions of Vehicle Code Section 22651 (n).

### **TRAFFIC ENGINEER'S REPORT**

Request for Parking Restrictions on Pontlavoy Avenue north of Rosecrans Avenue

#### **RECOMMENDATION**

That the Commission recommend to the City Council that a parking restriction for vehicles weighing over 6,000 pounds be implemented along with a provision for the towing of vehicles that violate the restriction on the east side of Pontlavoy Avenue beginning at a point 100 feet north of the centerline of Rosecrans Avenue to a point 200 feet north of the centerline of Rosecrans Avenue.

#### **BACKGROUND**

Staff has received a request from the owner of the property located at 13231-13245 Rosecrans Avenue for a parking restriction on the east side of Pontlavoy Avenue between the two driveways to the complex. The tenants are experiencing problems with large trucks parking continuously adjacent to the two driveways making it difficult for their customers, employees and delivery trucks to enter or exit the businesses. Their request is for the implementation of a restriction on the east side of Pontlavoy Avenue that would prohibit vehicles over 6,000 pounds from parking on the street frontage between the two driveways.

Pontlavoy Avenue is classified as an industrial collector cul-de-sac street with a curb-to-curb width of forty-eight feet and was built in 1978. It is unstriped for one vehicle each direction plus parking is permitted on both sides of the street. Pontlavoy Avenue has a posted speed limit of thirty miles per hour and terminates about 450 feet north of Rosecrans Avenue. The area is developed and has businesses that are consistent with the M1 zoning (Light Manufacturing) and M2 (Heavy Manufacturing) zoning land uses.

Staff reviewed the existing conditions at the location and found that there were two large vehicles being parked adjacent to the two driveways of the complex. These large parked vehicles impact the ability of customers and employees exiting the parking lots to see approaching traffic as well as make it difficult for commercial vehicles to enter the parking lot to make deliveries or pick-ups.

Staff recommends that a parking restriction prohibiting the parking of vehicles weighing over 6,000 pounds be implemented on the east side of Pontlavoy Avenue beginning at a point 100 feet north of the centerline of Rosecrans Avenue to a point 200 feet north of the centerline of Rosecrans Avenue.

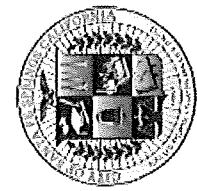
Also, in order to achieve a greater compliance of the restriction and alleviate the need for regular enforcement, a provision for the towing of vehicles that violate the restriction is recommended to be included with the parking restriction.



### Request Approval for Artwork Proposal by Artist Candace Galvan for Traffic Signal Cabinet Art Program

#### **RECOMMENDATION**

That the City Council approve the art concept by artist Candace Galvan and authorize staff to enter into an agreement with Hartzog & Crabill, Inc. as part of a Traffic Signal Cabinet Art Project.

#### **BACKGROUND**

At the Heritage Arts Advisory Committee (HAAC) meeting on April 28, 2015, the committee approved a proposal for artwork to be placed on the northwest corner of Telegraph Road and Jersey Avenue as the second traffic signal cabinet under the proposed program. The proposed art theme is a "Red Ribbon Week" which illustrates the red ribbon parade scene with the Police Services Center in the background.

The art murals are intended to enhance the aesthetics of the City and these decorative murals are a cost-benefit in reducing maintenance costs of graffiti removal which can exceed the cost of the murals over time. The murals have an anti-graffiti sealant on them which deters and prevents the application of graffiti.

Ms. Galvan has completed various art projects for the City of Bellflower, including completion of the first painted traffic signal box on the northeast corner of Telegraph and Orr & Day of the "All American City" scene set in 1957, featuring a 1957 Chevy, teens, and the Santa Fe Springs Mall. Ms. Galvan submitted three renderings depicting the selected Red Ribbon Week theme to the HAAC for their review. The HAAC selected and approved the attached rendering for City Council consideration. The Mayor may call upon Ed Ramirez, Executive Secretary for the HAAC, to answer any questions the Council may have regarding the proposed Traffic Signal Cabinet Art Project.

This project will be financed through the Art in Public Places Program Fund for a total amount of \$1,800.00.

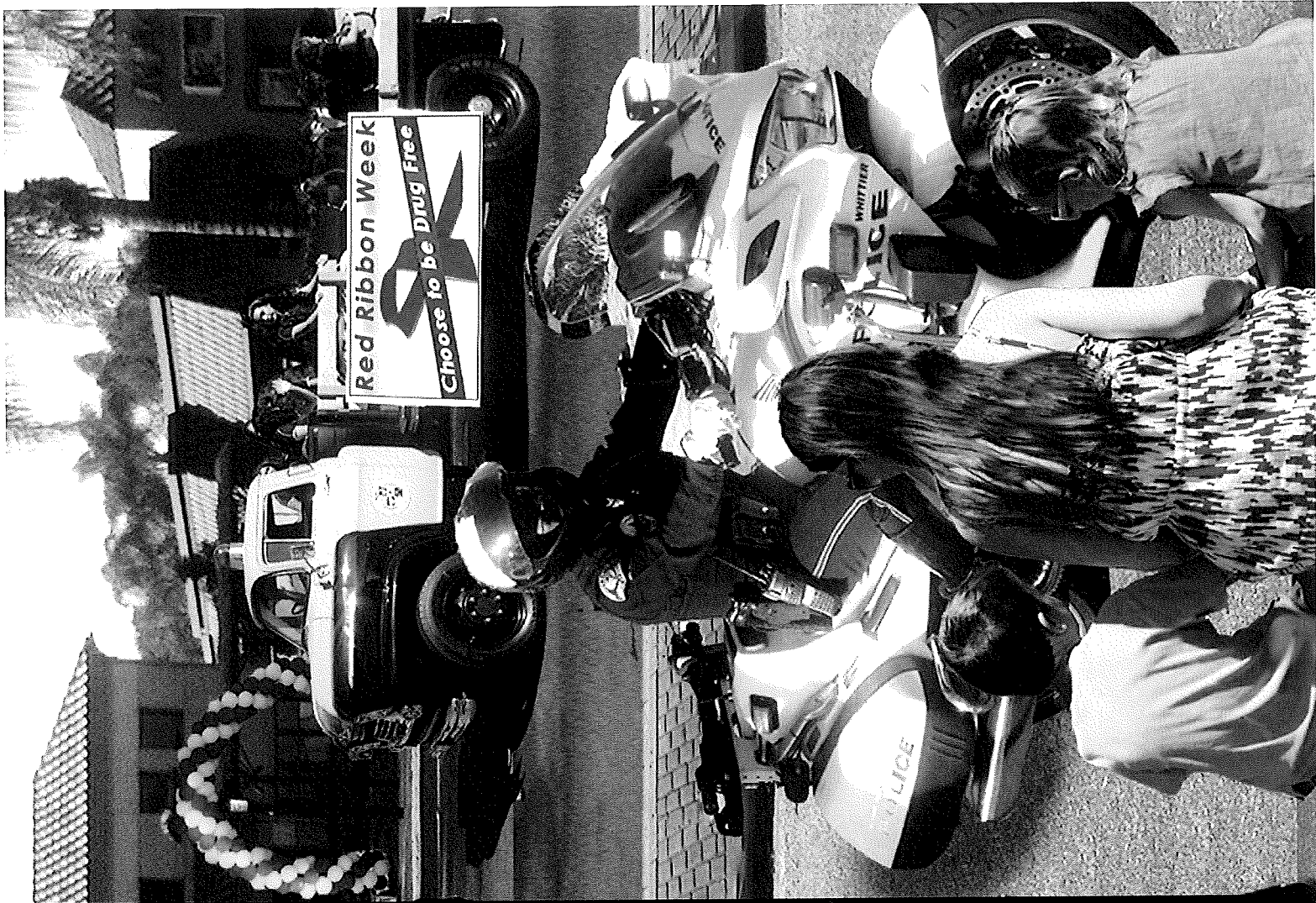

### Recognition of City's Birthday

#### **RECOMMENDATION**

That the Mayor call upon her colleagues, staff, and the community to join in a rousing rendition of Happy Birthday.

#### **BACKGROUND**

In the "old" days, before there was a city called Santa Fe Springs, there was a place called Santa Fe Springs. It was operated as a part of Los Angeles County. Less than 500 scattered residents, outnumbered by 600 oil derricks, called Santa Fe Springs home in 1949, although, the mail they received was addressed to "Four Corners." After decades of booms and busts, "Four Corners" was still just another country town.

Los Angeles began to grow with post-war industries and people moving in needed affordable housing. Rural areas like Santa Fe Springs suddenly looked attractive. The first housing tract, Imperial Crest, was built in 1949. By 1952, the population ballooned to 8,000 and homes sold for around \$13,000. Schools filled quickly, traffic was getting bad and dirt roads needed to be paved much faster than the County government was capable of handling. On the other hand, the homeowners were thrilled when a major grocery store called Market Basket opened at Telegraph and Orr and Day Roads, followed by Vincent's pharmacy, a post office, and Grants, a five and ten cent store. In addition to retail, 293 businesses had located in areas of the town that had previously been productive oilfields. The layout of the town was starting to take shape by accident, housing at the west end and industry at the east.

A homeowners association was formed in 1952. The association had the noble goals of developing community spirit through the sponsorship of parades, festivals, and recreational activities. In an early sign of organization, the association started publishing a newsletter in 1953. By 1955, a Junior Chamber of Commerce emerged and later became the Santa Fe Springs Area Industrial League. According to some reports, the idea for turning the town into a city came from the League. League member William Emmens was unhappy with his ability to get the County of Los Angeles to make a zoning change for his property. During a discussion about the issue, another League member, Claude Eib, suggested that the key to resolving the problem might be to become a city. With the newly organized residents pushing for community improvements that the County would not provide, the timing of this suggestion was perfect. The Industrial League funded a feasibility study. The study showed that there would be enough revenue raised from local taxes to transform Santa Fe Springs into a municipality, free from County rule. The process of transforming a town into a city entity is known as incorporation.

To incorporate, an election must be held and a majority of the voters must agree to the formation of a municipal government. The debate over incorporation was fierce at times. Opponents of incorporation claimed that taxes would be raised to fund the new government. When the election was held on May 15, 1957, Santa Fe Springs became a city by only a 5% margin of victory. The City was divided into voting districts, three residential and two industrial. Betty Wilson, Bill McCann and John Moreno, from the residential districts, and William Emmens and Foy Lee Peak, from the industrial areas, made up the first City Council. The first City budget, a very modest \$280,000, paid for a City Manager and safety services. City Hall was located in an old house on the northeast corner of Alburis Avenue and Telegraph Road. In 1961, the Library was the first City building constructed. City Hall followed the next year.

Tonight, we look back at the intervening 58 years and take pride that the progressive vision that the City's Founders set forth back in 1957 is alive and well in 2015. The lay of the land may have changed - the oil wells no longer outnumber the residents - but the civic values and strong bond and partnership between the business and residential communities still persists. Happy Birthday Santa Fe Springs!


**Albert L. Sharp Memorial Scholarship**
