15. Rosecrans/Marquardt Grade Separation Project-Alternatives Development Report

The City budget includes sufficient appropriations and adequate revenues are expected to be collected to meet the debt service obligations associated with the 2005 Water Revenue Bonds.

The former Community Development Commission (CDC) issued a number of tax allocation bonds before it was dissolved by State law effective February 1, 2012 and is administered by the City acting as Successor Agency under the oversight of the appointed Oversight Board. The Successor Agency no longer receives tax increment. Instead distributions from the Redevelopment Property Tax Trust Fund (RPTTF) are received based on approved obligations. It is anticipated that sufficient allocations from the RPTTF will continue to be made to the Successor Agency to meet ongoing debt service obligations.

Unspent Bond Proceeds

Under an approved Bond Expenditure Agreement, unspent bond proceeds of the former CDC in the amount of approximately \$19 million were transferred to the City in July 2014. The funds are to be spent in accordance with the original bond documents. The unspent proceeds continue to be a source of funding within the City's capital improvement program (CIP).

BACKGROUND

The Santa Fe Springs Water Utility Authority (WUA) is a City entity that has issued debt for the benefit of the Santa Fe Springs community. The following is a brief status report on the debt instruments currently outstanding that were issued through the WUA.

Water Revenue Bonds, 2013

Financing proceeds available for appropriation at 11/30/15 Outstanding principal at 11/30/15

In May 2013 the Water Utility Authority issued the 2013 Water Revenue Bonds in the amount of \$6,890,000. The bonds refunded the existing 2003 Water Revenue Bonds (issued through the Public Financing Authority) and provided additional funds for water improvement projects in the amount of \$2,134,339. The funds were restricted for use on water system improvements. In August 2013 the Water Utility Authority Board appropriated the proceeds for the Equipping Water Well No. 12 Project and all proceeds were since used on this project.

The City budget includes sufficient appropriations and adequate revenues are expected to be collected to meet the debt service obligations associated with the 2013 Water Revenue Bonds.

The WUA was formed in June of 2009. Water revenue bonds issued prior to this date were issued through the City of Santa Fe Springs Public Financing Authority.



BACKGROUND

The Water Quality Protection Plant (WQPP) began operations in December 2004, the facilities are owned by Central Basin Municipal Water District (Central Basin) and operated under contract by the City of Whittier. The purpose of the WQPP is to safeguard the groundwater in the Central Basin from contaminants migrating from the Upper San Gabriel Basin by acting as a second line of defense to the Whittier Narrows Operational Unit (WNOU). The WQPP is governed by an annual Memorandum of Understanding (MOU) with the following three Municipalities involved, the City of Pico Rivera, the City of Whittier, and the City of Santa Fe Springs. The overall management of the WQPP is performed by the Central Basin Municipal Water District (Central Basin).


The WQPP consists of two wells that can produce on the average 2,000-3,000 gallons per minute. The original plant design pumps water into a set of primary pressure vessels with Granular Activated Carbon (GAC) as the media. The GAC removes the Volatile Organic Compounds (VOCs) from the water meeting Public Health requirements. The plant was designed with redundant pressure vessels to ensure that the VOCs were being removed. The water is then treated with Sodium Hypochlorite (liquid Chlorine) for disinfectant purposes. The finished water then leaves the plant and is stored in the City of Whittier's 600,000 gallon clear well. WQPP water is blended with all water produced by the City of Whittier and then pumped up to the Whittier hills storage facilities for delivery. The winter blend is estimated at 20% WQPP water to 80% City of Whittier water, while the summer blend is estimated at 12.5% WQPP water to 87.5% City of Whittier water. The water is then distributed throughout the Whittier water system. The City of Santa Fe Springs receives water from the City of Whittier through the Whittier Connection at Chetle Avenue and Rivera Road. On an annual basis, the City receives 1,800 - 2,000 acre feet per year of water from the Whittier Connection.

STATUS

Currently the Memorandum of Understanding (MOU) has not been agreed upon by the City of Whittier and Central Basin. The current MOU expired in December of 2015 with all parties agreeing to maintain a status quo until the MOU can be brought to the Central Basin Board of Directors for signature. The discrepancy with the MOU is a retroactive inflationary recovery cost due to the City of Whittier for operating and maintain the WQPP. A future meeting will be scheduled between

all parties to reach an agreement. When all parties reach an agreement the extension to the agreement will be brought forward for Council consideration at a future meeting.

FISCAL IMPACT

A minimum of nineteen hundred acre feet (1,900 ac-ft.) of potable water will be extracted as ground water consumption at an amount of five hundred thirty three dollars (\$533) per metered acre foot as compared to purchasing surface water from the Metropolitan Water District (MWD) at a rate of one thousand thirty-two dollars (\$1,032) per acre foot.

INFRASTRUCTURE STATEMENT

A fully functioning WQPP provides a source of potable drinking water within Zone 1 and enhances the reliability of the system.

BACKGROUND

The City participates in the Los Angeles Urban County Community Development Block Grant (CDBG) program, a Department of Housing & Urban Development (HUD) entitlement program administered by the LACDC. Although the funds are an "entitlement," every year, the City must make specific application to the LACDC defining the projects to be funded. The application requires public participation subject to proper notification. Accordingly, notices were posted from January 7, 2016 to January 28, 2016 at City Hall, Town Center Hall, and the City Library informing interested persons of this Public Hearing.

The City's FY 2016-17 CDBG allocation is estimated to be \$111,000. Staff proposes allocation of these funds to the following projects.

Program	<u>Funds</u>
Teen Program	\$16,000
Fire Command Vehicle	\$95,000

Please note that the allocation to the Fire Command Vehicle is to purchase the vehicle only. An additional \$30,000 will be needed at future date to fund the vehicle-specific equipment. The City has a balance of \$105,000 in unused CDBG dollars that is currently unavailable for allocation, pending an audit. It is anticipated that after the audit is completed, the City will be able to use fund the \$30,000 from those funds. Please note that the Current Fire Command Vehicle, for which the new purchase will replace, has had electronic problems with some of the communications equipment. The plan would be to redeploy the current vehicle for use by the reserve Battalion Chief, as well as for potential use on strike teams

BACKGROUND

The City of Santa Fe Springs is currently operating in FY 2015-16 and is beginning the public process of developing the FY 2016-17 and FY 2017-18 Budgets. As has been our past practice, Staff is asking the City Council to outline budget priorities for the upcoming two-year budget cycle. Accordingly, the Council is being asked to complete the attached "Council Budget Priority Survey," the results of which will be compiled and reported back to the Council as part of the kick-off of the budget preparation process. Please complete the survey and return it to the City Clerk or City Manager at your earliest convenience.

The City's budget is a reflection of City policies, goals, and priorities. The budget process assigns resources to the goals, objectives, and community priorities set by the City Council. Over the past few years, we have worked to implement significant reductions. Previous goal and priority setting actions taken by the Council over the last five years have allowed the City to effectively manage and balance its budget during some very difficult times, by focusing the City's diminished resources on identified, essential services.

Just as goals and priorities proved important in guiding the City through the budget reductions of the past few years, I believe that the establishment of some key fiscal policies will serve the City well over the long term as our fiscal health has stabilized. Therefore, in addition to the attached Budget Priority Survey, I am asking that the Council consider identifying the below policy areas for incorporation into the development of this coming year's budget:

- 1. Continuing to work towards building up the General Fund reserves consistent with the Reserve Policy adopted last year, so as to buffer against the inevitable budget challenges that will occur when (not if) the economy goes into recession;
- 2. Developing long-term strategies to reduce unfunded liabilities, such as future retirement costs;
- 3. Recognizing the dramatic increases to PERS (retirement) costs now and on into the future, and endeavoring to control labor costs through prudent management of employee benefits and careful consideration of actions that might add to the City's already high PERS obligations; and,

PUBLIC HEARING/ORDINANCE FOR PASSAGE

Ordinance No. 1068: An Ordinance of the City Council of the City of Santa Fe Springs clarifying and imposing an express ban on marijuana cultivation/propagation, product labeling, storing, processing, transporting, delivery, sales/barters, dispensaries and cooperatives and testing laboratories in the City.

RECOMMENDATION

That the City Council waive further reading and adopt Ordinance No. 1068, an Ordinance of the City Council of the City of Santa Fe Springs clarifying and imposing an express ban on marijuana cultivation/propagation, product labeling, storing, processing, transporting, delivery, sales/barters, dispensaries and cooperatives and testing laboratories in the City.

BACKGROUND

Ordinance No. 1068 was introduced and passed its first reading at the January 14, 2016, City Council meeting. Below is the substance of the agenda report for the proposed ordinance as it appeared at that meeting.

At a public Hearing on December 14, 2015, the Planning Commission via Resolution No. 52-2015, recommended that the City Council adopt Ordinance No. 1068, clarifying and imposing an express ban on marijuana cultivation/propagation, product labeling, storing, processing, transporting, delivery, sales/barters, dispensaries and cooperatives and testing laboratories in the City of Santa Fe Springs.

This Code amendment is recommended based on recently adopted State legislation relating to the regulation of medical marijuana. On October 10, 2015, Governor Edmond G. Brown signed into law the Medical Marijuana Regulation and Safety Act ("MMRSA"), enacted through a combination of regulations contained in AB 266, AB 243 and SB 643. The MMRSA in part: (a) creates a dual licensing structure requiring all commercial cannabis operations to have both a state and a local license before operating, (b) establishes health and safety standards with required mandatory testing and labeling of edible medical cannabis products, (c) regulates physicians recommending medical cannabis products, (d) expressly recognizes local government authority to regulate, license, levy taxes and fees and/or ban commercial and noncommercial cannabis operations, (e) phases out marijuana collectives and cooperatives, (f) prevents illegal water diversion and establishes pesticide controls, and (g) requires a local jurisdiction to affirmatively prohibit unwanted cannabis activities or land uses, including banning cannabis cultivation by having an ordinance in effect on or before March 1, 2016 or by making a determination that its zoning code is "permissive" and therefore "any use not enumerated in the code is presumptively prohibited" as stipulated by the court. [City of Corona v. Naulis (2008) 166 Cal. App 4th 418, 425 and cited in County of Sonoma v. Superior Court (2010) 190 Cal.App.4th 1312,FN.3]

Prior to the adoption of the MMRSA, in 1996, the voters of the State of California approved Proposition 215 (codified as Health and Safety Code Section 11362.5, et. seq. and entitled "The Compassionate Use Act of 1996" or "CUA".) The intent of Proposition 215 was to provide legal protections to seriously ill persons, who have their doctor's recommendation to use marijuana for medical purposes, otherwise known as "qualified patients." The CUA also provides protections to the physicians and primary caregivers who assist these "qualified patients." The CUA enabled those who are in need of medical marijuana for medical purposes to obtain and use it under limited, specified circumstances. The CUA provides a criminal defense to the cultivation, possession and use of marijuana for medical purposes. The CUA does not address land use impacts caused by the cultivation of marijuana.

Neither the CUA, nor MMRSA, nor any other State Law, including the California Constitution, creates a right to cultivate marijuana or impose an affirmative duty or mandate upon local governments, such as the City, to allow, authorize or sanction those cultivating marijuana plants within its jurisdiction. Furthermore, nothing in the California Constitution nor State Law preempts the City's exercise of its traditional police powers in enacting land use and zoning regulations, as well as legislation for preservation of public health, safety and welfare, such as this zoning ordinance prohibiting the cultivation of marijuana.

Pursuant to the City's police powers as authorized in Article 11, Section 7 of the California Constitution, and as implemented in the Santa Fe Springs Municipal Code, the City has the power to regulate permissible land uses throughout the City and to enact regulations for the preservation of public health, safety and welfare of its residents and community. Additionally, per California Government Code Section 38771, the City also has the power through the City Council to declare actions, land uses and activities that constitute a public nuisance.

Pursuant to said police powers, Ordinance 1068 is proposed to regulate, through land use controls, marijuana related activities in a manner that protects the public health, safety and welfare of the Santa Fe Springs community, without violating the CUA or Health and Safety Code Sections 11362.7 et seq. entitled "The Medical Marijuana Program Act" (MMPA), and to prevent adverse impacts that such activities and land uses may have on nearby properties and residents, without interfering with the rights of qualified patients and their primary caregivers to possess medical marijuana pursuant to State law.

It has been reported that the cultivation of marijuana in other California cities has resulted in calls for service to the police department, including calls for robberies thefts, and physical assaults from marijuana that is grown outdoors; Marijuana growth poses significant safety risks for surrounding neighbors, including but not limits to, risks of violent confrontation in connection with attempts to steal marijuana, risk of fire from improperly wired electrical lights within structures growing marijuana, risk of guard dogs and security measures associated with structures and properties growing marijuana.

Furthermore, the United States Environmental Protection Agency has not established appropriate pesticide tolerances for, or permitted the registration and lawful use of, pesticides on cannabis crops intended for human consumption under the Federal Insecticide, Fungicide, and Rodenticide Act (7 U.S.C. 136, et seq.). The use of pesticides is therefore inadequately regulated and cannabis cultivated in California can and often does contain pesticide residues. These substances can run off of outdoor cultivation sites onto neighboring properties and/or leach into the groundwater.

Accordingly, the commercial and non-commercial cultivation of marijuana, whether for medical purposes or otherwise, significantly impacts, or has the potential to significantly impact, the residents of the City. These potential impacts include improper and dangerous alterations and/or use of buildings and outdoor areas in which cultivation may occur with compromised electrical connections, fire safety problems, inadequate ventilation, structural modifications, over use of water, increased nuisance impacts on neighboring properties from noxious odors originating from the plants, increased occurrences of theft crimes and a general increase in the instances and intensity of crime within the City.

In addition, it should be noted that Marijuana is an illegal substance under the Federal Controlled Substances Act, 21 U.S.C. 801, *et seq.* and is classified as a "Schedule I Drug", which is defined as a drug or other substance that has a high potential for abuse. Furthermore, the Federal Controlled Substances Act makes it unlawful for any person to cultivate, manufacture, distribute or dispense, or possess with intent to manufacture, distribute or dispense marijuana. The Controlled Substances Act contains no statutory exemption for the possession of marijuana for medical purposes. The City has no desire to interfere with or defy federal law.

In summary, the City has a compelling interest in protecting the public health, safety and welfare of its residents and businesses, and in preserving the peace and quiet of its neighborhoods. The public health, safety and general welfare of the City and its residents, necessitates and requires the adoption of this zoning ordinance, prohibiting the cultivation and distribution of marijuana plants and other cannabis products, in order to:

- (a) Protect and safeguard against the detrimental secondary negative effects and adverse impacts of cultivating and distributing marijuana;
- (b) Preserve and safeguard the minors, children and students in the community from the deleterious impacts of marijuana cultivation and distribution
- (c) Preserve the City's law enforcement services, in that monitoring and addressing the negative secondary effects and adverse impacts will likely burden the City's law enforcement resources with continuing and expanding marijuana cultivation.

Ordinance No. 1068 would clarify and impose an express ban on marijuana cultivation/propagation, product labeling, storing, processing, transporting, delivery, sales/barters, dispensaries and cooperatives and testing laboratories in the City. Through the City's police powers, as authorized by the California Constitution, the City

has the power to regulate permissible land uses and to enact regulations for the preservation of public health, safety and welfare of its residents and community. California Government Code also gives the City the power through the City Council to declare actions, land uses and activities that constitute a public nuisance. A recent Court of Appeals decision upheld the legal position that Cities have the right to use their police powers to totally ban the cultivation of marijuana within their jurisdictional boundaries. To preserve this ability, however, cities must have an ordinance in place regulating or prohibiting marijuana cultivation by March 1, 2016, or lose the authority to regulate or ban cultivation within their limits.

LEGAL NOTICE OF PUBLIC HEARING

This matter was set for Public Hearing in accordance with the requirements of Section 65090 and 65091 of the State Planning, Zoning and Development Laws and the requirements of Sections 155.860 through 155.864 of the City's Municipal Code. Legal notice of the Public Hearing was posted in Santa Fe Springs City Hall, the City Library and Town Center on December 3, 2015 and December 31, 2015, and published in a newspaper of general circulation (Whittier Daily News) on December 3, 2015 and January 1, 2016, as required by the State Zoning and Development Laws and by the City's Zoning Regulations.

FISCAL IMPACT:

Any impacts associated with the enforcement of this ordinance will be absorbed into the Whittier's Police Department operating budget.

ORDINANCE NO. 1068

AN ORDINANCE OF THE CITY OF SANTA FE SPRINGS ADDING CHAPTER 156 TO TITLE 15 (ZONING) OF THE SANTA FE SPRINGS CITY CODE CLARIFYING AND IMPOSING AN EXPRESS BAN ON MARIJUANA CULTIVATION/PROPAGATION, PRODUCT LABELING, STORING,, PROCESSING, TRANSPORTING, DELIVERY, SALES/BARTERS, DISPENSARIES AND COOPERATIVES AND TESTING LABORATORIES IN THE CITY

THE CITY COUNCIL OF THE CITY OF SANTA FE SPRINGS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. The City Council hereby finds and declares:

- A. That the commercial and non-commercial cultivation of marijuana, whether for medical purposes or otherwise, significantly impacts, or has the potential to significantly impact, the residents of the City of Santa Fe Springs (the "City"). These potential impacts include improper and dangerous alterations and/or use of buildings and outdoor areas in which cultivation may occur with compromised electrical connections, fire safety problems, inadequate ventilation, structural modifications, over use of water, increased nuisance impacts on neighboring properties from noxious odors originating from the plants, increased occurrences of theft crimes and a general increase in the instances and intensity of crime within the City.
- B. That marijuana is an illegal substance under the Federal Controlled Substances Act, 21 U.S.C. 801, *et seq.* and is classified as a "Schedule I Drug", which is defined as a drug or other substance that has a high potential for abuse. Furthermore, the Federal Controlled Substances Act makes it unlawful for any person to cultivate, manufacture, distribute or dispense, or possess with intent to manufacture, distribute or dispense marijuana. The Controlled Substances Act contains no statutory exemption for the possession of marijuana for medical purposes. The City has no desire to interfere with or defy federal law.
- C. That the voters of the State of California, in 1996, approved Proposition 215 (codified as Health and Safety Code Section 11362.5, et. seq. and entitled as "The Compassionate Use Act of 1996" or "CUA".) The intent of Proposition 215 was to provide legal protections to seriously ill persons, who have their doctor's recommendation to use marijuana for medical purposes, otherwise known as "qualified patients." The CUA also provides protections to the physicians and primary caregivers who assist these "qualified patients." The CUA enabled those who are in need of medical marijuana for medical purposes to obtain and use it under limited, specified circumstances. The CUA provides a criminal defense to the cultivation, possession and use of marijuana for medical purposes. The CUA does not address land use impacts that are caused by the cultivation of marijuana. This ordinance addresses those impacts by banning cultivation and distribution of both commercial and non-commercial operations.
- D. That on January 1, 2004, the legislature enacted SB 420 (codified as Health and Safety Code Sections 11362.7 et. seq. and entitled as "The Medical Marijuana Program Act" or "MMPA".) The MMPA was adopted to clarify the scope of the CUA and to allow cities and counties to adopt and enforce rules and regulations consistent with the MMPA and the CUA. The MMPA requires the California Department of Public Health (CDPH) to create the Medical Marijuana Program ("MMP").

The State MMP is responsible for developing and maintaining an online registry and verification system for Medical Marijuana Identification Cards or "MMICs." MMICs are available to qualified patients and their primary caregivers. The intent of SB 420 is to help law enforcement and qualified patients by creating a form of identification for qualified patients that is official and uniform throughout the State. The online registry does allow law enforcement to verify that a MMIC is valid.

- E. That the CUA is limited in scope, in that it only provides a defense from criminal prosecution for possession and cultivation of marijuana to qualified patients and their primary caregivers. The scope of the MMPA is also limited in that it establishes a statewide identification program and affords qualified patients, persons with identification cards and their primary caregivers, an affirmative defense to certain enumerated criminal sanctions that would otherwise apply to transporting, processing, administering or distributing marijuana, but not cultivation.
- F. That the intent of this ordinance is to utilize the City's inherent police power to regulate through land use controls marijuana related activities in a manner that protects the public health, safety and welfare of the Santa Fe Springs community, without violating the CUA or MMPA, and to prevent adverse impacts that such activities and land uses may have on nearby properties and residents, without interfering with the rights of qualified patients and their primary caregivers to possess medical marijuana pursuant to state law.
- G. That the implementation of CUA and MMPA does not appear to have facilitated the stated goals of providing access to marijuana for patients in medical need of marijuana, but has instead facilitated a predominant use of marijuana for recreational and not for medicinal purposes. The California Police Chiefs Association stated in a 2014 letter to State Senator Lon Correa: "Among the most troublesome issues with Proposition 215 includes the ability of virtually anyone to obtain a medical marijuana recommendation from a compliant doctor, unreliable quality control for consumers with respect to potency and the presence of carcinogenetic pesticides or other contaminants; as well as retail outlets that often become magnets for criminal activity." Such Association also stated earlier: "The vast majority of those using crude marijuana as medicine are young and are using the substance to be under the influence of THC [tetrahydrocannabinol] and have no critical medical condition."
- H. That on August 25, 2008, Edmond G. Brown, then the California Attorney General, issued the "Guidelines for the Security and Non-Diversion of Marijuana Grown for Medical Use" ("Guidelines"), which sets regulations intended to ensure the security and non-diversion of marijuana grown for medical use by qualified patients. Health and Safety Code 11362.81(d) authorizes the Attorney General to "develop and adopt appropriate guidelines to ensure the security and non-diversion of marijuana grown for medical use by patients qualified under" the CUA. Nothing in the Guidelines imposes an affirmative mandate or duty upon local governments, such as the City, to allow, sanction or permit the cultivation of marijuana plants within their jurisdictional limits.
- I. That on October 10, 2015, Edmond G. Brown, the Governor of California signed into law the Medical Marijuana Regulation and Safety Act ("MMRSA"), enacted through a combination of regulations contained in AB 266, AB 243 and SB 643. The MMRSA in part: (a) creates a dual licensing structure requiring all commercial cannabis operations to have both a state and a local license before operating, (b) establishes health and safety standards with required mandatory testing and labeling of edible medical cannabis products, (c) regulates physicians recommending medical cannabis products, (d) expressly recognizes local government authority to regulate, license, levy taxes and fees and/or ban commercial and non-commercial cannabis operations, (e) phases out marijuana collectives and cooperatives, (f) prevents illegal water diversion and

establishes pesticide controls, and (g) requires a local jurisdiction to affirmatively prohibit unwanted cannabis activities or land uses, including banning cannabis cultivation by having an ordinance in effect on or before March 1, 2016 or by making a determination that its zoning code is "permissive" and therefore "any use not enumerated in the code is presumptively prohibited" as stipulated by the court. - J. That neither the CUA, nor the MMPA, nor MMRSA nor the California Constitution creates a right to cultivate marijuana or impose an affirmative duty or mandate upon local governments, such as the City, to allow, authorize or sanction those cultivating marijuana plants within its jurisdiction.
- K. That neither the CUA nor the MMPA, nor MMRSA nor the California Constitution preempts the City's exercise of its traditional police powers in enacting land use and zoning regulations, as well as legislation for preservation of public health, safety and welfare, such as this zoning ordinance prohibiting the cultivation of marijuana.
- L. That neither the CUA nor MMPA nor MMRSA abrogates the City's powers to regulate for public health, safety and welfare. Health and Safety Code 11362.5(b)(2) provides that the Act does not supersede any legislation intended to prohibit conduct that endangers others. In addition, Health and Safety Code 11352.83 authorizes cities and counties to adopt and enforce rules and regulations consistent with the MMPA and MMRSA.
- M. That pursuant to the City's police powers as authorized in Article 11, Section 7 of the California Constitution, and as implemented in the Santa Fe Springs Municipal Code, the City has the power to regulate permissible land uses throughout the City and to enact regulations for the preservation of public health, safety and welfare of its residents and community. And, pursuant to California Government Code Section 38771, the City also has the power through the City Council to declare actions, land uses and activities that constitute a public nuisance.
- N. That California cities that have permitted the cultivation of marijuana have found that this activity causes negative and harmful secondary effects, such as an increase in crime, including robberies, burglaries, and sales of illegal drugs in the areas immediately surrounding properties that grow marijuana plants, noxious odors and an increase in the incidences of driving while under the influence of marijuana.
- O. That the City has a compelling interest in protecting the public health, safety and welfare or its residents and businesses, and in preserving the peace and quiet of its neighborhoods. That the public health, safety and general welfare of the City and its residents necessitates and requires the adoption of this zoning ordinance, prohibiting the cultivation and distribution of marijuana plants and other cannabis products, in order to:
- (a) Protect and safeguard against the detrimental secondary negative effects and adverse impacts of cultivating and distributing marijuana;
- (b) Preserve and safeguard the minors, children and students in the community from the deleterious impacts of marijuana cultivation and distribution
- (c) Preserve the City's law enforcement services, in that monitoring and addressing the negative secondary effects and adverse impacts will likely burden the City's law enforcement resources with continuing and expanding marijuana cultivation.
- P. That the City Council further finds that due to potential negative secondary effects and adverse impacts of marijuana plant cultivation on surrounding properties, these activities will negatively impact the City.
- Q. That State and Federal courts have recognized the aforementioned negative and harmful secondary effects.

R. That the City zoning regulations are consistent with the Santa Fe Springs General Plan in that the General Plan, its goals, objectives and policies do not permit or contemplate the establishment or exercise of marijuana cultivation activities either externally or internally within a structure on any property within the City.

- S. That the City Council takes legislative notice of all of the studies, statements and legal decisions set forth above and including but not limited to the following:
- 1) Browne v. County of Tehama (213 Cal App. 4th 704). This California Court of Appeal found that the CUA does not confer the right to cultivate marijuana.
- 2) City of Riverside v. Inland Empire Patients Wellness Center, Inc. (56 Cal 4th 729) This decision upheld that "local authority to regulate land use for the public welfare is an inherent preexisting power recognized by the California Constitution" and that the CUA and MMPA do not expressly or impliedly restrict the authority of local jurisdictions to decide whether local land use controls can be used to regulate medical marijuana. (May 6, 2013 State Supreme Court)
- 3) Moral v. City of Live Oak (221 Cal. App.4th 975) This decision by the Court of Appeals (November 26, 2013) upheld the legal position that the CUA and MMPA do not preempt the City's ability to use its police powers to totally ban the cultivation of marijuana within its jurisdictional boundaries. The Supreme Court on March 26, 2014 refused to hear an appeal of this decision and denied a request to depublish the finding, letting it stand.
- T. That justification for banning all cultivation of marijuana plants pursuant to the City's police powers includes but is not limited to: (1) an increased risk to public safety based on the value of the marijuana plants and the accompanying threat of robbery theft and the attendant violence and injury; (2) the noxious odors emanating from mature plants can interfere with the enjoyment and use of neighboring properties by their occupants; and (3) the potential for theft and use by school-age children when marijuana is cultivated in a visible area, especially when in proximity to residential areas, schools, parks and churches.

SECTION 2. The following new Chapter 156 is hereby added to Title 15 (ZONING) of the Santa Fe Springs City Code:

MARIJUANA RELATED ACTIVITIES

156.01 PURPOSE

It is the purpose and intent of this Chapter to utilize the City's inherent police power to regulate through land use controls, marijuana related activities in a manner that protects the public health, safety and welfare of the Santa Fe Springs community, without violating CUA and MMPA, and to prevent adverse impacts that such activities and land uses may have on nearby properties and residents, without interfering with the rights of qualified patients and their primary caregivers to possess medical marijuana pursuant to State law.

156.02 DEFINITIONS

In addition to any other definitions contained within the City's Municipal Code, the following words and phrases shall, for the purpose of this chapter, be defined as follows unless it is clearly apparent from the context that another meaning is intended. Should any of the definitions be in conflict with any current provisions of the City's Municipal Code, these definitions shall prevail.

"Distributor" means a person engaged in the purchasing of marijuana from a cultivator,

or marijuana products from a manufacturer, for sale to a dispensary, cooperative or collective

"Marijuana" means any or all parts of the plant Cannabis sativa Linnaeus, Cannabis indica, or Cannabis ruderalis, whether growing or not; the seeds thereof; the resin or separated resin, whether crude or purified, extracted from any part of the plant; and every compound, manufacture, salt, derivative, mixture, or preparation of the plant, its seeds or resin, including marijuana infused in foodstuff, or any other ingestible or consumable product containing marijuana. "Marijuana" shall also include "medical marijuana" as that term is used in the "Guidelines for the Security and Non-Diversion of Marijuana Grown for Medical Use," issued by the Office of the Attorney General for the State of California (the "Guidelines), as such Guidelines may be amended from time-to-time, or subject to the provisions of the California Compassion Use Act of 1996, or the California Medical Marijuana Program Act, as either may be amended from time-to-time.

"Marijuana cultivation" means the growing, planting, harvesting, drying, curing, grading, trimming, or processing of marijuana.

"Marijuana processing" means any method used to prepare marijuana or its byproducts for commercial retail and/or wholesale purposes, including but not limited to drying, cleaning, curing, packaging, and extraction of active ingredients to create marijuana related products and/or concentrates.

"Marijuana delivery" means the transfer of marijuana or its byproducts to or from a dispensary, collective, cooperative, primary caregiver, qualified patient or testing laboratory. "Marijuana delivery" also includes the use by any aforesaid transferor or transferee of any technology platform that enables any such transfer.

"Marijuana dispensaries" means any business, office, store, facility, location, retail storefront or wholesale component of any establishment, cooperative or collective that delivers, dispenses, distributes, exchanges, transmits, transports, sells or provides marijuana to any person for any reason, including members of any medical marijuana cooperative or collective.

"Medical marijuana cooperative" or "collective" means any group that is cooperatively or collectively cultivating and/or distributing marijuana for medical purposes that is organized in the manner set forth in the Guidelines

"Marijuana testing laboratory" means a facility, entity, or site that offers or performs tests of marijuana or marijuana products that is both: (a) accredited by an accrediting body that is independent from all other persons involved in the medical marijuana industry in the state; and (b) registered with the State Department of Public Health.

"Marijuana transporting" means the transfer of marijuana or marijuana products from one location to any other location.

"Manufacturer" means a person who conducts the production, preparation, propagation, or compounding of marijuana, or marijuana byproducts either directly or by extraction methods, or independently by means of chemical synthesis or by a combination of extraction and chemical synthesis, or that packages or repackages marijuana or marijuana products or labels or relabels its container.

"Transporter" means a person who transports or delivers marijuana or marijuana byproducts.

156.03 Prohibited Activities.

Marijuana cultivation/propagation, marijuana processing, marijuana testing laboratory, marijuana product labeling, marijuana storing, marijuana transporting, marijuana delivery, marijuana dispensaries, marijuana sales/barters and marijuana cooperatives or collectives shall be prohibited activities in the City, except where the City is preempted by federal or state law from enacting a prohibition on any such activity. Except in the circumstance of such preemption, if any, no use permit, variance, building permit, or any other entitlement, license, or permit, whether ministerial or discretionary, shall be approved or issued for any of the aforesaid prohibited activities anywhere in the City, and no person shall otherwise establish or conduct any such activity in the City. It shall be unlawful for any person or entity to establish, own, operate or manage, or participate as an employee, manufacturer, transporter, distributor, contractor, landlord, property owner, agent, or volunteer, in any of the aforesaid prohibited activities anywhere in the City for any reason including both commercial or non-commercial purposes.

156.04 Public Nuisance.

Any use or condition caused, or permitted to exist, in violation of any provision of this Chapter shall be, and hereby is declared to be, a public nuisance and may be summarily abated by the City pursuant to Code of Civil Procedure Section 731 or any other remedy available to the City.

156.05 Civil Penalties.

In addition to any other enforcement permitted in the City of Santa Fe Springs Municipal Code, the City Attorney and/or City Prosecutor may bring a civil action for injunctive relief and civil penalties against any person or entity that violates this Chapter. In any civil action brought pursuant to this Chapter, a court of competent jurisdiction may award reasonable attorney's fees and costs to the prevailing party.

156.06 Applicability.

In the event that any activity which is prohibited by this Chapter shall be determined to have occurred legally prior to the effective date of this Chapter, no such activity shall have any nonconforming rights as may otherwise be provided by this Code. Nothing in this Chapter is intended, nor shall it be construed to burden any defense to criminal prosecution under the Compassionate Use Act in 1996 pursuant to Proposition 215 and codified as the State of California Health and Safety Code section 11362.5.

SECTION 3. Nothing in this ordinance shall be interpreted to mean that the City's permissive zoning scheme allows any other use not specifically listed therein.

SECTION 4. This ordinance is exempt from CEQA pursuant to CEQA Guidelines Section 15305, minor alterations in land use limitations in areas with an average slope of less than 20% that do not result in any changes in land use or density and Section 15061(b)(3) which is the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment and CEQA does not apply where it can be seen with certainty that there is no possibility that the activity may have a significant effect on the environment. The City's permissive zoning provisions already prohibit all uses that are being expressly prohibited by this ordinance. Therefore, this

ordinance has no impact on the physical environment as it will not result in any changes.

SECTION 5. If any section, subsection, subdivision, sentence, clause, phrase or portion of this ordinance, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance. The City Council hereby declares that it would have adopted this ordinance and each section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

SECTION 6. To the extent the provisions of the Santa Fe Springs Municipal Code as amended by this ordinance are substantially the same as the provisions of that Code as they read immediately prior to the adoption of this ordinance, then those provisions shall be construed as continuations of the earlier provisions and not as new enactments.

SECTION 7. The City Clerk shall certify to the adoption of this Ordinance, including the vote for and against and shall post a certified copy of this ordinance, within 15 days after its passage to be posted in at least three (3) public places within the City as established by ordinance, and, in compliance with Section 36933 of the Government Code.

SECTION 8. This Ordinance is adopted pursuant to the authority granted by the California Constitution and State law, including but not limited to Article XI, Section 7 of the California Constitution, the Compassionate Use Act, the Medical Marijuana Program, and The Medical Marijuana Regulation and Safety Act.

ORDINANCE FOR PASSAGE

<u>Ordinance No. 1069</u> – An Ordinance of the City of Santa Fe Springs adopting a Development Agreement (Development Agreement No. 01-2016) by and between the City of Santa Fe Springs and Bulletin Displays, LLC, a Limited Liability Company.

RECOMMENDATION

1. That the City Council waive further reading and adopt Ordinance No. 1069, an ordinance of the City of Santa Fe Springs adopting a Development Agreement (Development Agreement No. 01-2016) by and between the City of Santa Fe Springs and Bulletin Displays, LLC, a Limited Liability Company.

BACKGROUND

Ordinance No. 1069 was introduced and passed its first reading at the January 14, 2016 City Council meeting. Below is the substance of the agenda report for the proposed ordinance as it appeared at that meeting:

At a duly noticed hearing, before the City Council, on November 8, 2012, Ordinance No. 1036 was introduced. The second reading of Ordinance No. 1036 occurred on November 20, 2012. It became effective thirty (30) days after its second reading.

Ordinance No. 1036 improved and updated the City's existing billboard regulations, which were badly outdated and failed to anticipate and regulate 21st-century trends, such as electronic billboards, supergraphics (building wraps), and mobile billboards. Key elements of the ordinance included:

- (1) Updating the definition of billboards to include electronic billboards.
- (2) Limiting electronic billboards to the FOZ.
- (3) Requiring a Conditional Use Permit (CUP) and Development Agreement for all new billboards and expansion of existing billboards.
- (4) Limiting the placement of billboards to properties with a minimum area of 5 acres.
- (5) Creating definitions and regulations for supergraphics and mobile billboards.
- (6) Creating a mechanism for the City to generate additional revenues, either as a one-time payment, or payment over time, or a combination of both.
- (7) Allowing space on new billboards to be utilized for City-related activities, or to bring awareness to City and/or charitable causes.
- (8) Establishing a minimum distance between billboards.
- (9) Limiting the contents of messages beyond sexually explicit materials, alcohol and tobacco advertising.

Pursuant to section 155.384(A), of Ordinance No. 1036, billboards are allowed only after a valid Conditional Use Permit has first been obtained and a Developer Agreement has been approved

On December 14, 2015, the Planning Commission approved Conditional Use Permit (CUP) Case No. 750 and Zone Variance (ZV) No. 76. The CUP allows for the construction and operation of a new digital billboard on a 4.98-acre property at 13711 Freeway Drive. The proposed sign will be approximately 50' tall (including the column and display). The billboard will be double-sided, meaning it will have a display area on both sides of the sign. Each display area will measure 14' x 48. Unlike other typical billboards, the proposed design, which was modeled after the city logo, is very unique and attractive. The ZV allowed for a reduction to the 5-acre minimum size requirement applied to properties with a digital billboard pursuant to Section 155.384 (H)(7) of the City's zoning regulations.

At said meeting, the Planning Commission, via Resolution No. 53-2015, also recommended that the City Council adopt Ordinance No. 1069. City Council approval of Ordinance No. 1069 would allow for a development agreement (Development Agreement No. 01-2016) between the City of Santa Fe Springs and Bulletin Displays, LLC, a Limited Liability Company. The Development Agreement would set forth rules and regulations applicable to the proposed billboards.

Development Agreement

A city's exercise of its power to enter into a development agreement is a legislative act; therefore, development agreements must be approved by ordinance. Under California Government Code Sections 65864 et seq. ("Development Agreement Law") cities can enter into binding development agreements with persons having a legal or equitable interest in real property for the development of such property, all for the purposes of strengthening the public planning process, encouraging private participation and comprehensive planning and identifying the economic costs of such development.

The main points of the Development Agreement (see attachment) are as follows:

- The Developer pays an annual development fee to the City to mitigate potential impacts of the Development on the City and surrounding community.
- 2. The Developer is prohibited from utilizing any of the displays on the New Digital Billboard or the New Static Billboard to advertise tobacco, marijuana, hashish, "gentlemen's clubs", adult entertainment businesses, sexually oriented materials, or use sexually oriented images or language, or as may be prohibited by any City ordinance.
- The City Council has the right to review the Agreement annually, or may, in its sole and absolute discretion, order a special review for compliance with the Agreement at any time at the City's sole cost

("Special Review"). Developer shall cooperate with the City in the conduct of such any Special Review.

LEGAL NOTICE OF PUBLIC HEARING

This matter was set for Public Hearing in accordance with the requirements of Sections 65090 and 65091 of the State Planning, Zoning and Development Laws and the requirements of Sections 155.860 through 155.864 of the City's Municipal Code. Legal notice of the Public Hearing was sent by first class mail to all property owners whose names and addresses appear on the latest County Assessor's Roll within 500 feet of the exterior boundaries of the subject property on December 30, 2015, posted in Santa Fe Springs City Hall, the City Library and Town Center on December 30, 2015, published in a newspaper of general circulation (Whittier Daily News) on January 1, 2016, as required by the State Zoning and Development Laws and by the City's Zoning Regulations.

As of the date of this report, staff has not received any comments and/or inquiries regarding the proposal.

SUMMARY

Ordinance No. 1036 established standards for the installation of billboards on certain properties within the City, only after a valid Conditional Use Permit has been obtained and a development agreement approved. Since a city's exercise of its power to enter a development agreement is a legislative act, development agreements must be approved by ordinance. Ordinance No. 1069 provides the legal authority allowing the City to enter into Development Agreement No. 01-2015 with Bulletin Displays, LLC, a Limited Liability Company.

FISCAL IMPACT

Potential to generate additional source of revenue through negotiated development agreements.

RECOMMENDATION

That the City Council approve the following actions:

- a. Authorize the Director of Purchasing Services to purchase one (1) 2016 Ford CMAX Hybrid, one (1) 2016 Ford F250 Supercab, and one (1) 2016 Ford Transit Passenger Wagon from Downtown Ford Sales through State of California Cooperative Purchasing Contracts: (1-14-23-10A, 1-14-23-20A, and 1-14-23-23A);
- b. Authorize a purchase order to be issued in the amount of \$88,925.37 for this transaction

BACKGROUND

Replacement vehicles are budgeted annually for vehicles that have reached the end of their mileage and/or service use life cycle. The City Council approved in the FY 2015/16 Budget for one (1) 2016 Ford CMAX Hybrid to be used by the Environmental Division of the Fire-Rescue Department; one (1) 2016 Ford Supercab used by Public Works Maintenance Division, and one (1) 2016 Ford Transit Passenger Wagon used by Community Services.

The Director of Purchasing Services requests approval to authorize the purchase of these three (3) trucks by "piggybacking" on existing State of California Contracts (No's. 1-14-23-10A, 1-14-23-20A, and 1-14-23-23A) from Downtown Ford Sales. This includes authorization to issue a purchase order in the amount of \$88,925.37. The State of California issued a contract to Downtown Ford Sales (among a select group of dealerships) based on a comprehensive procurement process for a range of vehicles. The contract is valid for use through February 2, 2016. The quoted amounts include all taxes, fees, and delivery. Below is a summary of the recommended vehicle purchases:

FISCAL IMPACT

The City Council approved \$90,000 in the FY 2015-16 Budget for the acquisition of these three vehicles. The City will realize a \$1,500 savings by taking advantage of a contract payment terms discount of \$500 per vehicle for invoices paid within 20 days. Doing so would bring the total purchase to \$87,425.37, or \$2,574.63 below budget.

<u>Authorize the Purchase of Five (5) 2016 Ford Police Interceptor Utility Vehicles from</u> Downtown Ford Sales

RECOMMENDATION

That the City Council authorize the Director of Purchasing Services to purchase five (5) 2016 Ford Police Interceptor Utility vehicles from Downtown Ford Sales utilizing the City of Sacramento Contract (No. B13131311025) and authorize a purchase order to be issued in the amount of \$177,338.64 for this transaction.

BACKGROUND

Replacement vehicles are budgeted annually for vehicles that have reached the end of their mileage and/or service use life cycle. In the FY 2015-16 Budget, the City Council approved for the replacement of four (4) police interceptor utility vehicles used by the Whittier Police Department in their contract patrol of Santa Fe Springs; and one (1) police interceptor utility vehicle used by Santa Fe Springs Police Service Officers (PSO's).

The Director of Purchasing Services requests approval to authorize the purchase of the five vehicles by "piggybacking" or utilizing an existing City of Sacramento Contract (No. B13131311025) from Downtown Ford Sales. The request includes authorization to issue a purchase order in the amount of \$177,338.64. The City of Sacramento issued a contract to Downtown Ford Sales based on a comprehensive procurement process for this type of police utility vehicles that was awarded on the basis of the lowest responsible bidder. The quoted amounts include all taxes, fees, and delivery.

Below is a summary of the recommended vehicle purchases:

FISCAL IMPACT

The City Council approved \$160,000 in the FY 2015-16 Budget for the acquisition of these five vehicles. The City may realize a \$3,546.77 savings by taking advantage of the contract payment terms that allow for a discount of 2% per vehicle for invoices paid within 20 days. Doing so would bring the total purchase to \$173,791.87 or \$13,791.87 more than the \$160,000 budgeted. The cost difference can be attributed to the added specification requirement of ballistic door panels on the four proposed police units. Since the budget was adopted, the Whittier Police Department has added ballistic door panels as a standard requirement for all police replacement vehicles. Ballistic door panels add a cost of \$3,372.46 per vehicle, for a total of \$13,489.84 on this transaction. If the ballistic doors had not been added, the total cost would have been \$160,302.03, or only \$302.03 more than budgeted.

As an overall consideration, there are anticipated budget savings of \$32,000 in the vehicle acquisition budget activity. We are recommending that a Police Services decoy vehicle originally identified for replacement be kept for a longer period of time. While the 2000 F-150 truck meets the replacement criteria, it is recommended that the vehicle's role and usage level allow for it to be retained beyond the standard replacement timeframe.

Description/Analysis

Issue: The Department of General Services, Fleet Management Division, has a requirement to purchase replacement vehicles for the Police Department for ongoing operations.

Policy Considerations: The recommendations in this report are in accordance with the provisions of City Code Chapter 3.56 and Resolution No. 2010-346 prohibiting the City from entering into any contract to purchase goods or services from any business or entity headquartered in Arizona.

Economic Impacts: None

Environmental Considerations:

California Environmental Quality Act (CEQA): No environmental review is necessary because the recommendations in this report involve the purchase of vehicles and are not considered to be a project in accordance with Section 15378(b)(2) of the CEQA Guidelines.

Sustainability: The recommended purchases are consistent with the Fleet Sustainability Policy adopted by City Council on February 16, 2010 (Resolution No. 2010-083).

Commission/Committee Action: None

Rationale for Recommendation: The Department of General Services, Fleet Management Division, has a requirement to purchase replacement vehicles for the Police Department for ongoing operations.

On January 18, 2013, Fleet Management, in accordance with City Code Chapter 3.56, issued Invitation for Bid No. B13131311025 for the purchase of Ford vehicles. Three responses were received. Downtown Ford was selected as the lowest responsive and responsible bidder. The bid results are provided in Attachment 1.

Financial Considerations: The recommended contract will be used for the following purchases:


- One Police Interceptor sedan budgeted in FY2011/12 in an amount not to exceed \$28,434, purchased from the Department of General Services operating budget (Fleet Fund, Fund 6501) and charged to the Police Department's multi-year operating project for replacement vehicles and equipment (I06013110, General Fund, Fund 1001). Sufficient funds are available in these budgets to make this purchase.
- One Police Interceptor sedan and one Police Interceptor utility vehicle (SUV) budgeted in FY2012/13 in an amount not to exceed \$60,342, purchased with lease financing as approved by City Council on September 27, 2012 (Resolution No. 2012-333), and repaid from the Police Department operating budget (General Fund, Fund 1001). Resolution No. 2012-333 authorized the City Manager to amend the Police department budget to reflect this lease financing. Lease terms are included in Attachment 1.
- An estimated 55 Police Interceptor sedans and one Police Interceptor SUV currently projected to be replaced in FY2013/14 – FY2014/15 in an amount not to exceed \$1,733,760 purchased from the Department of General Services operating budget (Fleet Fund, Fund 6501) and charged to the Police Department's multi-year operating project for replacement vehicles and equipment (I06013110, General Fund, Fund 1001). This includes a contingency of six Police Interceptor

sedans per fiscal year to replace any vehicles totaled in accidents or any vehicles that ultimately need to be replaced ahead of schedule, plus a maximum five percent price increase per year. These purchases are subject to funding availability in the adopted budget of the applicable fiscal year. The actual vehicles to be replaced and the models purchased may be different than the current projection depending on the driving patterns between the date of this report and the replacement year, and the operational needs of the Police Department. Fleet Management staff will meet with the Police Department prior to making the purchases to confirm the models and options required.

<u>Presentation and Consideration of the City's Comprehensive Annual Financial Report</u> (CAFR) for the Fiscal Year ending June 30, 2015

RECOMMENDATION

That the City Council: 1) Receive and file the City's Comprehensive Annual Financial Report (CAFR) for the Fiscal Year ending June 30, 2015 and (2) Approve amendments to the FY 2015-16 budget to transfer General Fund fund balance assignments as recommended by the Council Audit Subcommittee.

CAFR Review

The purpose of the City's CAFR is to provide relevant financial information to the City Council, citizens, staff, grant entities, creditors, bond investors, rating agencies, and other concerned readers.

The City's financial statements contained within the CAFR are presented in conformity with generally accepted accounting principles (GAAP) and audited in accordance with generally accepted auditing standards. The statements are reported on a fiscal year basis beginning July 1st and ending June 30th and have been audited by an independent firm of certified public accountants, Lance, Soll, & Lunghard LLP (LSL), to provide reasonable assurance that they fairly present the City's financial condition.

Pursuant to auditing standards requirements, the City Council has formed an Audit Subcommittee. Its members, Mayor Moore and Councilmember Sarno, working closely with Staff and LSL have examined an earlier draft of the FY 2014-15 CAFR. This is LSL's second year auditing the City after being selected through a comprehensive procurement process in spring 2014.

The year-end audited figures are quite consistent with the preliminary financial information presented to the Council at the December 22nd meeting.

In accordance with auditing standards, LSL has also issued an Audit Communication Letter summarizing the results or the audit and their Report on Internal Control and Compliance.

Attached is the City's CAFR, Audit Communications Letter, and Report on Internal Control and Compliance.

Audit Subcommittee Recommendations

In addition to reviewing the draft CAFR, the Audit Subcommittee made several recommendations regarding the assignment of the General Fund fund balance. The recommendations included assigning the following amounts from the General Fund unassigned fund balance:

Transfer to the Prefunded Capital Projects Fund	\$1,226,000
Transfer to the Employee Benefits Fund	600,000
Transfer to the Equipment Replacement Fund	500,000
Transfer to the Insurance Stabilization Fund	73,700
Total Recommended Transfers	\$2,399,700

The transfer to the Prefunded Capital Projects Fund was recommended to be allocated to two projects: \$400,000 to the City's General Plan Update and \$826,000 to the City's residential paving projects. If approved, City Staff will work with the Council CIP Subcommittee to determine specific recommendations for these projects and bring contracts for approval to the Council prior to beginning work on these projects.

The Employee Benefits Fund transfer of \$600,000 was recommended to be used to make an additional contribution towards the unfunded other post-employment benefits (OPEB) liability. This liability relates to the cost of health insurance premiums for current and retired City employees. The City utilizes a trust fund managed by CalPERS to accumulate funds to be used to cover future costs of these benefits.

The Equipment Replacement Fund transfer of \$500,000 was recommended to be used towards future vehicle and other equipment replacements. The specific vehicles and equipment to be replaced in the future will be approved by the Council at the time of recommended replacement.

The Insurance Stabilization Fund transfer of \$73,700 was recommended to provide additional funds to help offset future rate increases in the City's risk management programs.

Based on the Audit Subcommittee Recommendations, Staff recommends that the Council approve amendments to the FY 2015-16 budget to implement the transfers from the General Fund assigned fund balance as detailed above.



Fiscal Impact

If approved, transfers from the General Fund assigned fund balance will be made to the various funds in the amounts detailed above. In addition, the Employee Benefits Fund will make a contribution to the OPEB trust in the amount of \$600,000.

We have audited the financial statements of the governmental activities, the business-type activities, each major fund, and the aggregate remaining fund information of the City of Santa Fe Springs (the City) for the year ended June 30, 2015. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, Government Auditing Standards and OMB Circular A-133, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated June 15, 2015. Professional standards also require that we communicate to you the following information related to our audit.

Significant Audit Findings

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the City are described in the notes to the financial statements.

As described in Note 1, the City changed accounting policies related to pensions reporting by adopting Statement of Governmental Accounting Standards (GASB Statement) No. 68, Accounting and Financial Reporting for Pensions – an amendment of GASB Statement No. 27 in fiscal year 2014-2015. Accordingly, the cumulative effect of the accounting change as of the beginning of the year is reported in the government-wide statement of activities; and proprietary funds statement of revenues, expenses and changes in net position.

We noted no transactions entered into by the City during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected.

The financial statement disclosures are neutral, consistent, and clear.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management. Management has corrected all such misstatements. In addition, we detected misstatements as a result of audit procedures which were material, and were subsequently corrected by management. The details of these misstatements are described in a separate letter dated January 19, 2016.

Disagreements with Management

For purposes of this letter, a disagreement with management is a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated January 19, 2016.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the City's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the City's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

 The City's accounting manual of policies and procedures states machinery and equipment is depreciated over 7 years. During our procedures, we noted machinery and equipment is being depreciated over 3-10 years. We recommend the City updates its accounting manual of policies and procedures to reflect this information.

Other Matters

We applied certain limited procedures to management's discussion and analysis, the budgetary comparison information, the schedule of changes in the net pension liability and related ratios for the agent multiple-employer miscellaneous plan, schedule of plan contributions for the agent multiple-employer miscellaneous plan, schedule of proportionate share of the net pension liability for multiple-employer cost sharing plans, and the schedule of plan contributions for multiple-employer cost sharing plans which are required supplementary information (RSI) that supplements the basic financial statements. Our procedures consisted of inquiries of management regarding the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit of the basic financial statements. We did not audit the RSI and do not express an opinion or provide any assurance on the RSI.

We were engaged to report on the Statistical Section, which accompany the financial statements but are not RSI. With respect to this supplementary information, we made certain inquiries of management and evaluated the form, content, and methods of preparing the information to determine that the information complies with accounting principles generally accepted in the United States of America, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to our audit of the financial statements. We compared and reconciled the supplementary information to the underlying accounting records used to prepare the financial statements or to the financial statements themselves.

INDEPENDENT AUDITORS' REPORT ON INTERNAL CONTROL OVER FINANCIAL REPORTING AND ON COMPLIANCE AND OTHER MATTERS BASED ON AN AUDIT OF FINANCIAL STATEMENTS PERFORMED IN ACCORDANCE WITH GOVERNMENT AUDITING STANDARDS

To the Honorable Mayor and Members of the City Council City of Santa Fe Springs, California

We have audited, in accordance with the auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in Government Auditing Standards issued by the Comptroller General of the United States, the financial statements of the governmental activities, the business-type activities, each major fund, and the aggregate remaining fund information of the City of Santa Fe Springs, California, (the City) as of and for the year ended June 30, 2015, and the related notes to the financial statements, which collectively comprise the City's basic financial statements, and have issued our report thereon dated January 19, 2016.

Internal Control over Financial Reporting

In planning and performing our audit of the financial statements, we considered the City's internal control over financial reporting (internal control) to determine the audit procedures that are appropriate in the circumstances for the purpose of expressing our opinions on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the City's internal control. Accordingly, we do not express an opinion on the effectiveness of the City's internal control.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the entity's financial statements will not be prevented, or detected and corrected on a timely basis. A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.

Our consideration of internal control was for the limited purpose described in the first paragraph of this section and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and therefore, material weaknesses or significant deficiencies may exist that were not identified. Given these limitations, during our audit we did not identify any deficiencies in internal control that we consider to be material weaknesses. However, material weaknesses may exist that have not been identified. We did identify the following deficiencies in internal control that we consider to be significant deficiencies:

Restatements

During our audit procedures, we noted two items that caused the City to record fund balance and net position restatements. In the General Fund, a fund balance restatement of \$614,946 was recorded to accurately reflect the true sales tax receivable. In addition, construction-in-progress was restated in the amount of \$1,151,753 to capture costs that should have been capitalized in prior years. The City's accounting staff discovered these misstatements through its review of accounts and preparation for the audit.

City's Response to the Finding:

Management makes every effort to create a system that prevents the restatement of beginning fund balance and/or net position. Additionally, management works to set up an internal control system that detects adjustments which may become necessary. During fiscal year 2014-15 two items were noted which required adjustments to the beginning fund balance and net position. In the first case, an adjustment was made to the beginning sales tax receivable in the General Fund related to the past ten years of "triple flip" activity. The triple flip was a state mandate which diverted .25% of sales tax which otherwise belonged to the City. The take away was replaced with additional property tax allocated by Los Angeles County. As the final year of the triple flip approached, the City obtained additional information which revealed that the sales tax receivable account was overstated due to accumulated county administrative fees which had not been reported to the City. The City also discovered an error in the amount which was set up in the first year in which the triple flip took effect. The City's current control system detected this error and the City is confident that the system will prevent such an error in the future.

The second restatement, also discovered by the City, resulted from a review of accumulated costs capitalized as part of the Valley View Grade Separation project. The project, constructed on the border with a neighboring city, took place over several fiscal years. Each year, the costs allocable to each city were determined and reported in each city's respective financial statements. At the conclusion of the project a detailed review was performed which revealed that approximately \$1.2 million in right-of-way acquisition costs were incorrectly reported with the City's capital assets, when in fact, the acquisitions related to property located on the neighboring city's side of the project. The overall project costs were approximately \$70 million and represented the largest capital project ever constructed by the City. The City is confident that the current system is adequate to identify future cost allocations and will take extra care in reviewing these allocations on an annual basis.

The City's response to the findings identified in our audit was not subjected to the auditing procedures applied in the audit of the financial statements and, accordingly, we express no opinion on it.

Accounting System

During our review of internal control procedures, we noted that the City utilizes an accounting system with dated features which may increase the likelihood that misstatements be unprevented or undetected.

Recommendation

We recommend the City upgrade its accounting system to modernly accepted technology. An upgrade will require training for the accounting staff, but it will inherently strengthen the accounting controls and procedures of the City.

City's Response to the Finding:

The City agrees that the accounting system is outdated and has inherent limitations which could limit the overall operation of the internal control system. During fiscal year 2015-16 the City Council set aside \$1.5 million for the replacement of the Citywide finance system. The City has engaged an assessment consultant to assist the City in determining the requirements of the new system and anticipates that a vendor for the new system will be selected in early FY 2016-17. An implementation timeline for the various modules will be determined at that time.

The City's response to the findings identified in our audit was not subjected to the auditing procedures applied in the audit of the financial statements and, accordingly, we express no opinion on it.

Compliance and Other Matters

As part of obtaining reasonable assurance about whether the City's financial statements are free from material misstatement, we performed tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements, noncompliance with which could have a direct and material effect on the determination of financial statement amounts. However, providing an opinion on compliance with those provisions was not an objective of our audit, and accordingly, we do not express such an opinion. The results of our tests disclosed no instances of noncompliance or other matters that are required to be reported under *Government Auditing Standards*.

Purpose of this Report

The purpose of this report is solely to describe the scope of our testing of internal control and compliance and the results of that testing, and not to provide an opinion on the effectiveness of the City's internal control or on compliance. This report is an integral part of an audit performed in accordance with *Government Auditing Standards* in considering the City's internal control and compliance. Accordingly, this communication is not suitable for any other purpose.

Acceptance of State Homeland Security Grant Program (SHSGP) Funds for the Trade-in and Upgrade of the Department of Fire-Rescues Self-Contained Breathing Apparatus (SCBA) Equipment.

RECOMMENDATIONS

That the City Council approve the following actions:

- a. Accept State Homeland Security Grant (SHSGP) funds in the amount of \$86,748.74.
- b. Authorize the trade-in and upgrade of sixty-two (62) Self-Contained Breathing Apparatus (SCBA) and the purchase of related equipment from L.N. Curtis & Sons.

BACKGROUND

In August of 2008, the City Council authorized the Department of Fire-Rescue to purchase 62 self-contained breathing apparatus and related equipment using State Homeland Security Grant Program Funds (SHSGP) in the amount of \$327,941.

The grant was a regional award funded through the Los Angeles Area Fire Chiefs Association (LAAFCA) and was awarded to all thirty-one fire agencies in LA County who wished to participate. The purpose of the grant award was for each agency to purchase and utilize breathing apparatus that were compatible and interchangeable with one another in the event of a mutual aid emergency.

Through extensive testing and research, the Los Angeles Fire Chief's Association (LAAFCA) selected the manufacturer Honeywell First Responder Products and the Sperian Warrior breathing apparatus model. Over the past five years, the Sperian Warrior breathing apparatus purchased by the Los Angeles County fire agencies with the grant funds have presented several inherent electronic issues that were not able to be resolved by the manufacturer. The manufacturer, Honeywell First Responder Products, responded by re-designing the pack and offering a replacement breathing apparatus through a trade-in program. The electronic issues mentioned above are not considered a safety issue and the breathing apparatus may continue to be used until replacements are tested and delivered.

Honeywell First Responder Products is offering each agency two trade-in options. The first option is a trade-in with no additional cost. The new pack is a re-designed 2007 National Institute for Occupational Safety and Health (NIOSH) compliant version of the current pack that utilizes previously purchased SCBA masks and voice amplifier components. The second option is an upgraded 2013 NIOSH compliant pack that includes a new upgraded voice communication system, upgraded face masks, and upgraded electronics. The second option is offered at an additional cost of approximately \$1,400 per unit.

The main differences between the 2007 NIOSH compliant pack and the 2013 NIOSH complaint pack is an increased heat rating in the face piece, an improved voice amplifier system, and upgraded electronics that provide increased safety warning devices for the user.

The Fire Chief recommends the second option that includes the trade-in of the Department's current breathing apparatus and the upgrade to the 2013 NIOSH compliant Sperian Warrior pack. This upgrade will provide Fire-Rescue personnel the latest technology accompanied with the highest level of breathing apparatus protection available. Furthermore, the Department of Fire-Rescue was able to secure 100% funding through the State Homeland Security Grant Program to negotiate this upgrade. The new breathing apparatus will be carried on each Fire-Rescue apparatus and have an estimated service life of fifteen to twenty years.

The trade-in options are only being made available through the original vendor, L.N. Curtis & Sons. The Sperian Warrior Pack is manufactured by Honeywell First Responder Products.

FISCAL IMPACT

The State Homeland Security Grant (SHSGP) is a 100% reimbursable grant so there will be no fiscal impact to the General Fund.

BACKGROUND

February is American Heart Health month; an annual campaign dedicated to raising awareness of heart disease and educating the public about the importance of preventing the disease by living heart healthy lives at home and in our communities.

According to the American Heart Association, heart disease in the leading cause of death for men and women in the United States, causing 1 in 4 deaths each year. Anyone can develop heart disease; however, those with high blood pressure or high cholesterol and those who smoke are at greater risk. Risk factors including diabetes, obesity, poor diet, physical inactivity, and excessive alcohol consumption can also increase the likelihood of developing heart disease. The good news is that heart disease can be prevented when people adopt a few healthy habits such as eating diets rich in fruits and vegetables, consuming food low in salt, saturated fat, and cholesterol, exercising, not smoking, and significantly reducing alcohol use. Managing your health conditions can also lessen the chance of heart attack or developing heart disease.
