BACKGROUND

The Santa Fe Springs Public Financing Authority (PFA) is a City entity that has periodically issued debt for the benefit of the Santa Fe Springs community. The following is a brief status report on the debt instruments currently outstanding that were issued through the PFA.

Consolidated Redevelopment Project 2006-A Tax Allocation Bonds

Financing proceeds available for appropriation at 5/31/18 Outstanding principal at 6/30/18 None \$36,986,736

Bond Repayment

The former Community Development Commission (CDC) issued a number of tax allocation bonds before it was dissolved by State law effective February 1, 2012 which are administered by the City acting as Successor Agency under the oversight of the appointed Oversight Board. The Successor Agency no longer receives tax increment. Instead, distributions from the Redevelopment Property Tax Trust Fund (RPTTF) are received based on approved obligations. It is anticipated that sufficient allocations from the RPTTF will continue to be made to the Successor Agency to meet ongoing debt service obligations.

Unspent Bond Proceeds

Under an approved Bond Expenditure Agreement, unspent bond proceeds of the former CDC in the amount of approximately \$19 million were transferred to the City in July 2014. The funds are to be spent in accordance with the original bond documents. The unspent proceeds continue to be a source of funding within the City's capital improvement program (CIP).

2016 Bond Refunding

In July 2016 the Successor Agency issued its 2016 Tax Allocation Refunding Bonds, which paid off several bond issuances of the former CDC. The bonds were originally issued through the Public Financing Authority and included the 2001 Series A, 2002 Series A, 2003 Series A, the current interest portion of the 2006 Series A, and 2006 Series B bond issuances.

The Santa Fe Springs Water Utility Authority (WUA) is a City entity that has issued debt for the benefit of the Santa Fe Springs community. The following is a brief status report on the debt instruments currently outstanding that were issued through the WUA.

In May 2013 the Water Utility Authority issued the 2013 Water Revenue Bonds in the amount of \$6,890,000. The bonds refunded the existing 2003 Water Revenue Bonds (issued through the Public Financing Authority) and provided additional funds for water improvement projects in the amount of \$2,134,339. The funds were restricted for use on water system improvements. In August 2013 the Water Utility Authority Board appropriated the proceeds for the Equipping Water Well No. 12 Project and all proceeds were since used on this project.

In January 2018 the Water Utility Authority issued the 2018 Water Revenue Bonds in the amount of \$1,800,000. The bonds refunded the existing 2005 Water Revenue Bonds (issued through the Public Financing Authority). No additional funds were raised through the issuance of the 2018 Water Revenue Bonds.

The City budget includes sufficient appropriations and adequate revenues are expected to be collected to meet the debt service obligations associated with the 2013 and 2018 Water Revenue Bonds.

RECOMMENDATION

BACKGROUND

This report is for informational purposes only. The following is a listing of current active water projects.

Imperial Highway Underpass Storm Pump Retrofit

Caliagua was awarded the project and work began at the Imperial Underpass on July 9, 2018. Existing pumps, motors, and pipe fittings were disconnected and removed. The two new pumps, corresponding motors, and pipe fittings were installed and connected on July 12th. Preliminary pump testing is scheduled for the week of July 23rd. City Staff completed the required electrical upgrades resulting in cost savings to the project. The project is anticipated to be completed by July 30, 2018.

Water Well No. 12 – Packer Testing Hydrogeological Services

City Council directed Staff to evaluate the option of installing well packers to eliminate the potential sources of elevated concentrations of iron and hydrogen sulfide. Staff has prepared a request for proposals (RFP) as a separate item on the agenda to provide packer testing hydrological services to prepare specifications to install well packers and to test water quality at Water Well No. 12.

INFRASTRUCTURE IMPACT

The completion of the Imperial Underpass project will greatly improve reliability, efficiency, and public safety during storm and flooding conditions. The production of adequate water quality by Water Well No. 12 is imperative to addressing the City's water demands.

FISCAL IMPACT

The Imperial Highway Underpass Project is funded through the one-time nonrecurring account. Funding for the Water Well No. 12 - Packer Testing Hydrological Services Agreement is available through the Water CIP Fund.

The City of Santa Fe Springs (AGENCY) is seeking proposals for hydrogeological services to develop specifications for installing packers and water quality testing of Water Well No. 12 located at 13939 Borate Street, Santa Fe Springs, CA 90670. Several issues have been identified with the quality of the ground water pumped from the well, particularly elevated concentrations of iron (brown color) and hydrogen sulfide (odor).

Proposers are requested to submit their proposals and written statements of technical qualifications for completing the work in accordance with and as specified in this Request for Proposals (RFP). If a Consultant requires clarifications to this RFP, the Consultant shall notify the AGENCY in writing in accordance with Subsection "A" above. Should it be found that the point in question is not clearly and fully set forth in the RFP, a written addendum clarifying the matter will be issued.

C. Submitting Requests

All questions must be submitted to the AGENCY by 4:00 p.m. on Monday, August 6, 2018. The AGENCY is not responsible for failure to respond to a request or question that has not been labeled correctly. Questions can be submitted via U.S. Mail, Personal Courier, Fax or Email as long as they are received no later than the date and time specified above. The AGENCY is not liable for any late arrivals due to courier method or electronic delivery.

Requests for clarifications, questions and comments received after 4:00 p.m. on Monday, August 6, 2018 will not be responded to.

D. Agency Responses

The AGENCY, in its sole discretion, will respond to requests for clarifications, questions and comments. Responses will be emailed to proposers on or before 5:00 p.m. on August 9, 2018.

7. <u>COST OF PROPOSAL PREPARATION</u>

Any party responding to this RFP shall do so at their own risk and cost. The AGENCY shall not, under any circumstances, be liable for any pre-contractual expenses incurred by any Consultant who elects to submit a proposal in response to this RFP or by any Consultant that is selected. Pre-contractual expenses are defined as expenses incurred by Consultants and the selected Consultant, if any, in:

- Preparing a Proposal and related information in response to this RFP;
- Submitting a Proposal to the AGENCY;
- Negotiations with the AGENCY on any matter related to this RFP;
- Costs associated with interviews, meetings, travel or presentations; or

• Any and all other expenses incurred by a Consultant prior to the date of award, if any, of an agreement, and formal notice to proceed.

The AGENCY will provide only the staff assistance and documentation specifically referred to herein and will not be responsible for any other cost or obligation of any kind, which may be incurred by the Consultant.

8. <u>CONFLICT OF INTEREST</u>

By responding to this RFP, each Consultant represents to the best of its knowledge that:

- Neither Consultant, nor any of its affiliates, proposed sub-consultants, and associated staff, have communicated with any member of the AGENCY since the release of this RFP on any matter related to this RFP except to the extent specified in this RFP;
- Neither Consultant, nor any of its affiliates, proposed sub-consultants and associated staff, has obtained or used any information regarding this RFP and the proposed services that has not been generally available to all Consultants, and
- No conflict of interest exists under any applicable statute or regulation or as a result of any past or current contractual relationship with the AGENCY;
- Neither Consultant, nor any of its affiliates, proposed sub-consultants, or associated staff, have any financial interest in any property that will be affected by any of the referenced projects.
- Neither Consultant, nor any of its affiliates, proposed sub-consultants, or associated staff, have a personal relationship with any member of the governing body, officer or employee of the AGENCY who exercises any functions or responsibilities in connection with the referenced projects.

9. <u>KEY PERSONNEL</u>

It is imperative that key personnel proposed to provide services have the background, experience and qualifications to properly undertake all necessary services for the successful completion of the referenced project. The Consultant must identify all proposed key personnel in its Proposal. Key personnel must be well qualified and have sufficient experience in the areas described in the Scope of Services.

The AGENCY reserves the right to approve all key personnel individually for any and all projects authorized by the AGENCY as a result of this solicitation. After an agreement has been executed, the selected consultant may not replace any key staff without written approval from the AGENCY. The AGENCY must approve replacement staff before a substitute person is assigned to a project. The AGENCY reserves the right to require the Consultant to replace a staff person assigned to the contract should the AGENCY consider replacement to be for the good of the project. Replacement staff will be subject to the AGENCY's approval prior to assignment by Consultant.

10. BASIS FOR AWARD OF CONTRACT

The contract is to be awarded to the Consultant whose proposal best meets the technical requirements of the RFP as determined by the AGENCY. Should an award be made, the proposal submitted by Consultant shall be incorporated as part of the final contract accordingly.

The AGENCY intends to select the Consultant on the basis of demonstrated competence and professional qualifications and accreditation in accordance with applicable State and Federal regulations.

11. <u>FEE SCHEDULE</u>

The AGENCY will compensate the Consultant for actual hours worked by assigned personnel on a monthly basis. Compensation will be based on the fee schedule in the proposal. The consultant will provide an invoice clearly documenting the services performed each day and the number of hours worked.

12. REQUIRED FORMAT FOR PROPOSALS

The AGENCY is requiring all proposals submitted in response to this RFP to follow a specific format. The Proposal, including the Appendices, shall not exceed thirty (30) pages in length, utilizing 8.5" x 11" pages with one-inch margins. As an exception, 11" x 17" pages may be used to display organizational charts. Font size shall not be smaller than 12 point for text or eight (8) point for graphics. Dividers used to separate sections will not be counted. Creative use of dividers to portray team qualifications, etc. is discouraged.

Consultants are required to prepare their written proposals in accordance with the instructions outlined below. Deviations from these instructions may be construed as non-responsive and may be cause for disqualification. Emphasis should be placed on accuracy, completeness, and clarity of content.

The written proposal should be organized as described below. Each section of the written proposal should contain the title of that section, with the response following the title. The following are the required titles with a brief statement as to that section's desired content:

A. Letter of Offer

The AGENCY has the right to accept or reject any changes made to the proposed project team members, including the use of consultants and/or subcontractors.

E. Work Approach

This section of the Proposal shall include a narrative that addresses the Scope of Services and demonstrates that Consultant understands the scope of this project. More specifically, the Proposal should include the Consultant's general approach for completing the activities specified in the Scope of Services. The work approach shall be of sufficient detail to demonstrate Consultant's ability to accomplish the project tasks.

F. Client References

List your three (3) most recent similar clients (including name, address, contact person, and phone number). The AGENCY is most interested in government and California clients and may randomly select agencies to contact from your list as part of the evaluation process.

G. Appendices

This part shall include brief resumes of proposed staff. Consultant information and general marketing materials will not be considered in the ranking of the Proposals.

H. Rights to Materials

All responses, inquiries, and correspondence relating to this RFP and all reports, charts, displays, schedules, exhibits, and other documentation produced by the Consultant that are submitted as part of the proposal and not withdrawn shall, upon receipt by AGENCY, become property of AGENCY.

J. Fee Proposal.

A Fee Proposal shall be provided in a <u>separately sealed envelope and shall comply</u> with the following guidelines:

Two copies of a Fee Proposal shall be submitted in a separately sealed envelope plainly labeled "Fee Proposal" with the name of the Consultant and project title "Hydrogeological Services for Water Well No. 12 Packer Testing" shall be presented in a manner that allows the AGENCY to understand the Fee Schedule. The terms and conditions for obtaining 'reimbursable costs' shall be identified in the Proposal.

13. PROPOSAL EVALUATION PROCESS AND CRITERIA

A. GENERAL

All proposals will be evaluated based on the technical information and qualifications presented in the proposal, reference checks, and other information, which may be gathered independently. E. FINAL SELECTION

The final selection will be the consultant which, as determined by the AGENCY, is the most responsive and responsible, meets the AGENCY's requirements in

providing this service, and is in the AGENCY's best interest. The AGENCY maintains the sole and exclusive right to evaluate the merits of the proposals received.

14. EXCEPTIONS OR ADDITIONS

The Proposal shall include a detailed description of all of the exceptions to the provisions and conditions of this RFP upon which the Consultant's submittal is contingent and which shall take precedence over this RFP.

15. INSURANCE REQUIREMENTS

Prior to the start of contract negotiations, the highest qualified Consultant will be required to submit to the City the required insurance certificates for the Consultant and its team. Insurance certificates will also be required, in advance, for any Consultant subsequently identified for negotiations with the AGENCY.

The successful Consultant shall indemnify and hold AGENCY and its officers, agents, employees, and assigns harmless from any liability imposed for injury whether arising before or after completion of work hereunder or in any manner directly or indirectly caused, occasioned, or contributed to, or claims to be caused, occasioned, or contributed to, in whole or in part, by reason of any act or omission, including strict liability or negligence of Consultant, or of anyone acting under Consultant's direction or control or on its behalf, in connection with, or incident to, or arising out of the performance of this contract.

- 3. Joslin Avenue from Flallon Avenue to Orr & Day Road

The projects scope of work included the sealing of all cracks with Polyflex Type 2, followed by slurry sealing which is a mixture of asphalt emulsion and fine crushed aggregate that is spread on the surface of the road and striping with thermoplastic material.

The following payment detail represents the Final Payment (less 5% Retention) due per terms of the contract for the work which has been completed and found to be satisfactory.

The final construction cost is \$98,205.32. The final project cost including construction, engineering, inspection and contingency is within the budgeted amount of \$120,000.

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANTA FE SPRINGS, CALIFORNIA CONFIRMING A DIAGRAM AND ASSESSMENT AND PROVIDING FOR ANNUAL ASSESSMENT LEVY

WHEREAS, the City Council has initiated for the annual levy of the assessments for a lighting district pursuant to the terms and provisions of the "Landscaping and Lighting Act of 1972" being Part 2 of Division 15 of the Streets and Highways Code of the State of California, in a district known and designated as:

WHEREAS, the City Council has ordered the preparation of a report and the City Engineer has prepared and filed with this City Council a report pursuant to law for its consideration and subsequently thereto, this City Council did adopt its Resolution of Intention to levy and collect assessments for the next ensuing fiscal year relating to the above-referenced District, and further did proceed to give notice of the time and place for a Public Hearing on all matters relating to said annual levy of the proposed assessment; and

WHEREAS, at this time, this City Council has heard all testimony and evidence and is desirous of proceeding with said annual levy of assessments.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SANTA FE SPRINGS DOES HEREBY RESOLVE AS FOLLOWS:

Section 1: That the above recitals are true and correct.

<u>Section 2:</u> That upon the conclusion of the Public Hearing, written protests filed, and not withdrawn, did not represent property owners owning more than fifty percent (50%) of the area of assessable lands within the District, and all protests are overruled and denied.

<u>Section 3:</u> That this City Council hereby confirms the diagram and assessment as submitted and orders the annual levy of the assessment for the fiscal year and in the amounts as set forth in the Engineer's Report and as referred to in the Resolution of Intention as previously adopted relating to said annual assessment levy.

<u>Section 4:</u> That the diagram and assessment as set forth and contained in said Engineer's Report are hereby confirmed and adopted by this City Council.

<u>Section 5:</u> That the adoption of this Resolution constitutes the levy of the assessment for the fiscal year.

<u>Section 6:</u> That the estimates of costs, the assessment diagram, the assessments and all other matters, as set forth in the Engineer's Report," pursuant to said "Landscaping and Lighting Act of 1972," as submitted, are hereby approved, adopted by this City Council and hereby confirmed.

<u>Section 7:</u> That the maintenance works of improvements contemplated by the Resolution of Intention shall be performed pursuant to law and the County Auditor shall enter on the County Assessment Roll the amount of the Assessment, and said assessment shall then be collected at the same time and in the same manner as the County taxes are collected. After collection by said County, the net amount of the assessment shall be paid to the City Treasurer of said City.

<u>Section 8:</u> That the City Treasurer has previously established a special fund known as the

<u>Section 10:</u> That a certified copy of the assessment and diagram shall be filed in the Office of the City Engineer, with a duplicate copy on file in the office of the City Clerk and open for public inspection.

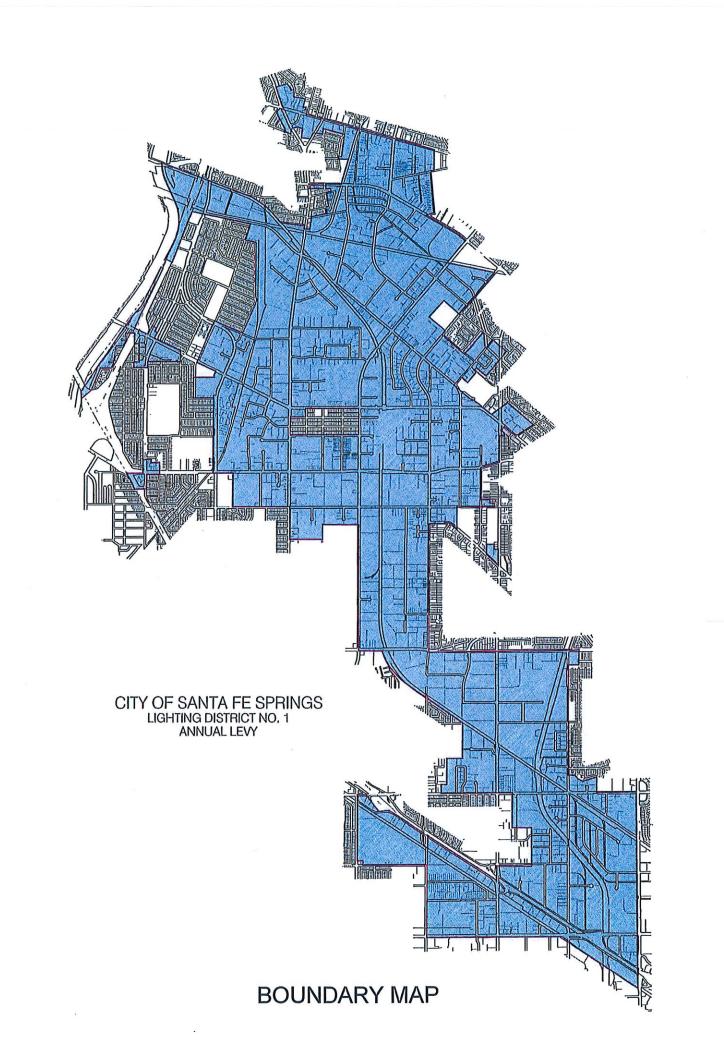

CITY OF SANTA FE SPRINGS Heritage Springs Assessment District 2001-1 (Hawkins Street and Palm Drive)

RESOLVED, by the City Council (the "Council") of the City of Santa Fe Springs, County of Los Angeles, State of California, that:

WHEREAS, this Council has conducted proceedings under and pursuant to the Municipal Improvement Act of 1913, Division 12, California Streets and Highways Code (the "Act") and Resolution Ordering the Assessment District Formation No. 6642, adopted June 28, 2001 (the "Resolution of Formation"), to form the Heritage Springs Assessment District 2001-1 (the "Assessment District"), to authorize the levy of special assessment upon the lands within the Assessment District, to acquire and construct public streets and other improvements, all as described therein; and

WHEREAS, pursuant to Section 10100.8 of the Act and the Resolution of Intention, this Council is authorized to levy annual assessments (the "Assessments") for maintenance, repair or improvement, including all expenses required for resurfacing and repair to public streets (the "Maintenance") in and adjacent to the Assessment District to keep such acquisitions and improvements in fit operating condition which are ordinarily incurred no more frequently than every five years, of the acquisitions and improvements for the Assessment District; and

WHEREAS, under the Act, this Council and for the annual levy of the Assessments, on July 12, 2018, has adopted Resolution No. 9594, a Resolution of the City Council of the City of Santa Fe Springs of Intention to Levy Annual Assessments for the City of Santa Fe Springs Heritage Springs Assessment District 2001-1 for Fiscal Year 2018/2019 (the "Intention Resolution") and approved the Engineer's Report (the "Engineer's Report") prepared pursuant to the Act for purposes of the levy of assessments for Fiscal Year 2018/2019; and

WHEREAS, as specified in the Intention Resolution, and upon notice as required by the Act, this Council held a public hearing on the issue of the levy of the assessments for the Next Fiscal Year, and all persons desiring to be heard were given an opportunity to be heard, and all objections to the assessment were considered by this Council.

NOW, THEREFORE, IT IS ORDERED as follows:

1. Objections Overruled. The objections and protests against the annual levy of assessments for the Assessment District, as a whole or as to any part thereof, or against the estimate of costs and the assessments, in whole or in part, written and oral, are hereby overruled.

2. Public Interest. The public interest, convenience and necessity require the levy of annual assessments for the Assessment District.

3. District Described. The District specially benefited and to be assessed to pay the costs and expenses thereof, and the exterior boundaries thereof, are as shown by the assessment diagram thereof filed in the offices of the City Clerk, which map is made a part hereof by reference thereto.

4. Engineer's Report Approved. The Engineer's Report, in the form on file with the City Clerk and to which reference is hereby made for further particulars, including the estimates of costs and expenses, the apportionment of assessments and the assessment diagram contained in the Engineer's Report, was adopted on July 12, 2018 by Resolution No. 9593 shall stand as the Engineer's Report for FY 2018/2019.

5. Benefits Determined. Based on the oral and documentary evidence, including the Engineer's Report, offered and received at the public hearing, this Board expressly finds and determines that each of the several subdivisions of land in the Assessment District will be specially benefited.

6. Collection of Assessments. The assessments herein confirmed shall be collected in the same manner and upon the same roll as general taxes of the County of Los Angeles are collected. The Director of Finance and Administrative Services or other authorized official of the City is hereby authorized and directed to cause such collections to be made for the Next Fiscal Year.

7. Effective. This resolution shall take effect from and after its adoption.

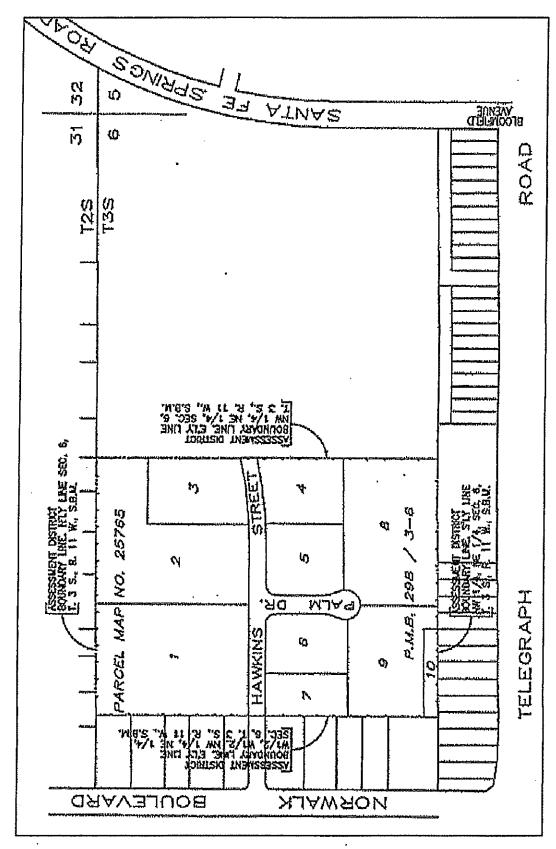

COUNCIL MEMBER REQUESTED ITEM

Market Rent Appraisal of the Ground Lease of the Santa Fe Springs Post Office, located at 11760 Telegraph Road, Santa Fe Springs, CA 90670.

RECOMMENDATIONS: That the City Council:

- Receive and file the results of the Market Rent Appraisal of the ground lease of the Santa Fe Springs Post Office;
- Provide staff with direction regarding Cushman & Wakefield's proposal to negotiate, on the behalf of the City, a new lease agreement with the United States Post Office; and
- Provide staff with direction, in the event, a new lease agreement cannot be reached with the United States Post Office; and
- Provide staff with direction, other than what is enumerated above.

BACKGROUND

The purpose of this item is for the City Council to consider the recent market rent appraisal completed by the Valuation and Advisory division of Cushman & Wakefield, of the ground lease for the Santa Fe Springs post office, located within the City's Civic Center, specifically at 11760 Telegraph Road, Santa Fe Springs, CA 90670. Cushman and Wakefield is one of the largest commercial and real estate services firm with revenues of over \$6 billion. The firm operates in more than 70 countries and has 48,000 employees.

The postal building is a concrete block building that based on building records, was finalled in 1968. The original building permit indicates a building of 12,994 sq. ft. with a lobby expansion in 1981. It is 100 percent occupied by the United States Postal Service. The underlying land is a $\pm 35,850$ sq. ft. portion of a larger legal parcel of $\pm 159,865$ sq. ft. A gated, asphalt-paved parking lot, with ± 44 parking spaces, is located at the rear of the building.

It appears that the lease between the City of Santa Fe Springs and the United States Postal Office (USPS) commenced in 1967 for an initial twenty (20) year term, with six, five-year extensions. The rent was based on whether the postal building would be occupied by a post office use or a non-post office use, with the rent for non-post office use being on average, 25 percent higher. Notwithstanding, the last five-year extension will expire on June 1, 2019. The annual rent currently paid by the United States Postal Office is \$6,491.00.

The purpose of the market rent appraisal report is to estimate the fair market rent for the property as is. Market Rent or Rental Value is defined as the most probable rent that a property should bring in a competitive and open market reflecting all conditions

and restrictions of the lease agreement, including permitted uses, use restrictions, expense obligations, term, concessions, renewal and purchase options, and tenant improvements. Cushman & Wakefield developed the following opinion of Rental value:

Note: The Value Conclusion is based on a lease area of 17,150 sq. ft., It appears that the lease area is $\pm 11,564$ sq. ft.; thus the value conclusion would be \$213,934 ($\$18.60 \times 11,564$ sq. ft.)

The USPS has retained the services of Jones Lang LaSalle to negotiate on their behalf. Although there is some discrepancy, regarding the exact area of the ground lease (11,564 sq. ft. versus 12,994 sq. ft.), the price per square foot remains the same, but the total value of the lease will change.

In addition to providing the opinion of rental value, Cushman & Wakefield (C&W) has proposed working directly with the City to negotiate a new lease with the USPS. Their service would include:

- Providing direct communication with the existing tenant (USPS) and their broker (JLL).
- Preparing all written lease proposals and communications for City approval. (C&W will rely upon the recently completed Post Office rental valuation and local market knowledge to assist the city in maximizing the potential rental income for the Post Office).
- Working with the City's legal counsel to prepare a "market lease" agreement.

Cost Structure:

Should a new lease terms be agreed upon, the City would be responsible for a brokerage fee to the USPS broker in the range of 3% to 4% (negotiable) plus a fee to C&W for 2% (proposed) of the total lease revenue. For example, if the USPS agreed to a new five-year lease at \$1.55 per sq. ft. NNN per month, the total rental income would be approximately (11,564 sq. ft. x \$1.55 per. sq. ft. x 60 months) \$1,075,452 and the typical fee to the tenant side broker would be 3% or \$32,263 and the landlord side at 2% would be \$21,509 for a total fee of \$53,772. This amount would be due once the lease has been fully executed.

Market Rent Appraisal-Ground Lease-Santa Fe Springs Post Office

If an agreement cannot be reached with the USPS, the C-4, Community Commercial, Zone would allow the property to be developed into a community-centric retail center, with the following benefits to the City:

- Create a community gathering place which would complement and enhance the City Center, Clarke Estate, and surrounding green space
- Generate much higher ground lease proceeds than the present USPS ground lease
- Produce retail sales tax from retailers occupying the redeveloped improvements
- Establish an amenity center which will benefit surrounding residents, businesses, and property owners

FISCAL IMPACT

There is no fiscal impacts associated with the Market Rent Appraisal of the ground lease. If, however, a new lease with the USPS is negotiated, the City will receive revenue beyond the current \$540.92 a month it is receiving for the current lease.

INFRASTRUCTURE IMPACT

No infrastructure impacts are associated with the Market Rent Appraisal of the ground lease nor its renewal.

ORDINANCE FOR ADOPTION

Zone Change Case No. 137

<u>Ordinance No. 1093</u>: An Ordinance of the City Council of the City of Santa Fe Springs, requesting approval of Zone Change Case No. 137, to change the zoning designation for properties located on the west side of Carmenita Road, approximately 605 feet south of Lakeland Road, from PF (Public Facilities) to R-3-PD (Multiple Family Residential – Planned Development). (Storm Properties, Inc.)

RECOMMENDATION

Staff recommends that the City Council:

- Find that Zone Change Case No. 137 satisfies the criteria and conditions set forth in Section 155.825 et. seq. of the City Code for the granting of a Change of Zone request; and
- Find that Zone Change Case No. 137, involving the proposed Change of Zone from PF, Public Facilities to R-3-PD, Multiple Family Residential Planned Development, is consistent with the City's General Plan; and
- Waive further reading and adopt Ordinance No. 1093, approving Zone Change Case No. 137.

JULY 12, 2018 CITY COUNCIL MEETING

Ordinance No. 1093, passed its first reading at the July 12, 2018 City Council meeting. Below is the substance of the agenda report for the proposed Ordinance as it appeared at the City Council meeting of July 12th, listed under New Business as "Zone Change Case No. 137 / Ordinance No. 1093." It should be noted that there was no one from the public who came up to speak in favor or against the subject Ordinance.

LOCATION/BACKGROUND

The subject property, located at 13300 Lakeland Road, is currently comprised of one (1) parcel (APN: 8026-008-903) measuring approximately 558,028 sq. ft. (12.81-acres), and located at the southwest corner of Carmenita Road and Lakeland Road. The subject property is zoned PF (Public Facilities) and is currently developed with an elementary school to the north and a preschool to the south. Residential uses are located to the north, south, east, and west of the property. The residential properties located to the east, west, and a portion of the south of the subject property are not within the City's boundaries, but are within an unincorporated area of Los Angeles County.

As part of their proposal to develop a new 128-unit gated apartment project, Storm Properties will subdivide the existing 12.81-acre parcel into 3 separate parcels. The South Whittier School District will continue to own all three parcel but will be leasing the middle portion to Storm Properties to develop their apartment project. The

northerly and southerly parcels will continue to be occupied by Carmela Elementary School and Options State Preschool, respectively. The table provided below helps clarify the addresses and associated use for each of the three proposed parcels.

PREVIOUS ACTIONS BY PLANNING COMMISSION

On April 9, 2018, the Planning Commission held a public hearing on the proposed 128-unit gated apartment development, including Zone Change Case No. 137. After opening the Public Hearing, listening to a presentation from Staff, and receiving concerned comments from the public, the Planning Commission continued the agenda items to the following Planning Commission date of May 14, 2018.

On May 14, 2018, the Planning Commission held a public hearing on the proposed 128-unit gated apartment development, including Zone Change Case No. 137, and after opening the Public Hearing, listening to a presentation from Staff and receiving comments, the Planning Commission approved Tentative Parcel Map No. 78240, Development Plan Approval Case No. 935, Conditional Use Permit Case No. 786, and recommended that the City Council approve the subject Zone Change Case No. 137 and General Plan Amendment Case No. 27.

On May 25, 2018, an appeal for the proposed project was filed with the City Clerk.

On June 14, 2018, the City Council held a public hearing to consider the appeal of the proposed 128-unit gated apartment development and all related entitlements, including the proposed Zone Change. After opening the Public Hearing, listening to a presentation from Staff and receiving comments, the City Council approved Tentative Parcel Map No. 78240, Development Plan Approval Case No. 935, Conditional Use Permit Case No. 785, Conditional Use Permit Case No. 786, and set a public hearing for the July 12, 2018 City Council meeting to consider the first reading for Zone Change Case No. 137 and to approve General Plan Amendment Case No. 27.

Below are the case numbers, as well as, a brief description of each entitlement request, including the subject Zone Change:

<u>Tentative Parcel Map (TPM 78240)</u> – A request for approval to allow the approximately 12.81-acre subject site to be subdivided into three (3) separate parcels measuring Report Submitted By: Cuong Nguyen Planning and Development Dept. 274,799 sq. ft. (Parcel 1), 223,416 sq. ft. (Parcel 2), and 59,813 sq. ft. (Parcel 3) for property located at 13300 Lakeland Road (existing APN: 8026-008-903), within the PF, Public Facilities, and proposed R-3-PD, Multiple Family Residential – Planned Development, Zones.

<u>General Plan Amendment (GPA 27)</u> – A request for approval to amend the Land Use Map of the City's General Plan for properties located on the west side of Carmenita Road, approximately 605 feet south of Lakeland Road, from the existing land use designation of Public Facilities to Multiple Family Residential.

Zone Change (ZC 137) – A request for approval to change the zoning designation for properties located on the west side of Carmenita Road, approximately 605 feet south of Lakeland Road, from PF (Public Facilities) to R-3-PD (Multiple Family Residential – Planned Development).

<u>Development Plan Approval (DPA 935)</u> – A request for approval to allow the construction of a new 128-unit gated apartment complex and appurtenant improvements at 11201 – 11313 Carmenita Road, within the proposed R-3-PD, Multiple Family Residential – Planned Development, Zone.

<u>Conditional Use Permit (CUP 785)</u> – A request for approval to allow the operation and maintenance of a new 128-unit gated apartment complex and appurtenant improvements (totaling approximately 174,201 sq. ft.) on property located at 11201 – 11313 Carmenita Road, within the proposed R-3-PD, Multiple Family Residential – Planned Development, Zone.

<u>Conditional Use Permit (CUP 786)</u> – A request for approval to allow the operation and maintenance of a preschool use located at 11325 Carmenita Road, within the proposed R-3-PD, Multiple Family Residential – Planned Development, Zone.

The City Council also approved and adopted the proposed Initial Study/Mitigated Negative Declaration, and Mitigation Monitoring and Reporting Program (IS/MND/MMRP), which, based on the findings of the Initial Study and the proposed mitigation measures, indicates that there is no substantial evidence that the approval of Tentative Parcel Map Case No. 78240, General Plan Amendment Case No. 27, Zone Change Case No. 137, Development Plan Approval Case No. 935, Conditional Use Permit Case No. 785, and Conditional Use Permit Case No. 786 will have significant adverse effects that cannot be mitigated to levels of insignificance.

STREETS AND HIGHWAYS

The property is located at the southwest corner of Lakeland Road and Carmenita Road. Carmenita Road is designated as a "Major" arterial and Lakeland Road is designated as a "Secondary" arterial, within the Circulation Element of the City's General Plan.

ZONING & GENERAL PLAN LAND USE DESIGNATION

The subject property is currently zoned PF, Public Facilities with a general plan land use designation of "Public Facilities." The proposed zoning is R-3-PD, Multiple Family Residential – Planned Development with a general plan land use designation of "Multiple Family Residential." As shown in Table 2 Below, the zoning, General Plan and land use of the surrounding properties are as follows:

LEGAL NOTICE OF PUBLIC HEARING

This matter was set for Public Hearing in accordance with the requirements of Sections 65090 et seq. and 65854 of the State Planning, Zoning and Development Laws and the requirements of Sections 155.860 through 155.866 of the City's Municipal Code. Legal notice of the Public Hearing for the proposed zone change was sent by first class mail to all property owners whose names and addresses appear on the latest County Assessor's Roll within 500 feet of the exterior boundaries of the subject property on June 28, 2018. The legal notice was also posted at Santa Fe Springs City Hall, the City Library and the City's Town Center kiosk and published in a newspaper of general circulation (Whittier Daily News) on June 28, 2018, as required by the State Zoning and Development Laws and by the City's Zoning Ordinance.

ENVIRONMENTAL IMPACT ASSESSMENT

The environmental analysis provided in the Initial Study indicates that the proposed project will not result in any significant adverse immitigable impacts on the environment therefore, at the June 14, 2018 City Council Meeting, the City Council approved and adopted a Mitigated Negative Declaration (MND) for the proposed Project. The MND reflects the independent judgment of the City of Santa Fe Springs, and the environmental consultant, Blodgett/Baylosis Environmental Planning.

ZONING ORDINANCE REQUIREMENTS – FINDINGS

1. That there is a real need in the community for more of the types of uses permitted by the zone requested than can be accommodated in the areas already zoned for such use.

There is a need in the community for additional housing. Santa Fe Springs is a predominantly industrial community with most of its residential neighborhoods built out in the 1950's. Approximately ten percent of the City's 8.9 square miles is zoned for residential uses, and virtually all of those areas are now fully developed.

The City is also expected to experience future growth in population and employment; thus, the need for these types of uses (residential) permitted by the zone change request. Table 3 outlines the Southern California Association of Governments (SCAG) population, housing and employment forecast for Santa Fe Springs.

As seen in the table, between 2008 and 2020, the population is projected to increase by 1,700 individuals, housing is projected to increase by 400 units, and employment is projected to remain unchanged. Between 2020 and 2015, the population is projected to increase by 2,400 individuals, housing is projected to increase by 600 units, and employment is projected to increase by 900 jobs.

With projected increases in population and employment, coupled with the complete build-out of residentially zoned areas of the City, there is a definite need for additional residentially zoned properties in the City.

2. That the property involved in the proposed change of zone is more suitable for the uses permitted in the proposed zone than for the uses permitted in the present zone classification.

Although the uses within the PF, Public Facilities, Zone are compatible with the surrounding properties, the uses within the R-3-PD, Multiple Family – Planned

Development, Zone will be much more suitable with the various residential uses that currently surround the subject property. Moreover, the proposed 5.13-acre area in which the apartments will be constructed is not currently utilized by the South Whittier School District. Therefore, the proposed zone change will allow the construction of a harmonious development, and thus, improve the appearance and attractiveness of the subject site.

3. That the proposed change of zone would not be detrimental in any way to persons or property in the surrounding area, nor to the community in general.

The proposed Zone Change and associated General Plan Amendment will have the following positive impacts: (1) address the housing shortage in the City by adding up to 128 apartment units and expanding the economic variety of housing in the City; (2) promote jobs/housing balance by locating attractive housing in proximity to employment centers and to convenient freeway access (approximately 2.5 miles from the I-5 Freeway); and (3) provide a project that incorporates high-quality landscaping and aesthetics, creating a more beautiful and livable neighborhood environment.

4. That the proposed change of zone will not adversely affect the master plan of the city.

The General Plan is the *master plan of the city*. The General Plan provides the overall direction for the future development of the City. It is a comprehensive planning document that addresses the many aspects of community life in the City of Santa Fe Springs. It is a long range plan in that it seeks to provide for the needs of the community into the future. The General Plan is also flexible enough to respond to the changing needs and concerns of those who live, work and frequent Santa Fe Springs.

The General Plan consists of six mandatory elements, including: 1) Land Use; 2) Housing; 3) Open Space/Conservation; 4) Safety; 5) Circulation; and 6) Noise. There is no evidence to suggest that the proposed Zone Change will *adversely affect the master plan of the city*.

The table on the following page (Table 4) illustrates how the proposed Zone Change will be consistent with the goals and policies of the General Plan.

WHEREAS, on April 9, 2018, the Planning Commission voted to continue the matter to the May 14, 2018 Planning Commission Meeting; and

WHEREAS, on May 14, 2018, the Planning Commission of the City of Santa Fe Springs held a public hearing on the proposed Zone Change, at which time oral and documentary evidence was introduced along with the written recommendations of the Planning Commission, and the Planning Commission received public testimony; and

WHEREAS, the Planning Commission considered information presented by the applicant, the Planning and Development Department, and other interested parties at that public hearing on May 14, 2018; and

WHEREAS, on May 14, 2018, the Planning Commission found and determined that the subject Ordinance will not result in any significant adverse immitigable impacts on the environment, therefore, approved and adopted a Mitigated Negative Declaration (MND) for the proposed project; and

WHEREAS, on May 14, 2018, the Planning Commission unanimously voted to approve Tentative Parcel Map No. 78240, Development Plan Approval Case No. 935, Conditional Use Permit Case No. 785, Conditional Use Permit Case No. 786, and to recommend the City Council approve General Plan Amendment Case No. 27 and Zone Change Case No. 137; and

WHEREAS, on May 25, 2018, an appeal for the proposed project was filed with the City Clerk; and

WHEREAS, on June 14, 2018, the City Council of the City of Santa Fe Springs held a public hearing on the consideration of an appeal for the proposed apartment development, including the proposed Zone Change, at which time oral and documentary evidence was introduced along with the written recommendations of the Planning Commission and Planning and Development Department of the City of Santa Fe Springs, and the City Council received public testimony; and

WHEREAS, the City Council considered the Planning Commission's recommendations, and information presented by the applicant, the Planning and Development Department, and other interested parties at a public hearing held on June 14, 2018.

WHEREAS, on June 14, 2018, the City Council found and determined that the subject Ordinance will not result in any significant adverse immitigable impacts on the environment, therefore, approved and adopted a Mitigated Negative Declaration (MND) for the proposed project; and

WHEREAS, on June 14, 2018, the City Council unanimously voted to approve Tentative Parcel Map No. 78240, Development Plan Approval Case No. 935, Conditional Use Permit Case No. 785, Conditional Use Permit Case No. 786, and to set a public hearing for the July 12, 2018 City Council Meeting to consider the first reading for Zone Change Case No. 137 and to approve General Plan Amendment Case No. 27; and

WHEREAS, on July 12, 2018 the City Council of the City of Santa Fe Springs held a public hearing to consider the first reading for Zone Change Case No. 137 and to approve General Plan Amendment Case No. 27; and

WHEREAS, on July 26, 2018 the City Council of the City of Santa Fe Springs held a public hearing to consider the second reading for Zone Change Case No. 137, and to approve and adopt Ordinance No. 1093.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SANTA FE SPRINGS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. Attached hereto and, by this reference, made a part hereof, is a map entitled "Exhibit A." The property which is the subject of this Ordinance is shown on said map as currently being in the PF, Public Facilities, Zone, and more specifically described as a 6.50-acre portion of an existing 12.81-acre parcel (APN: 8026-008-903), at the southwest corner of Lakeland Road and Carmenita Road. The property addresses are identified as 11201 – 11313 Carmenita Road and 11325 Carmenita Road.

SECTION 2. Title 15 of the Code of Ordinances of the City of Santa Fe Springs, which chapter is the Zoning Ordinance of the City, is amended by placing a 6.50-acre portion of an existing 12.81-acre property shown upon "Exhibit A" as being in the R-3-PD, Multiple Family Residential – Planned Development, Zone. The property addresses are identified as 11201 – 11313 Carmenita Road and 11325 Carmenita Road.

SECTION 3. The City Clerk shall certify to the adoption of this Ordinance, including the vote for and against and shall post a certified copy of this Ordinance, within 15 days after its passage to be posted in at least three (3) public places within the City as established by ordinance, and, in compliance with Section 36933 of the Government Code.

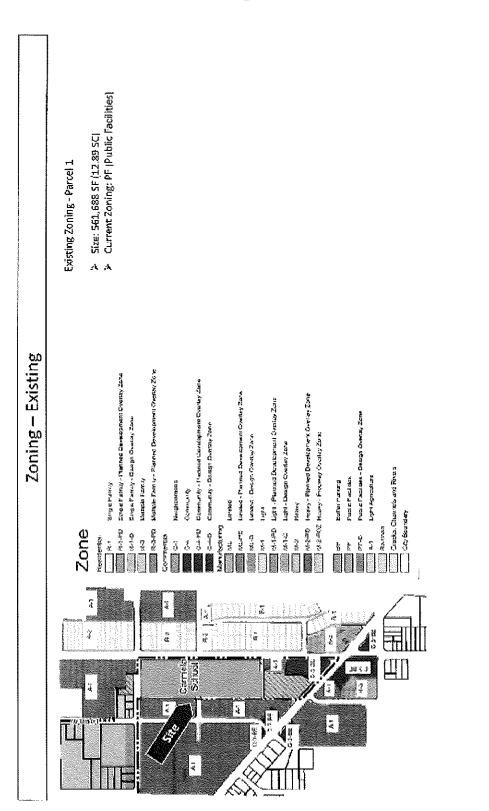

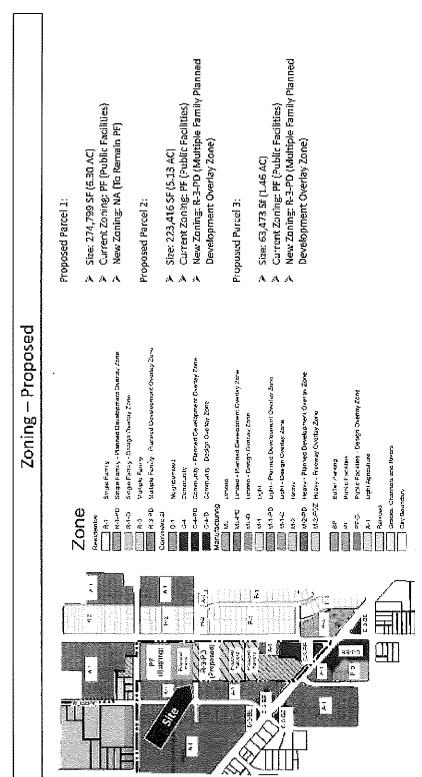

<u>Second reading of Ordinance No. 1094 of the City of Santa Fe Springs, California</u> <u>enacting a transactions and use tax to be administered by the Department of Tax</u> <u>and Fee and Selection of Councilmembers to Submit Arguments</u>

<u>RECOMMENDATION</u> : That the City Council:

- Give second reading and adopt Ordinance No. 1094 of the City of Santa Fe Springs, California enacting a transactions and use tax to be administered by the Department of Tax and Fee Administration, **subject to adoption by the** electorate;
- Select Council Members to submit arguments.

BACKGROUND

At its July 12, 2018 meeting, the City Council adopted two resolutions and gave first reading to an ordinance to place a measure on the November 2018 statewide general election ballot to establish a one-cent transaction and use tax ("Measure").

1. Ordinance Approving Transaction and Use Tax

A city may levy, increase, or extend a transactions and use tax for general purposes if the ordinance proposing that tax is <u>approved</u> by a *two-thirds vote* of the City Council (four of five councilmembers) followed by approval of a majority vote of the qualified voters of the city." Rev & T C §7285.9. Attorneys specializing in state and local taxes recommend that the City Council follow the standard procedure for adopting ordinances-i.e.) give first and second reading, in order to comply with the "approval" requirement in Revenue and Taxation Code Section 7285.9.

At its July 12, 2018 meeting, the City Council gave first reading to the attached ordinance. Tonight's action would consist of giving second reading and adopting the ordinance. Upon approval, the Ordinance will be forwarded to the County of Los Angeles to be placed on the November 2018 statewide general election ballot.

2. Resolution No. 9590: Ballot Arguments and Impartial Analysis

At its July 12, 2018 meeting, the City Council adopted Resolution No. 9590 which authorized councilmembers to prepare arguments. The staff report provided details required councilmember arguments. Tonight's action, the Council would specify which members of the City Council should prepare the arguments in support of the Measure that will be included in the voter pamphlet materials that voters receive. Elections Code Section 9282. The ballot argument must be accompanied by the names and signatures of no more than five (5) people.

ORDINANCE NO. 1094

ORDINANCE OF THE CITY OF SANTA FE SPRINGS, CALIFORNIA ENACTING A TRANSACTIONS AND USE TAX TO BE ADMINISTERED BY THE DEPARTMENT OF TAX AND FEE ADMINISTRATION, SUBJECT TO ADOPTION BY THE ELECTORATE

THE CITY COUNCIL OF THE CITY OF SANTA FE SPRINGS DOES ORDAIN AS FOLLOWS:

SECTION 1. TITLE. This ordinance shall be known as the City of Santa Fe Springs Transactions and Use Tax Ordinance of 2018. The City of Santa Fe Springs hereinafter shall be called "City." This ordinance shall be applicable in the incorporated territory of the City.

SECTION 2. OPERATIVE DATE. "Operative Date" means the first day of the first calendar quarter, commencing more than 110 days after the approval of the tax set forth herein by the voters pursuant to Section 15 of this ordinance.

SECTION 3. PURPOSE. This ordinance is adopted to achieve the following, among other purposes, and directs that the provisions hereof be interpreted in order to accomplish those purposes:

A. To impose a retail transactions and use tax in accordance with the provisions of Part 1.6 (commencing with Section 7251) of Division 2 of the Revenue and Taxation Code and Section 7285.9 of Part 1.7 of Division 2 which authorizes the City to adopt this tax ordinance which shall be operative if a majority of the electors voting on the measure vote to approve the imposition of the tax at an election called for that purpose.

B. To adopt a retail transactions and use tax ordinance that incorporates provisions identical to those of the Sales and Use Tax Law of the State of California insofar as those provisions are not inconsistent with the requirements and limitations contained in Part 1.6 of Division 2 of the Revenue and Taxation Code.

C. To adopt a retail transactions and use tax ordinance that imposes a tax and provides a measure therefore that can be administered and collected by the Department of Tax and Fee Administration in a manner that adapts itself as fully as practicable to, and requires the least possible deviation from, the existing statutory and administrative procedures followed by the Department of Tax and Fee Administration in administering and collecting the California State Sales and Use Taxes.

D. To adopt a retail transactions and use tax ordinance that can be administered in a manner that will be, to the greatest degree possible, consistent with the provisions of Part 1.6 of Division 2 of the Revenue and Taxation Code, minimize the cost of collecting the transactions and use taxes, and at the same time, minimize the burden of record keeping upon persons subject to taxation under the provisions of this ordinance. **SECTION 4**. CONTRACT WITH STATE. Prior to the operative date, the City shall contract with the Department of Tax and Fee Administration to perform all functions incident to the administration and operation of this transactions and use tax ordinance; provided, that if the City shall not have contracted with the Department of Tax and Fee Administration prior to the operative date, it shall nevertheless so contract and in such a case the operative date shall be the first day of the first calendar quarter following the execution of such a contract.

SECTION 5. TRANSACTIONS TAX RATE. For the privilege of selling tangible personal property at retail, a tax is hereby imposed upon all retailers in the incorporated territory of the City at the rate of 1% of the gross receipts of any retailer from the sale of all tangible personal property sold at retail in said territory on and after the operative date of this ordinance.

SECTION 6. PLACE OF SALE. For the purposes of this ordinance, all retail sales are consummated at the place of business of the retailer unless the tangible personal property sold is delivered by the retailer or his agent to an out-of-state destination or to a common carrier for delivery to an out-of-state destination. The gross receipts from such sales shall include delivery charges, when such charges are subject to the state sales and use tax, regardless of the place to which delivery is made. In the event a retailer has no permanent place of business in the State or has more than one place of business, the place or places at which the retail sales are consummated shall be determined under rules and regulations to be prescribed and adopted by the Department of Tax and Fee Administration.

SECTION 7. USE TAX RATE. An excise tax is hereby imposed on the storage, use or other consumption in the City of tangible personal property purchased from any retailer on and after the operative date of this ordinance for storage, use or other consumption in said territory at the rate of 1% of the sales price of the property. The sales price shall include delivery charges when such charges are subject to state sales or use tax regardless of the place to which delivery is made.

SECTION 8. ADOPTION OF PROVISIONS OF STATE LAW. Except as otherwise provided in this ordinance and except insofar as they are inconsistent with the provisions of Part 1.6 of Division 2 of the Revenue and Taxation Code, all of the provisions of Part 1 (commencing with Section 6001) of Division 2 of the Revenue and Taxation Code are hereby adopted and made a part of this ordinance as though fully set forth herein.

SECTION 9. LIMITATIONS ON ADOPTION OF STATE LAW AND COLLECTION OF USE TAXES. In adopting the provisions of Part 1 of Division 2 of the Revenue and Taxation Code:

A. Wherever the State of California is named or referred to as the taxing agency, the name of this City shall be substituted therefor. However, the substitution shall not be made when:

1. The word "State" is used as a part of the title of the State Controller, State Treasurer, State Board of Control, State Board of Equalization, Department of Tax and Fee Administration, State Treasury, or the Constitution of the State of California;

2. The result of that substitution would require action to be taken by or against this City or any agency, officer, or employee thereof rather than by or against the Department of Tax and Fee Administration, in performing the functions incident to the administration or operation of this Ordinance.

3. In those sections, including, but not necessarily limited to sections referring to the exterior boundaries of the State of California, where the result of the substitution would be to:

a. Provide an exemption from this tax with respect to certain sales, storage, use or other consumption of tangible personal property which would not otherwise be exempt from this tax while such sales, storage, use or other consumption remain subject to tax by the State under the provisions of Part 1 of Division 2 of the Revenue and Taxation Code, or;

b. Impose this tax with respect to certain sales, storage, use or other consumption of tangible personal property which would not be subject to tax by the state under the said provision of that code.

4. In Sections 6701, 6702 (except in the last sentence thereof), 6711, 6715, 6737, 6797 or 6828 of the Revenue and Taxation Code.

B. The word "City" shall be substituted for the word "State" in the phrase "retailer engaged in business in this State" in Section 6203 and in the definition of that phrase in Section 6203.

SECTION 10. PERMIT NOT REQUIRED. If a seller's permit has been issued to a retailer under Section 6067 of the Revenue and Taxation Code, an additional transactor's permit shall not be required by this ordinance.

SECTION 11. EXEMPTIONS AND EXCLUSIONS.

A. There shall be excluded from the measure of the transactions tax and the use tax the amount of any sales tax or use tax imposed by the State of California or by any city, city and county, or county pursuant to the Bradley-Burns Uniform Local Sales and Use Tax Law or the amount of any state-administered transactions or use tax.

B. There are exempted from the computation of the amount of transactions tax the gross receipts from:

1. Sales of tangible personal property, other than fuel or petroleum products, to operators of aircraft to be used or consumed principally outside the county in which the sale is made and directly and exclusively in the use of such aircraft

as common carriers of persons or property under the authority of the laws of this State, the United States, or any foreign government.

2. Sales of property to be used outside the City which is shipped to a point outside the City, pursuant to the contract of sale, by delivery to such point by the retailer or his agent, or by delivery by the retailer to a carrier for shipment to a consignee at such point. For the purposes of this paragraph, delivery to a point outside the City shall be satisfied:

a. With respect to vehicles (other than commercial vehicles) subject to registration pursuant to Chapter 1 (commencing with Section 4000) of Division 3 of the Vehicle Code, aircraft licensed in compliance with Section 21411 of the Public Utilities Code, and undocumented vessels registered under Division 3.5 (commencing with Section 9840) of the Vehicle Code by registration to an out-of-City address and by a declaration under penalty of perjury, signed by the buyer, stating that such address is, in fact, his or her principal place of residence; and

b. With respect to commercial vehicles, by registration to a place of business out-of-City and declaration under penalty of perjury, signed by the buyer, that the vehicle will be operated from that address.

3. The sale of tangible personal property if the seller is obligated to furnish the property for a fixed price pursuant to a contract entered into prior to the operative date of this ordinance.

4. A lease of tangible personal property which is a continuing sale of such property, for any period of time for which the lessor is obligated to lease the property for an amount fixed by the lease prior to the operative date of this ordinance.

5. For the purposes of subparagraphs (3) and (4) of this section, the sale or lease of tangible personal property shall be deemed not to be obligated pursuant to a contract or lease for any period of time for which any party to the contract or lease has the unconditional right to terminate the contract or lease upon notice, whether or not such right is exercised.

C. There are exempted from the use tax imposed by this ordinance, the storage, use or other consumption in this City of tangible personal property:

1. The gross receipts from the sale of which have been subject to a transactions tax under any state-administered transactions and use tax ordinance.

2. Other than fuel or petroleum products purchased by operators of aircraft and used or consumed by such operators directly and exclusively in the use of such aircraft as common carriers of persons or property for hire or compensation under a certificate of public convenience and necessity issued pursuant to the laws of this State, the United States, or any foreign government. This exemption is in addition to the exemptions provided in Sections 6366 and 6366.1 of the Revenue and Taxation Code of the State of California.

3. If the purchaser is obligated to purchase the property for a fixed price pursuant to a contract entered into prior to the operative date of this ordinance.

4. If the possession of, or the exercise of any right or power over, the tangible personal property arises under a lease which is a continuing purchase of such property for any period of time for which the lessee is obligated to lease the property for an amount fixed by a lease prior to the operative date of this ordinance.

5. For the purposes of subparagraphs (3) and (4) of this section, storage, use, or other consumption, or possession of, or exercise of any right or power over, tangible personal property shall be deemed not to be obligated pursuant to a contract or lease for any period of time for which any party to the contract or lease has the unconditional right to terminate the contract or lease upon notice, whether or not such right is exercised.

6. Except as provided in subparagraph (7), a retailer engaged in business in the City shall not be required to collect use tax from the purchaser of tangible personal property, unless the retailer ships or delivers the property into the City or participates within the City in making the sale of the property, including, but not limited to, soliciting or receiving the order, either directly or indirectly, at a place of business of the retailer in the City or through any representative, agent, canvasser, solicitor, subsidiary, or person in the City under the authority of the retailer.

7. "A retailer engaged in business in the City" shall also include any retailer of any of the following: vehicles subject to registration pursuant to Chapter 1 (commencing with Section 4000) of Division 3 of the Vehicle Code, aircraft licensed in compliance with Section 21411 of the Public Utilities Code, or undocumented vessels registered under Division 3.5 (commencing with Section 9840) of the Vehicle Code. That retailer shall be required to collect use tax from any purchaser who registers or licenses the vehicle, vessel, or aircraft at an address in the City.

D. Any person subject to use tax under this ordinance may credit against that tax any transactions tax or reimbursement for transactions tax paid to a district imposing, or retailer liable for a transactions tax pursuant to Part 1.6 of Division 2 of the Revenue and Taxation Code with respect to the sale to the person of the property the storage, use or other consumption of which is subject to the use tax.

SECTION 12. AMENDMENTS TO STATE LAW. All amendments subsequent to the effective date of this ordinance to Part 1 of Division 2 of the Revenue and Taxation Code relating to sales and use taxes and which are not inconsistent with Part 1.6 and Part 1.7 of Division 2 of the Revenue and Taxation Code, and all amendments to Part 1.6 and Part 1.7 of Division 2 of the Revenue and Taxation Code, shall automatically become a part of this ordinance, provided however, that no such amendment shall operate so as to affect the rate of tax imposed by this ordinance.

SECTION 13. ENJOINING COLLECTION FORBIDDEN. No injunction or writ of mandate or other legal or equitable process shall issue in any suit, action or

proceeding in any court against the State or the City, or against any officer of the State or the City, to prevent or enjoin the collection under this ordinance, or Part 1.6 of Division 2 of the Revenue and Taxation Code, of any tax or any amount of tax required to be collected.

SECTION 14. SEVERABILITY. If any provision of this ordinance or the application thereof to any person or circumstance is held invalid, the remainder of the ordinance and the application of such provision to other persons or circumstances shall not be affected thereby.

SECTION 15. EFFECTIVE DATE AND SUBMISSION TO VOTERS. This ordinance relates to the levying and collecting of City transactions and use tax and shall take effect immediately. However, no tax imposed by this ordinance shall be effective unless that tax has been approved by the voters of the City as required by Section 2(b) of Article XIII C of the California Constitution and applicable law. Furthermore, the tax shall become operative only as set forth in Section 2 of this Ordinance.

SECTION 16. AUDIT. The proceeds of the tax imposed pursuant to this Ordinance, as well as the expenditure thereof, shall be audited annually by an independent accounting firm.

SECTION 17. TERMINATION. If approved by the voters, the tax imposed by this Ordinance shall be levied until terminated by voters.

SECTION 18. USE OF FUNDS. The proceeds of the tax imposed by this ordinance shall be deposited in the general fund of the City and may be used to fund additional law enforcement services and for any other lawful municipal purpose. The tax does not meet the criteria established by Section 1(d) of Article XIII C of the California Constitution for special taxes, and is a general tax imposed for general government purposes.

The forgoing ordinance was introduced at a regular meeting of the Santa Fe Springs City Council on July 12, 2018 and adopted at a regular meeting of the Santa Fe Springs City Council on July 26, 2018 by the following vote:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANTA FE SPRINGS, CALIFORNIA, AUTHORIZING COUNCIL MEMBERS TO SUBMIT ARGUMENTS, SETTING PRIORITIES FOR SELECTING ARGUMENTS TO PRINT, AND DIRECTING THE CITY ATTORNEY TO PREPARE AN IMPARTIAL ANALYSIS RELATING TO A CITY MEASURE

WHEREAS, at the November 6, 2018 General Municipal Election, Santa Fe Springs voters will consider Ordinance No. 1094, the City of City of Santa Fe Springs Transactions and Use Tax Ordinance of 2018 (the "Ordinance"), which is attached hereto as Exhibit "A" and incorporated herein by reference; and

WHEREAS, the question to be presented to Santa Fe Springs' voters is the following:

To maintain quality neighborhoods	YES
and effective 911 emergency response services by retaining firefighters, police officers, and paramedics; fixing potholes/streets; maintaining senior services, parks, library services, after school programs, community events, and graffiti removal shall a one cent transactions and use tax available for general municipal revenue purposes be collected in the City of Santa Fe Springs generating approximately \$12.8 million annually, until ended by voters, requiring annual audits, with all funds controlled locally?	NO

WHEREAS, the city council, any council member, any registered voter, any bona fide association of citizens, or any combination of voters and associations may file a written argument for or against any city measure not to exceed 300 words that must be distributed to voters in the voter information guide in accordance with state law including, but not limited to, Elections Code Sections 9280 *et. seq.*; and

WHEREAS, if more than one argument is submitted for or against any measure, the City Clerk must select only one argument, using the following order

of priority of the argument's signatories in accordance with state law including, but not limited to, California Elections Code Section 9287:

- The city council, or any member or members of the council authorized by the city council;
- The bona fide sponsor of the measure;
- Bona fide associations of citizens; and
- Individual voters eligible to vote on the measure

WHEREAS, given the order of priority outlined in the preceding paragraph, the City Council by adoption of this resolution may determine authorship by the City Council of arguments in favor of the Ordinance; and

WHEREAS, additionally, whenever a city measure qualifies for a place on the ballot, the city attorney, on direction of the city council, must prepare an impartial analysis of the measure showing the effect of the measure on existing law and the operation of the measure in accordance with state law including, but not limited to California Elections Code Section 9280.

NOWTHEREFORE, THE CITY COUNCIL OF THE CITY OF SANTA FE SPRINGS DOES RESOLVE AS FOLLOWS:

SECTION 1. The City Council determines that the priorities for selection of direct and rebuttal arguments for printing shall be those described in Elections Code Section 9287. That the City Council authorizes the following member(s) of its body

(Mayor In Favor/rebuttal) (Mayor Pro Tem In Favor/rebuttal) (Council Member In Favor/rebuttal) (Council Member In Favor/rebuttal) (Council Member In Favor/rebuttal)

to file a written argument In Favor of the City measure, not exceeding 300 words, accompanied by the printed names(s) and signature(s) of the author(s) submitting it, in accordance with Article 4, Chapter 3, Division 9 of the Elections Code of the State of California. The arguments may be changed or withdrawn until and including the date the fixed by the City Clerk after which no arguments for or against the City measure may be submitted to the City Clerk.

SECTION 2. That arguments for and against said measure may be filed in accordance with applicable provisions of the law. In the event that the City Council does not authorize the Council as a body or any individual member of the Council to file a written argument or any rebuttal argument for or against the measure, the City Clerk shall consider other arguments and rebuttal arguments filed by bona fide associations or individual residents who are eligible to vote in accordance with Elections Code Sections

9282, 9285 and 9287. Pursuant to Section 9285 of the California Elections Code, the provisions of which are hereby adopted, when the City Clerk has selected the arguments for and against the measure which will be printed and distributed to the voters, the City Clerk shall send copies of the argument in favor of the measure to the authors of the argument against, and copies of the argument against to the authors of the argument in favor. The rebuttal arguments shall be filed with the City Clerk not more than ten (10) days after the final date for filing direct arguments. Rebuttal arguments shall be printed in the same manner as the direct arguments. Each rebuttal argument shall immediately follow the direct argument which it seeks to rebut. The text of the measure shall be printed on the ballot in the voter information portion of the sample ballot.

SECTION 3. That the City Council directs the City Clerk to transmit a copy of the measure to the City Attorney who shall prepare an impartial analysis of the measure not exceeding 500 words showing the effect of the measure on the existing law and the operation of the measure. The impartial analysis shall be filed by the date set by the City Clerk for the filing of primary arguments. The impartial analysis shall include a statement indicating whether the measure was placed on the ballot by the City Council. In the event that the entire text of the measure is not printed on the ballot, or in the voter information portion of the sample ballot, there shall be printed immediately below the impartial analysis of the Ordinance or Measure... If you desire a copy of the ordinance or measure, please call the election official's office at (562) 868-0511 and a copy will be mailed at no cost to you."

SECTION 4. The City Clerk shall certify to the passage and adoption hereof.

Introduction of Ordinance No. 1094 and adoption of Resolution Nos. 9589 and 9590 to Place a Transaction and Use Tax on the November 6, 2018 Regular Municipal Election Ballot

RECOMMENDATION : That the City Council adopts:

- Give first reading to Ordinance No. 1094 of the City of Santa Fe Springs, California enacting a transactions and use tax to be administered by the Department of Tax and Fee Administration, subject to adoption by the electorate;
- Adopt Resolution No. 9589 to submit to voters at the November 6, 2018 Regular Municipal Election a Measure to establish a one percent general transactions and use tax, and requesting the Board of Supervisors of the County of Los Angeles consolidate that election with the statewide general election and to render specific services to the city relating to the conduct of the election; and
- Adopt Resolution No. 9590 Authorizing council members to submit arguments, setting priorities for selecting arguments to print, and directing the City Attorney to prepare an Impartial Analysis relating to the Measure

BACKGROUND

During the budget process, the City Council has discussed the many financial challenges facing the City of Santa Fe Springs due to a number of factors including, but not limited to, a structural deficit of approximately \$5.8 million which is expected to grow to over \$12 million over the next six fiscal years. The structural deficit is primarily a result of the continuing effects brought on by the dissolution of redevelopment agencies in the State of California and expenditures increasing faster than revenues. Over the past six years, the City has made significant cuts in staff and city services, however, in order to maintain existing city services, one of the proposals is placing a measure on the November 2018 statewide general election ballot to establish a one cent transaction and use tax ("Measure") to be used for general revenue purposes to fund critical city services including, but not limited to, maintaining current levels of police, fire, and paramedic personnel, 911 emergency response times, maintaining local streets and intersections, youth antigang and anti-drug prevention programs, after-school recreation programs, and improving City infrastructure.

The Measure is expected to raise approximately \$12.8 million annually. The Measure would operate similar to the current sales tax with some notable exceptions:

- Sales of property made within the City but delivered to a customer outside of the City <u>are not subject</u> to the Measure.
- Sales of property made outside of the City but delivered to a customer within the City are subject to the Measure.
- Vehicle sales are subject to the Measure if registered within the City, regardless of location of purchase.
- Fixed-price contracts (i.e. leases) entered into prior to the effective date of the Measure and sales of property to operators of aircraft are exempt from the Measure.

Due to these differences, the actual revenue generated by the Measure may vary from the estimated \$12.8 million. City Staff has worked with the City's sales tax consultant. MuniServices LLC, to analyze the current sales tax level and expectations for the amount that would be generated by the Measure. The total sales tax base is divided into several categories (i.e. general retail, food products, transportation, construction, business-to-business) and then each category is further divided into segments (i.e. apparel stores, drug stores, department stores, etc. within general retail and office equipment, light industry, heavy industry, etc. with business-to-business). An expected percentage is assigned to each segment within each category, which is then multiplied against the current level of sales tax received from each segment. Higher percentages of current activity are applied to general retail and food product categories (i.e. generally 75-100%) while lower percentages are applied to construction and business-to-business categories (i.e. generally 4-40%). This produces an estimate of the level of revenue to be expected from the current base. Lastly, based on past experience with other agencies and the City's demographics, an amount is estimated which would be generated outside of the current base. This amount represents sales from outside of the City which are delivered to customers within the City.

The amount expected is an estimate and can vary approximately \$1.1 million from the anticipated amount. If approved, the Measure would become effective April 1, 2019 with the first collections received by the City in June 2019. It will take approximately one full year of collections to evaluate the ongoing amount which should be expected from the Measure.

Procedure for Adoption of the Measure

Both Proposition 218 and Proposition 62 require a general tax, as proposed here, to be approved by a majority of voters during a regularly scheduled general election of the City Council (except in the case of an emergency). Cal. Const. art XIIIC §2(b); Govt. C §53723. Since a city council election will be held in November 2018, it is the appropriate date for voters to consider this Measure. However, prior to the Measure being placed on the ballot, a number of procedural steps must be followed by the City Council that includes City Council:

- 1. Adoption of the Ordinance enacting the Measure;
- Adoption of a resolution "calling for an election" to submit the Measure to voters along with taking a number of other procedural steps including requesting the Board of Supervisors of the County of Los Angeles to consolidate the Measure with the regularly scheduled statewide general election and administer the election on behalf of the City; and
- 3. Adopting a resolution authorizing council members to submit arguments and directing the City Attorney to prepare an impartial analysis about the Measure.

1. Ordinance Approving Transaction and Use Tax

A city may levy, increase, or extend a transactions and use tax for general purposes if the ordinance proposing that tax is <u>approved</u> by a *two-thirds vote* of the City Council (four of five councilmembers) followed by approval of a majority vote of the qualified voters of the city." Rev & T C §7285.9. Attorneys specializing in state and local taxes recommend that the City Council follow the standard procedure for adopting ordinances-i.e.) give first and second reading, in order to comply with the "approval" requirement in Revenue and Taxation Code Section 7285.9. The attached ordinance is prepared in accordance with Revenue and Tax Code's requirements for a transaction and use taxes and has been reviewed and approved by the California Department of Tax and Fee Administration ("CDTFA") prior to its presentation to the City Council.

2. Resolution Calling Election and Taking Other Procedural Steps

In order to place the Measure on the November 2018 ballot, the City Council adopts the attached resolution "calling for the election" for voters to consider the following question:

In addition to calling for the election, the resolution also requests election services and consolidation from the Los Angeles Board of Supervisors.

3. Resolution No. 9590: Ballot Arguments and Impartial Analysis

In the event the City Council move forward with the Measure, the City Council has first priority in deciding whether the entire council, or a portion of the council, would like to prepare and sign the argument in favor (along with a rebuttal of any argument against) of the Measure that will be included in the voter pamphlet materials that voters receive. Elections Code Section 9282. The ballot argument must be accompanied by the names and

signatures of no more than five (5) people. Therefore, the City Council may decide 1) the entire council will prepare and sign the argument in favor of the Measure, 2) a lesser number of councilmembers sign the Measure or 3) the entire council may opt out of signing the argument in favor of the Measure.

With the UUT that was passed by Santa Fe Springs voters in 2010, the ballot argument in favor of Measure S was signed by one (1) councilmember (Putnam), former mayor Gus Velasco, then Santa Fe Springs Firefighters Association President, then chair of the Senior Citizens Advisory Committee and the Fire Chief at the time. In the event a majority of the council decides to prepare and sign the argument in favor of the Measure, it would require compliance with the Brown Act.

Alternatively, in the event of NO councilmembers prepare/sign the argument in favor of the Measure, the order of priority for submitting the argument as set forth in Elections Code Section 9287 is as follows: a bona fide sponsor of the measure, a bona fide association of citizens, followed by individual voters eligible to vote on the measure.

Finally, whenever a city measure qualifies for placement on the ballot, the city attorney, on direction of the city council, must prepare an impartial analysis of the measure showing the effect of the measure on existing law and the operation of the measure. The impartial analysis must also include a statement indicating whether the measure was placed on the ballot by a petition signed by the requisite number of voters or by the governing body of the city.

CONCLUSION

Once the City Council takes the actions, discussed above, the following table provides a general timeline of the relevant dates that follow.

FISCAL IMPACT

BACKGROUND

It is necessary for the City Council to adopt a resolution calling and giving notice of holding a general municipal election in the City of Santa Fe Springs on November 6, 2018 and requesting the Board of Supervisors of the County of Los Angles to consolidate the general municipal election with the statewide general election.

By adoption of proposed resolutions, Los Angeles County Registrar/Recorder County Clerk is authorized to canvass the returns of the election.

CONCLUSION

Following this action, the City Clerk's office will submit the election materials to the County of Los Angeles Registrar of Voters.

FISCAL IMPACT

The estimated cost for the November 2018 statewide general election is approximately \$75,000.00.

RESOLUTION NO. 9599

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANTA FE SPRINGS, CALIFORNIA CALLING A GENERAL MUNICIPAL ELECTION TO BE HELD ON NOVEMBER 6, 2018 FOR THE ELECTION OF THREE (3) COUNCILMEMBERS

THE CITY COUNCIL OF THE CITY OF SANTA FE SPRINGS DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:

WHEREAS, pursuant to state law, The City Council has requested the consolidation of the City's General Municipal Election with the Statewide General Election by adopting Resolution No. 9599.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SANTA FE SPRINGS, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

<u>SECTION 1</u>. Incorporation of Recitals. The foregoing recitals are true and correct and are hereby incorporated and made an operative part of this Resolution.

<u>SECTION 2</u>. Pursuant to the laws of the State of California, relating to general law cities, there is called and ordered a general municipal election in the City of Santa Fe Springs, California, to be held on Tuesday, November 6, 2018 for the purpose of electing three (3) members of the City Council to a four (4) year term.

<u>SECTION 3</u>. In all particulars not recited in this Resolution, the election shall be held and conducted as provided by law for holding municipal elections and the consolidation of municipal election with the statewide general election.

<u>SECTION 4</u>. Notice of the time and place of the election is hereby given. Additionally, the City Clerk is authorized, instructed and directed to procure and furnish any and all official ballots, notices, printed matter and all supplies, equipment and paraphernalia that may be necessary in order to properly and lawfully conduct the election.

<u>SECTION 5</u>. The City's Finance Director is hereby authorized and directed to appropriate the necessary funds to pay for the City's cost of holding the election.

<u>SECTION 6</u>. Severability. The provisions of this Resolution are severable, and if any provision of this Resolution is held invalid that provision shall be severed from the Resolution and the remainder of this Resolution shall continue in full force and effect and not be affected by such invalidity.

<u>SECTION 7</u>. The City Clerk shall certify to the adoption of this Resolution.

RESOLUTION NO. 9600

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANTA FE SPRINGS, CALIFORNIA REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF LOS ANGELES TO CONSOLIDATE A GENERAL MUNICIPAL ELECTION FOR THE PURPOSE OF ELECTING THREE (3) COUNCILMEMBERS TO BE HELD ON TUESDAY, NOVEMBER 6, 2018 WITH THE STATEWIDE GENERAL ELECTION

WHEREAS, the City Council of the City of Santa Fe Springs called a general municipal election to be held on November 6, 2018 for the purpose of electing three (3) councilmembers; and

WHEREAS, the City desires the general municipal election be consolidated with the statewide general election to be held on the same date and for the County of Los Angeles Registrar of Voters render services related to the election;

WHEREAS, all necessary expenses in performing these services shall be paid by the City of Santa Fe Springs;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SANTA FE SPRINGS, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. The City Council hereby requests consolidation of the general municipal election with the statewide general election to be held on Tuesday, November 6, 2018, for the purpose of electing three (3) councilmembers.

SECTION 2. That pursuant to the provisions of § 10002 of the Elections Code of the State of California, this City Council requests the Board of Supervisors of the County of Los Angeles to permit the County Election Department to prepare and furnish the following for use in conducting the election:

- A listing of county precincts with number of registered voters in each, so city may consolidate election precincts into city voting precincts, and maps of the voting precincts;
- 2. A list of polling places and poll workers the county uses for their elections;
- 3. The voter record of the names and address of all eligible registered voters in the City in order that the City's consultant may:
 - a. Produce labels for vote-by-mail voters;
 - b. Produce labels for voter information guides;
 - c. Print Rosters of Voters and Street Indexes;
- 4. Voter signature verification services as needed;
- 5. Make available to the City election equipment and assistance as needed according to state law;
- 6. All other services necessary to conduct the election.

SECTION 3. That the City shall reimburse the County for services performed

when the work is completed and upon presentation to the City of a properly approved bill.

SECTION 4. That the City Clerk is directed to forward without delay to the Board of Supervisors and to the County Election Department, each a certified copy of this resolution.

SECTION 5. That the City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.

RESOLUTION NO. 9601

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANTA FE SPRINGS, CALIFORNIA ADOPTING REGULATIONS FOR CANDIDATES FOR ELECTIVE OFFICE PERTAINING TO CANDIDATES STATEMENTS SUBMITTED TO THE VOTERS AT AN ELECTION TO BE HELD ON TUESDAY, NOVEMBER 6, 2018

WHEREAS, §13307 of the Elections Code of the State of California provides that the governing body of any local agency adopt regulations pertaining to materials prepared by any candidate for a municipal election, including costs of the candidates statement;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SANTA FE SPRINGS, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. GENERAL PROVISIONS. That pursuant to §13307 of the Elections Code of the State of California, each candidate for elective office to be voted for at an Election to be held in the City of Santa Fe Springs on November 6, 2018 may prepare a candidate's statement on an appropriate form provided by the City Clerk. The statement may include the name, age and occupation of the candidate and a brief description of no more than 200 words of the candidate's education and qualifications expressed by the candidate himself or herself. The statement shall not include party affiliation of the candidate, nor membership or activity in partisan political organizations. The statement shall be filed in the office of the City Clerk at the time the candidate's nomination papers are filed. The statement may be withdrawn, but not changed, during the period for filing nomination papers and until 5:00 p.m. of the next working day after the close of the nomination period.

SECTION 2. FOREIGN LANGUAGE POLICY.

- A. Pursuant to the Federal Voting Rights Act, candidates statements will be translated into all languages required by the County of Los Angeles. The County is required to translate candidate's statements into the following languages: Spanish.
- B. The County will print and mail voter information guides and candidates statements to all voters in Spanish and English or The County will mail separate voter information guides and candidates statements in Spanish and English to only those voters who are on the county voter file as having requested a voter information guide in a particular language. The County will make the voter information guides and candidates statements in the required languages available at all polling places, on the County's website, and in the Election Official's office.

SECTION 3. PAYMENT.

A. Translations (choose one or both):

1. The candidate shall be required to pay for the cost of translating the candidates statement into any <u>required</u> foreign language as specified in A and B *of Section 2 above* pursuant to State law.

B. Printing:

1. The candidate shall be required to pay for the cost of printing the candidates statement in English in the main voter pamphlet.

2. The candidate shall be required to pay for the cost of printing the candidates statement in a foreign language required in (A) of Section 2 above, in the main voter pamphlet.

3. The candidate shall be required to pay for the cost of printing the candidates statement in a foreign language requested by the candidate per (B) of Section 2 above, in the main voter pamphlet.

4. The candidate shall be required to pay for the cost of printing the candidates statement in a foreign language required by (A) of Section 2 above, in the facsimile voter pamphlet.

The City Clerk shall estimate the total cost of printing, handling, translating, and mailing the candidate's statements filed pursuant to this section, including costs incurred as a result of complying with the Voting Rights Act of 1965 (as amended), and require each candidate filing a statement to pay in advance to the local agency his or her estimated pro rata share as a condition of having his or her statement included in the voter's pamphlet. In the event the estimated payment is required, the estimate is just an approximation of the actual cost that varies from one election to another election and may be significantly more or less than the estimate, depending on the actual number of candidates filing statements. Accordingly, the clerk is not bound by the estimate and may, on a pro rata basis, bill the candidate for additional actual expense or refund any excess paid depending on the final actual cost. In the event of underpayment, the clerk may require the candidate to pay the balance of the cost incurred. In the event of overpayment, the clerk shall prorate the excess amount among the candidates and refund the excess amount paid within 30 days of the election.

SECTION 4. MISCELLANEOUS.

- A) All translations shall be provided by professionally-certified translators.
- B) The City Clerk shall allow (bold type) (underlining) (capitalization) (indentations) (bullets) (leading hyphens) to the same extent and manner as allowed in previous City elections.

C) The City Clerk shall comply with all recommendations and standards set forth by the California Secretary of State regarding occupational designations and other matters relating to elections.

SECTION 5. ADDITIONAL MATERIALS. No candidate will be permitted to include additional materials in the *voter information guide*.

SECTION 6. That the City Clerk shall provide each candidate or the candidate's representative a copy of this Resolution at the time nominating petitions are issued.

SECTION 7. That all previous resolutions establishing council policy on payment for candidates statements are repealed.

SECTION 8. That this resolution shall apply at the next ensuing municipal election and at each municipal election after that time.

SECTION 9. That this resolution shall apply only to the election to be held on November 6, 2018and shall then be repealed.

SECTION 10. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.

Sale of Parcel APN 8007- Process and Expenditures

RECOMMENDATIONS

That the City Council Provide Direction Regarding the Potential Sale of City Assessors' Parcel Number (APN) 8007-001-909 (Camp Fire Girl's Parcel) to Rafael Rosalez (Horizon Nursery).

BACKGROUND

In 2013, the City received a default judgement from the Los Angeles County Superior Court granting title to a parcel (APN 8007-001-012) owned by the Camp Fire Los Angeles Area Council, Inc. (Camp Fire Girls). The Court granted the City a default judgement because the Camp Fire Girls had been suspended as a corporation and thereby unable to respond to the City's interest purchasing the parcel. Pursuant to the City receiving title to the former Camp Fire Girls parcel, the Los Angeles County Assessor's Office changed the Assessor's Parcel Number to APN 8007-001-909 (indicating the parcel was tax exempt).

In April, 2015 the City Council approved an Agreement with Horizon Nursery to lease the former Camp Fire Girls parcel (approximately 1.27 acres) so that they may expand their current nursery operations. The rental rate is \$380.00 per month under this Agreement. This rental rate is consistent with SCE's rental rate. The Lease Agreement is for a five (5) year term with the option to renew for an additional five (5) years.

The owners of Horizon Nursery, Mr. and Mrs. Rosalez, are long-time Santa Fe Springs residents. Leasing the vacant parcel removed an isolated vacant parcel as a potential nuisance attraction and reduced risk liability to the City.

Mr. and Mrs. Rosalez communicated to the City their interest in purchasing parcel APN 8007-001-909 to construct a single-family home for their retirement or for their nursery business. Sale of this parcel would require the City to provide a permanent easement to access subject parcel.

Pursuant to City Council request, the following are process and estimated expenditures to execute a purchase and sale agreement for subject parcel:

<u>Approval of Funding for Miscellaneous Concrete Improvement Project FY 2018/19</u> <u>Under the CDBG Co-Op Agreement with the County of LA</u>

RECOMMENDATIONS:

That the City Council take the following actions:

- Approve FY 2018-2019 CDBG Funding in the amount of \$103,000;
- Appropriate \$91,000 from UUT Funding to Miscellaneous Concrete Improvement Project; and
- Conduct Public Hearing on August 23, 2019 at 6:00 p.m. in the City Council, Chambers to Provide for Citizen Review and Comment on the Proposed Project.

BACKGROUND

The City participates in the Los Angeles Urban County Community Development Block Grant (CDBG) program, a U.S. Department of Housing & Urban Development (HUD) entitlement program administered by the County of Los Angeles. Although the funds are an "entitlement," every year, the City must make specific application to the County defining the projects to be funded. The application requires public participation subject to proper notification of at least 30 days. Accordingly, notices will be posted from approximately July 26, 2018 to August 23, 2018, at City Hall, the kiosk at Town Center Hall, the City Library, and the Gus Velasco Neighborhood Center advising the public of this hearing.

The City was allocated \$103,000 for FY 2018-2019 CDBG funds. These funds can be utilized for proposed CDBG projects that meet one of the following three national objectives:

- 1. Benefit low- and moderate-income persons;
- 2. Elimination of slums or blight;
- 3. Meet an urgent need.

Staff recommends that the City Council approve the CDBG funds for Miscellaneous Concrete Improvement Project, including sidewalks, curbs and ADA-compliant ramps primarily north of Telegraph Road, west of Arlee Road, south of Los Nietos Road, and east of Pioneer Boulevard. Staff further recommends that the City Council approve allocating \$91,000 of Utility Users' Tax (UUT) funds to the Miscellaneous Concrete Improvement Project.

A list of the proposed residential street concrete improvements projects is attached for City Council review and approval. The list is based on sidewalk evaluation and survey completed in early 2018. The survey evaluated sidewalk uplift throughout the City. The list represents the most severe uplift conditions of residential streets

primarily north of Telegraph Road, west of Arlee Road, south of Los Nietos Road, and east of Pioneer Boulevard. The list also includes a curb and gutter improvement on Muller Street, an ADA curb ramp improvement on Alburtis Avenue at Fredson Street, and the most severe uplift conditions north of approximately Lakeland Road with Pioneer Boulevard serving as the easterly boundary and the Interstate 605/5 Freeways as the westerly boundary.

FISCAL IMPACT

The CDBG allocation of \$103,000 will positively impact the UUT Fund for CIP projects. The appropriation of \$91,000 of UUT funds will provide cost advantages and economies of scale. The total amount budgeted for this project is \$194,000.

INFRASTRUCTURE IMPACT

The proposed residential street concrete improvements project will provide for the safety and welfare of the residents and enhance the longevity of the City's residential streets as vital assets.

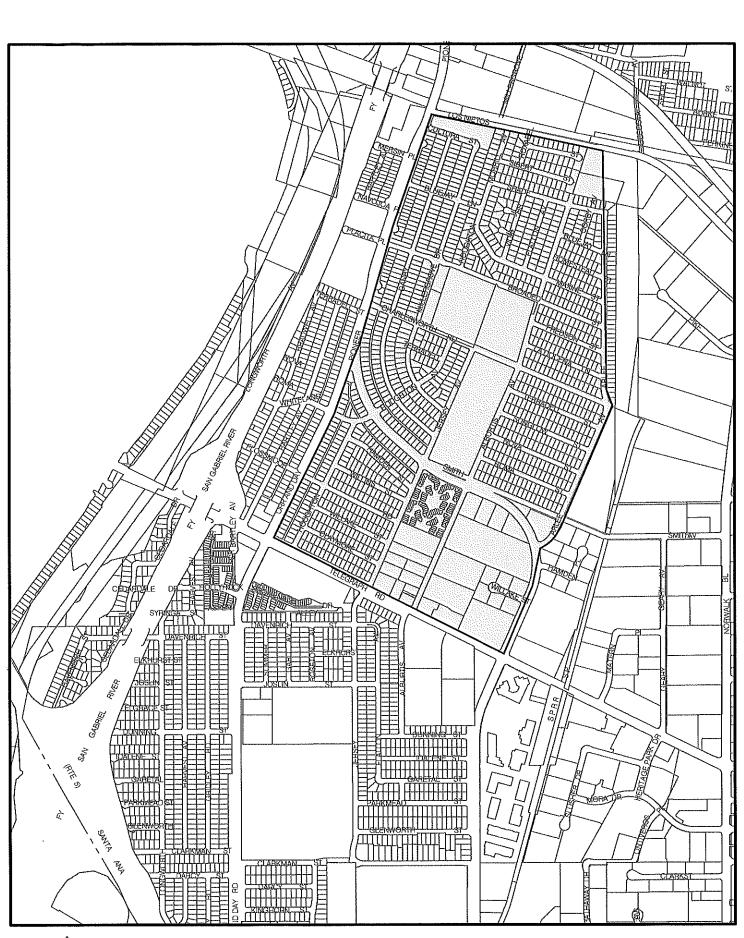
