NEW BUSINESS

Certification of the November 6, 2018 General Municipal Election

RECOMMENDATION: That the City Council:

- Receive and file the Certificate of the Canvass of the Election Returns from the Los Angeles County Registrar-Recorder/County Clerk.
- Waive reading in full and adopt Resolution No. 9612 of the City Council of the City of Santa Fe Springs reciting the fact of the General Municipal Election held on November 6, 2018, declaring the results, and such other matters as provided by law.

BACKGROUND

At its July 26, 2018 regular meeting, the City Council adopted resolutions calling an election to elect three (3) members of the City Council and vote on Measure Y; consolidating the election with the County of Los Angeles on Tuesday, November 6, 2018; and requesting them to conduct the election and canvass the votes. The Los Angeles County Registrar of Voters provided certification and canvass information on December 3, 2018, declaring the results of the election.

Information from the County Registrar pertaining to the November 6, 2018 General Municipal Election indicates the following:

- 5,782 total votes cast for Councilmember Seats
- 1,388 votes cast for Blake Carter for City Council
- 1,254 votes cast for Ralph Aranda for City Council
- 2,692 votes cast for Annette Rodriguez for City Council
- 2,786 votes cast for Juanita Trujillo for City Council
- 1,914 votes cast for John Mora for City Council
- 1,891 votes cast for Jay Sarno for City Council
- 5,781 total votes cast for Measure Y
- 3,962 votes cast for Yes on Measure Y
- 1,285 votes cast for No on Measure Y

FISCAL IMPACT

The County has not yet invoiced the City for election costs. The current budget has funds allocated for this expense.

RESOLUTION NO. 9612

A RESOLUTION OF THE SANTA FE SPRINGS CITY COUNCIL RECITING THE FACTS OF THE GENERAL MUNICIPAL ELECTION HELD IN THE CITY ON NOVEMBER 6, 2018; DECLARING THE RESULTS AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a General Municipal Election was held and conducted in the City of Santa Fe Springs, California, ("City") on Tuesday, November 6, 2018 as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed; and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Election Code of the State of California for the holding of elections in general law cities; and

WHEREAS, the Los Angeles County Registrar-Recorder/County Clerk canvassed the returns of the election and has certified the results to this City Council, and the results are received, attached and made a part hereof as "Exhibit A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SANTA FE SPRINGS, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

Section 1. That the whole number of ballots cast in the City to elect a Councilmember (except vote by mail ballots) was 3,622.

That the whole number of absentee and provisional ballots cast in the City was 2,160, making a total of 5,782 ballots cast in the City.

Section 2. That the names of persons voted for at the election for member of the City Council of the City are as follows:

Blake Carter
Ralph Aranda
Annette Rodriguez
Juanita Trujillo
John Mora
Jay Sarno

That the measure voted upon at the election is as follows:

Measure Y: To maintain quality neighborhoods and effective 911 emergency response services by retaining firefighters, police officers, and paramedics; fixing potholes/streets; maintaining senior services, parks, library services, after school programs, community events, and graffiti removal shall a one cent transactions and

use tax available for general municipal revenue purposes be collected in the City of Santa Fe Springs generating approximately \$12.8 million annually, until ended by voters, requiring annual audits, with all funds controlled locally?

Section 3. That the number of votes given at each precinct and the number of votes given in the City to each of such persons above named for the respective offices for which the persons were candidates are as listed in Exhibit "A" attached.

Section 4. THE CITY COUNCIL DOES DECLARE AND DETERMINE THAT:

Annette Rodriguez was elected as Member of the City Council of the City for the full term of four years.

Juanita Trujillo was elected as Member of the City Council of the City for the full term of four years.

John Mora was elected as Member of the City Council of the City for the full term of four years.

That as a result of the election, a majority of the voters voting on Measure Y did vote in favor of it, and that the measure was carried, and shall be deemed adopted and ratified.

Section 5. The City Clerk shall enter on the records of the City Council of the City a statement of the result of the election.

Section 6. The City Clerk shall enter on the records of the City Council of the City a statement of the results of the election showing:

- (1) The whole number of ballots cast in the City;
- (2) The names of the persons voted for;
- (3) The measure voted upon;
- (4) The office each person was voted for;
- (5) The number of votes given at each precinct to each person and for and against the measure;
- (6) The total number of votes given to each person, and for and against the measure.

Section 7. The City Clerk shall immediately make and deliver to each of such persons so elected a Certificate of Election signed by the City Clerk and duly authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the State Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

Section 8. The City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of Original Resolutions.
