#### MINUTES REGULAR/ TRAFFIC COMMISSION MEETING CITY OF SANTA FE SPRINGS March 16, 2023

#### 1. CALL TO ORDER

Vice Chairperson Miranda called the Traffic Commission meeting to order at 6:00 PM.

#### **NEW BUSINESS**

5. <u>Traffic Bureau Report – January 2023</u>

Recommended action: To receive the report.

Traffic Engineer Consultant Lopez provided the following summary: (25) Property Damage, (23) Injury, and (1) Fatality. There were (2) DUI, (10) CPI, (0) Pedestrians (0) Bicycle and (13) Hit and Run). There were (8) operations at (17) locations yielding (79) Stops, and (73) Citations. The primary collision factors noted were (12) Improper Turning, (9) Right-of-Way Violations, (8) Unsafe Speed, (7) Traffic Signals and Signs, and (6) Other Improper Driving. For the Year-to-Date from 2022 to 2023 there were (33/25) Property Damage, (17/23) Injury and (1/1) Fatalities. Enforcement Citations yielded (164) Moving Citations, (198) Moving Violations, (138) Hazardous Violations, and (487) Parking Citations. The six High Collision Intersections are Florence Avenue/ Norwalk Boulevard (4), Telegraph Road/Greenleaf Avenue (3) Florence Avenue/Bloomfield Avenue (2), Florence Avenue/Pioneer Boulevard (2), Florence Avenue/Orr and Day Road (1), and Telegraph Road/Bloomfield Avenue (1).

#### 6. COMMUNICATIONS

#### Commission

Commissioner Carter inquired about the status of Orr & Day Road at Davenrich Road. Mr. Lopez indicated that for the time being, the focus has been on Pioneer Boulevard and Whiteland Street.

Commissioner Gaitan inquired about the status of the signage for Telegraph Road and Alburtis Avenue. Mr. Lopez indicated that the sign she had previously mentioned would cost \$2,300 and is not a usual sign. He suggested to move the sigh to the signal head, and have it done in a different color for \$167.

#### Staff

Mr. Lopez indicated that the City Council has opted not to install a traffic signal at the intersection of Pioneer Boulevard and Whiteland Street. Noting that a traffic signal pole costs about \$650,000, and there is about two to three month supply delay in addition to the installation. Council is recommending that staff look into the price of stop signs with LEDs and flashing red beacons. However, he noted that staff needs clarification from council to proceed with pricing request. Currently, the approximate installation price for six stop signs at the intersection, would be \$40,000 to \$50,000.

Mr. Lopez provided information regarding a 2022 collision data study on the onset of Daylight Saving Time (DST) done one month prior and one month after DST. The graph reflects no significant changes in collisions.

Ms. De Léon presented slides of current and upcoming Community Services events.
