The Income-Qualified Senior Water Discount Program provides a 15% discount off your water bill, subject to the limitations stated below, if you meet all of the following eligibility requirements and income limits. To apply for this discount, please complete and mail or return this application to the Gus Velasco Neighborhood Center, Human & Family Services, 9255 Pioneer Boulevard, Santa Fe Springs, CA 90670.

**Eligibility Requirements:**

- \* Applicant must be at least 60 years old AND a fulltime resident of the City of Santa Fe Springs.
- \* Applicant's property must be served by the City and the water bill must be in the applicant's name.
- \* Applicant's property must be their permanent primary residence.
- \* Applicant cannot be claimed on another person's income tax return.

The total combined annual gross income of applicant's household, based on the total number of persons who live in the household, must not exceed the following:

1 - 2 Persons	\$ 27,145
3 Persons	\$ 34,180
4 Persons	\$ 41,215
5 Persons	\$ 48,250
6 Persons	\$ 55,285
Each Additional Person	\$ 4,020

The term of the discount will be for two years after approval. At that time, a letter will be mailed to the applicant to recertify the information. This must be done by June 1st of the corresponding year. If the application is not recertified by that date, the discount will be removed.

**Discount Limitations:**

The discount only applies to the first 1,800 cubic feet of water used per month. All water used in excess of 1,800 cubic feet per month will be billed at the normal City water rate.
