Councilman Hinze

 He reported that the Sealy PTA is sponsoring an event on Friday between noon and 3:00 p.m. A HURT's donut truck will be selling donuts in front of Tractor Supply.

Mayor Whitehead

- She said someone has approached her concerning the placement of lighting on the soccer fields.
- She said she has also received a request for the placement of a water fountain by the basketball courts at B&PW Park.
- She asked about the annexation project that was started. Warren Escovy said he will speak to the new city attorney concerning the process. All but two of the non-annexation development agreements have been completed.
- She asked that city staff provide information concerning achievements and future plans for the State of the City report on September 20th.

Councilman Hinze thanked the police chief and department for solving the break-in at the B&PW concession stand. The suspects were identified and placed into custody within hours.
