1. Call to Order

10 Presentation by Enterprise Pipeline, Inc., concerning facility safety and preparedness training and plans.

Representatives of Enterprise Pipeline, Inc., gave a presentation concerning the Sealy facilities safety and preparedness plans and strategies for different emergency situations.

11. Consider and take action regarding the preliminary plat for Palo and Melanie llagen, located on FM 1094 near Oaks Street.

Councilwoman Lerma moved to approve the preliminary plat for Palo and Melanie Ilagen with the planning commission's recommendations. Councilwoman Sullivan seconded the motion. Mayor Whitehead called for the vote:

12. Discussion and possible action regarding the presentation and acceptance of the independent audit performed by Belt Harris Pechacek, LLLP.

Robert Belt with Belt Harris Pechacek, LLLP reviewed the audit with the council. Mr. Belt reported that it was an unmodified report which is the highest level. There was a large increase in the fund balance at the end of the fiscal year. Although there were previous concerns regarding the amount of operating funds on hand in the previous fiscal year, the end of the fiscal year 2018 has greatly improved. He reported a clean audit for the City of Sealy.

13. Quarterly presentation and discussion by Robert Worley, Executive Director of the Sealy Economic Development Corporation.

Robert Worley updated the council on industrial and residential projects being proposed and/or contemplated for Sealy. He reported that the Sealy EDC Business Improvement Grant program is being modified to become the Main Street District Improvement Program. This will be presented to the EDC board and council for approval. Opportunities for training for staff and board members are being researched. He said the city departments and staff he has worked with in Sealy are very professional and skilled.

14. Fire Marshal/IT Staff report and discussion.

Joey Schmidt, Fire Marshal/It, provided an update concerning on-going and proposed projects in his department. He reported that the Windows software will have to be updated throughout the city departments on the computers not being replaced this year. He also reported that the telephone system will need to be updated by the end of 2020.

15. Consider and take action regarding the variance granted to Sealy ISD by City Council for a time extension until January 31, 2020 to pave the parking area for the football stadium area as required by City Code.

Warren Escovy asked that the item be tabled to allow additional time to speak with school staff.

18. Annexation Fees – discussion and possible action to establish fees for voluntary annexations and direct City Staff to prepare an ordinance for consideration and adoption.

Chris Nichols explained to council that there are costs to the city with voluntary annexations. Setting a fee will be to recoup the cost associated with the annexation. He will move forward using the current voluntary annexation to determine a fair and equitable fee for the process.

19. Discussion and possible action to allow Jose Chavez the use of the City Facilities at B&PW Park for a youth soccer camp.

Jose Chavez told the council that he would like to use the soccer fields at B&PW Park to hold a soccer camp for children. It will be free of charge.

Councilwoman Lerma moved to allow use of the soccer fields for a youth camp on Tuesdays and Thursdays from 5:30 p.m., to 7:00 p.m. Councilman Noack seconded the motion. Mayor Whitehead called for the vote:

Consideration and possible action to call two (2) public hearings before the City Council of the City of Sealy, Texas, on June 11, 2019 at 6:00 p.m. and on June 11, 2019 at 6:30 p.m. at City Hall, 415 Main Street, Sealy, Austin County, Texas to hear any and all persons desiring to be heard on or in connection with any matter or question involving the proposed voluntary annexation into the City of Sealy, Texas of an approximate 45.11-acre tract of land situated in the Austin County located near the intersection of Rice Field Road and FM 3013 and that portion of FM 3013 running adjacent to the tract proposed for annexation as may be necessary to comply with state law contiguity requirements.
