4. Discussion and possible action to approve an ordinance adopting the City of Sealy, Texas budget for the fiscal year 2019-2020.

(Per the City of Sealy Home Rule Charter, Section 3.12. (1) Procedure to Enact Legislation, and Section 7.02.E. Adoption, only one reading is required for final passage of this ordinance. A record vote will be taken.)

Councilwoman Lerma moved to approve the 2019 maintenance and operations property tax rate of 19.310 cents per \$100 valuation. Councilwoman Sullivan seconded the motion. Mayor Whitehead called for the vote:
