- He'd like to have a discussion with the Parks Department, Parks Board and Council regarding the lights from the Cryan Park walkway to the pool area. He'd also like to address the track and other unlighted areas.

- He inquired about the city's status on zoning. Warren Escovy stated that he will provide an update at the October 15<sup>th</sup> council meeting.
