# 9. Presentation and discussion regarding House Bill 866.

Public Works Director Mark Pulos gave an update on House Bill 866, which requires the replacement of certain types of natural gas lines. Fortunately, the City of Sealy has neither cast iron gas lines nor bare steel mains in the system. Mr. Pulos estimates that 143 risers will need to be replaced. He stated that there is a 12 ½ year turnaround to have them replaced, but he hopes to have this completed within the next two-three years. Each replacement is going to cost approximately \$400.

# 14. Presentation, discussion, and possible action regarding annexation laws, changes in the law, and processes and procedures on same.

City Attorney Tim Kirwin updated the council on annexation laws, changes in the law, and processes and procedures on same. Mr. Kirwin stated that a new Legislative bill was passed earlier this year, and home rule cities are no longer able to annex property without first being asked to do so. Although this new law limits a city's ability to annex the way it wants to, it does not mean that every annexation request has to be accepted.

Me. Kirwin also cautioned the council that if they annex a Municipal Utility District (MUD), that the MUD dissolves and any debt it holds becomes the responsibility of the city. He said if a developer wants to create a MUD, it is best to annex the property first and then have the MUD created within the city so the rest of the residents are not liable for its debts.

# 15. Presentation, discussion, and possible action regarding LGI Homes annexation petition.

Assistant City Manager/Planning Director Warren Escovy informed council that the developers of a proposed 440-home development off Schmidt Road near the Walmart Distribution Center have changed their request to develop the property as a Municipal Utility District (MUD) rather than a Public Improvement District (PID).

He stated that there is a total of four parcels that make up 157 acres. Two of these parcels are located outside of the city limits. Mr. Escovy said that LGI Homes has already submitted a petition for the annexation of the additional two parcels.

No action was taken at this time.

# 16. Discussion and possible action to approve the purchase and placement of the Mark A. Chapman dedication plaque at B&PW Park.
