#### 4. Proclamations and Special Recognitions

### 5. Petition(s) and/or Request(s) from the Public.

Carolyn Bilski, Nick Tirey, Diane Wuthrich and Roxanne Saldana spoke in opposition of the Sealy Oaks Apartments that will be located at approximately 1457 South Circle Drive. They addressed their concerns regarding drainage, potential crime, and limited parking. These citizens feel as though Sealy's management is too aggressive.

Joe Mora, the developer for Sealy Oaks Apartments, explained that professional plans were devised by engineers. He said he is invested in Sealy because he owns seven local properties and paid over \$20,000 in property taxes last year. He admitted that there can be crime in apartments, but stated there is crime in neighborhoods as well. He feels as though some citizens are making false statements and being unfair.

## 11. Discussion and possible action to review the City's restaurant inspection policy. (Noack)

Building Official Chrissy McGee informed council that the City conducts health inspections for 62 locations biannually. She explained how and why staff performs the inspections. If the City wants more inspections, additional staff will be required. She proposed implementing a "restaurant of the month" incentive/recognition.

City Attorney Tim Kirwin suggested that some cities give their restaurants a grade/rating, and the owners are required to post their ratings on the doors of their establishments.

### Discussion and possible action to approve or deny a variance request by Sealy ISD regarding parking lot material.

Sealy citizen Nick Tirey expressed his belief that Sealy ISD has had ample time (approximately three years) to pave the parking lot. He stated the ordinance was created for beautification; the parking lot was designed to be paved, and the funds are present; therefore, he thinks council should require the school to fulfill their commitment.

## 13. Discussion and possible action regarding potential park facility openings.

Lawrence Siska, Director of Parks/Streets/Drainage, informed council that all City-owned halls will remain closed throughout the month of June, and this topic will be revisited in July. Restrooms at Levine Park, B&PW Park, and Scranton Park will also remain closed until further notice. Ball games at B&PW Park can resume on Monday, June 15<sup>th</sup>.

## 14. Discussion and possible action regarding animal control facility. (Sullivan)

Police Chief Jay Reeves and Public Works Director Mark Pulos proposed building a more suitable animal shelter on the opposite side of the existing parking lot. A change in location will work better with the drainage. Chief Reeves expressed a need to provide better conditions than what currently exist, while maintaining a low cost to do so. He said he plans on meeting with a contactor next week and will present the quotes to council at the next meeting.

### Councilwoman Lerma

- She requested an update from staff on the stoplight in front of Chicken Express, as well as the stoplight at Highway 90 and South Circle Drive.
- She wants council to be informed of new development when new plans are submitted.
- She'd like an update from staff on the status of Allen's Creek clean-out and widening.
- She requested regular updates on the status of delinquent HOT taxes for Rooms 4 Rent.
- She requested to see council reports on health inspections.
- She'd like to see a "restaurant of the month" program be implemented.
- She requested an ordinance regarding the restaurant rating posting.
- She requested a future agenda item regarding the zoning project update.

#### Councilman Noack

- He said if a time limit is set at the meetings, he wants to make sure it's enforced.
- He requested a copy of the current health inspection ordinance.
- He asked council to brainstorm ideas on how the City can get better information out to the public. He wants to make sure citizens' expectations of council are accurate.

### Councilwoman Vrablec

- She requested a copy of the newest ordinance on the health department.
- She requested an executive session to discuss the planning commission and planning department.

### Councilwoman Sullivan

- She requested a full report on the Sealy Oaks Apartments.
- She requested a future agenda item to discuss staff recommendations for adjusting the budget to account for the loss of revenue due to the COVID-19 pandemic.
- She stated that the city manager was to inquire with the International City Manager's Association for ideas on goals and objectives to build upon. She requested an agenda item to start working on this.

#### Councilman Koy

- He requested a future agenda item to review, change, and/or replace parts of Ordinance No. 2004-05 (the Municipal Drainage Utility System).
- He requested a future agenda item to discuss plans for Sealybration.
- He requested a future agenda item to engineer, bid, and construct drainage channel along Allen's Creek between Rexville Road and the I-10 Feeder Road.

- He requested a future agenda item to discuss halting any construction between Hwy 90 and the I-10 Feeder and from Hwy 36 to Miller Road.
- He wants staff to apply for grants from the federal government to fund employees' salaries during the time period they were not at work due to the COVID-19 pandemic.
- He would like staff to verify whether or not TLD Ramp has water, sewer, gas, and/or electric power. He said a trailer has been sitting on the property since December.
- He inquired about the proposed detention pond at Dove Landing.
- He said there is a pothole in the road at 715 Front Street.

### Councilman Burttschell

- He would like staff to provide council with information on the Sealy Oaks Apartment complex, perhaps the information that the Planning Commission received at their previous meeting.
- He reiterated the importance of attendance at City board meetings.
- He wants to know if the City has received any profit/loss information from local hotels.

### Mayor Whitehead

- She would like to see budget amendments as soon as possible.
- She said the city manager received information on performance review evaluations. Councilmembers can let her know if they would like to receive the information.

## 21. EXECUTIVE SESSION: A closed meeting will be held concerning the following item(s):
