5. Petition(s) and/or Request(s) from the Public.

Ronnie Smith spoke in opposition of a variance request at 405 Gebhardt Road. He believes variances should only be issued for hardship cases. He provided the city secretary with a petition that was signed by himself and neighbors.

Felicitia Fernandez said she is in agreeance with Mr. Smith. She is concerned about the number of variances that have been approved.

6. CONSENT AGENDA

- a) Discussion and possible action regarding approval of minutes for the meetings held:
 - November 9, 2020- Special Meeting

Councilwoman Sullivan moved to approve the consent agenda as presented. Councilwoman Vrablec seconded the motion. Mayor Bilski called for the vote:

7. Presentation, discussion, and possible action by Sealy Community Foundation regarding COVID-19 and other health and safety protocols for Fantasy of Lights events.

Melanie Willingham updated council on Sealy Community Foundation's plan of action regarding health and safety protocols for Fantasy of Lights events. She said there will be hand sanitization stations, individuals will be asked to practice social distancing, and vendors will have hand sanitizer as well.

Mayor Bilski and Councilwoman Vrablec expressed their concerns about the number of people allowed in the Hill Community Center for the cookoff. Mayor Bilski said the judging would be best if done outdoors. Melanie Willingham said that is not possible, but the judges can easily be spread out inside of the building.

There was brief discussion about potentially rerouting the parade; however, Mrs. Willingham informed council that the route needs approval by the State. Police Chief Jay Reeves has already been granted approval for the current route. The officers are maxed out with the traditional route, according to Police Captain Scott Riske. The proposed new route would require 8 additional officers.

Councilwoman Lerma acknowledged that there is no face mask mandate; however, she would like to come up with a way to encourage people to wear face masks in the crowd.

Councilwoman Sullivan suggested getting word out on Facebook and the Sealy News asking people to go to areas that are less crowded. She also asked if free masks will be provided. Melanie Willingham said she can make that happen, if that is what council wants.

Councilman Koy suggested forming a small committee of councilmembers/Sealy Community Foundation members and coming up with ideas to present to council on December 1st. He said a decision can be made at that time.

Councilwoman Lerma will work with Melanie Willingham on coming up with a plan.

No formal action was taken.

Steven Kutra provided a presentation regarding the financial report, and council informed him that they would like to see reports on a more frequent basis.

Engineer Llarence Turner with Kaluza Inc. and developer Scott Lease with Campbell Garrett Distinctive Homes & Estates, LP provided council with information regarding a prospective development, known as Cane Belt Estates.
