7. Presentation, discussion and possible action regarding EMS service providers.

Walter Morrow with Austin County EMS provided council with an update regarding EMS-related activities. He said they are currently addressing approximately 4,000 calls per year and 60 percent of those calls are filtered to the Sealy area. On average, their response time is less than four minutes.

He said alternative EMS providers frequently request to provide services in the County; however, after speaking with Judge Tim Lapham, the County feels as though there is already sufficient EMS coverage in the area. The County has made the decision to deny approval of any third-party requests. Regardless, Mr. Morrow said these agencies still have the right to open their businesses after two years of being denied.

City Attorney Tim Kirwin said the City received a request from Merlin EMS to provide additional services in the City. He explained there are state law requirements that this agency does not meet.

Councilwoman Johnson moved to deny the request from Merlin EMS because it does not meet state law requirements. Councilwoman Vrablec seconded the motion. Mayor Bilski called for the vote:

Tax Code Sec. 312.201(d); and

The City Council finds that the designation of the reinvestment zone is reasonably likely to contribute to the retention or expansion of primary employment or to attract major investment in such reinvestment zone that will be a benefit to the property and will contribute to the economic development of the City of Sealy pursuant to Tex. Tax Code Section 312.202(a)(6).

(This is the second of two readings).
