12. Discussion and possible action regarding the proposed property tax rate.

Staff proposed a property tax rate of \$0.27133/\$100, which is an 8 percent increase.

Councilwoman Lerma moved to increase the proposed property tax rate by 8 percent, provided that additional budget cuts will be made. The motion failed for lack of a second motion.

Mayor Bilski moved to increase the proposed property tax rate by 5 percent (\$0.26575/\$100) and wants the money get put away for emergency use and as good of a fund balance that can be restricted by law based on our auditor's advice. Councilman Noack seconded the motion. Mayor Bilski called for the vote:

The motion carried.

13. Discussion and possible action regarding adopting culvert installation fees.

Warren Escovy recommended approval of a \$500 fee for culvert installation when a driveway is 20 feet and a \$700 fee for culvert installation when a driveway is 30 feet. The cost for materials will be an additional fee.
