ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the City of Sedro-Woolley for the period from January 1, 2009, through December 31, 2009.

We evaluated internal controls and performed audit procedures on the activities of the City. We also determined whether the City complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Open Public Meetings Act
- Conflict of interest
- Ability to meet current and future operations
- Disbursement internal controls

- Investments
- Procurement/bid law
- Safeguarding of assets
- Payroll
- Cemetery Department review

RESULTS

In the areas we examined, the City's internal controls were adequate to safeguard public assets. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

ABOUT THE CITY

The City of Sedro-Woolley, incorporated in 1898, currently serves approximately 10,030 citizens in Skagit County. The City provides services including police, fire, building inspection, general administration, stormwater, wastewater treatment, solid waste disposal, legal administration, library, street construction and maintenance, parks and a cemetery.

An elected, seven-member Council and an independently elected Mayor govern the City. The Council appoints management to oversee the City's daily operations as well as its 60 employees. For fiscal year 2009, the City operated on an annual general fund budget of approximately \$4.2 million.

We audit the City every year. In 2003, we reported a finding for inadequate internal controls over the Municipal Court. This finding was resolved in 2004. There have been no findings in the last five audits and we believe this reflects the City's desire and commitment to maintain a strong financial system.
