To apply for a SEVIER COUNTY Business License, the business must reside in Sevier County. Sevier County Business License fee is \$15.00 (credit card fees may apply). All businesses within city limits must apply and maintain current licenses with BOTH the County and the City. Please review the following information before applying:

Choose between a minimal or standard business license

- *Minimal Business License (gross sales of \$3,001 to \$99,999)*
- *Standard Business License (gross sales over \$100,000)*
- Choose the "Type of Ownership":
 - Sole Proprietorship
 - Marital Joint
 - Estate or Trust
 - Partnership
 - Limited Liability Company
 - Multi-Member LLC
 - Single Member LLC
 - Corporation
- To apply you will need the following information
 - Business name, Business address, Business telephone number
 - Owner's name(s), home address, home telephone number, social security number (ITIN number accepted in place of social security number)
 - If business is registered as a Corporation or LLC you will have to list your FEIN number provided by the Internal Revenue Service on your application
 - Name of person(s) or company owning the personal property (equipment, etc.)
 - Signature of each owner
- All Businesses within City Limits MUST apply and maintain current license with BOTH THE COUNTY & CITY
- Business license application cannot be processed before 90 days prior to opening business date
