Director Valentine presented the monthly report from the Sevier County Ambulance Service. The Seymour station is finishing up and they should move out of the temporary location at The King's Academy the first week of July.

Director Ayers presented the monthly report from the Sevier County Emergency Management Agency. Director Ayers also updated the Committee on the joint partnership with the Cities for the new Flood Activation System and that the recently purchased Mobile Command Vehicle should be operational in the next few months.

Sheriff Hodges presented the monthly report from the Sevier County Sheriff's Office. SCSO will be providing an SRO at Trula Lawson this coming school year and have applied for a 100% grant for 2 SRO positions. Mayor Waters asked about SROs in private schools in the county. Sheriff Hodges said there have been talks with a few of the private schools about entering into a contract with the Sheriff's Office to provide those services.

Mayor Waters informed the Committee of the discussion in Intergovernmental Committee concerning the proposed Fire Code and Life Safety fee schedule. There will be a meeting the week of June 19th to discuss again.
