

**AN ORDINANCE CREATING SECTION 5.075, CAMPING PROHIBITED, AND
REPEALING AND RECREATING 9.06, MOTOR VEHICLES PROHIBITED,
OF THE MUNICIPAL CODE OF THE TOWN OF SHEBOYGAN**

WHEREAS, pursuant to Wis. Stat. §§ 60.10(2)(c), 60.22(3) and 61.34, the Town of Sheboygan is authorized to enact parking regulations to promote the public health, safety and general welfare of the Town and its residents; and

NOW, THEREFORE, the Town Board of the Town of Sheboygan does ordain as follows:

Section 1. Creating Code. The Municipal Code of the Town of Sheboygan, more particularly Section 5.075 thereof, is hereby created to read as follows:

"5.075 Camping Prohibited.

- (1) Except as approved by the Town Board, no person shall camp or maintain a campsite, tent or recreational vehicle, motor home, motor vehicle, trailer, vehicle, or camping trailer, whether self-propelled or not, or camp on any road, street or property owned, leased, maintained or controlled by the Town. Such property shall include but not be limited to Town streets, parks or municipal parking lots.
- (2) The following definitions, including amendments, are hereby adopted and incorporated herein by reference:
 - (a) Camping Trailer as defined by Wis. Stat. § 340.01(6m).
 - (b) Motor Home as defined by Wis. Stat. § 340.01(33m).
 - (c) Motor Vehicle as defined by Wis. Stat. § 340.01(35).
 - (d) Recreational Vehicle as defined by Wis. Stat. § 340.01(48r).
 - (e) Trailer as defined by Wis. Stat. § 340.01(71).
 - (f) Vehicle as defined by Wis. Stat. § 340.01(74).
- (3) Penalty -

Any person who shall violate or cause to be violated any provision of this section shall upon conviction thereof be penalized as provided in Section 11.04(1) of this Code. A separate offense shall be deemed committed on each day and for each vehicle on which a violation of any provision of this section occurs or continues."

Section 2. Repealing and Recreating Code. The Municipal Code of the Town of Sheboygan, more particularly Section 9.06 thereof, is hereby repealed and recreated to read as follows:

"9.06 Camping Prohibited. Camping is prohibited in Town parks as provided in Section 5.075 of this Code."

Section 3. Severability. Should any portion of this Ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder shall not be affected.

Section 4. Effective Date. This Ordinance shall take effect upon enactment and publication as required by law.
