#### Chairperson Dan Hein's Letter

1. On June 15th, 2022, around 8:00 PM, a devastating storm hit the east side of Sheboygan and the Town of Sheboygan. According to the National Weather Service, straight line winds in excess of 70 miles per hour created a swath of wind damage. Trees fell on homes and in streets causing thousands of dollars of damage. We estimate that the cleanup costs for the Town exceeded \$200,000. We will be applying for disaster aid from the State of Wisconsin once all the final numbers are received. I want to thank The Sheboygan County Highway Department for the great job they did in assisting our Department of Public Works crew in the cleanup efforts. I also want to give a sincere thank you to our crew, Tom Holtan, Tod Holfeltz, Nathan Luedtke, Tracy Messner, Damian Nevers, Steve Norton, James Reinhardt, Joe Winscher, and John Witters. I also want to thank our Town of Sheboygan Fire Department and EMS and the Howards Grove Fire Department, who were out most of the night. Our Town Officer Mark Heronymus was also directing traffic until the early morning. The first night of the storm our crew worked past 3:00 AM opening streets, cutting trees off power lines, and helping our residents open driveways. In some cases, trees were removed from homes, especially on LS. Our crew worked on cleaning up debris for two months. We are so proud of our crew. Several residents who experienced storm damage have also expressed their appreciation in the professionalism of our team. Thank you to all who helped us recover from this disaster.

#### 2. Construction Updates:

- Olive Garden is in the process of finalizing all permits, with construction of the building in Spring of 2023. Road construction and utilities will start this Fall. The location is west of Hardee's and north of Texas Roadhouse.
- Biggby coffee on Hwy 42 is expected to be completed by the end of Fall.
- Home2 suites by Hilton, a 93-room hotel on the North Town Development is expected start of construction in the Spring of 2023.
- Van Horn/North Town development infrastructure continues to be work in process. Two apartment buildings with commercial buildings are expected to start construction in Spring of 2023.
- Miesfeld's Triangle Market is adding an additional smokehouse.

- Maywood Estates LLC, Maywood Estates Subdivision will be starting infrastructure in the Spring of 2023 with home construction starting in the Summer of 2023.
- Pine Hills Country Club has started an addition/remodel, which includes a new pool.
- Ashford Place Apartments has started construction of four new apartment buildings on Playbird Road.
- Club carwash is anticipating to build in the Walmart development area off Vanguard and Hwy. 42
- 3. The Town Board approved \$25,000.00 to help fund Uptown Social Senior Center. Uptown Social is located at 1817 North 8th Street in Sheboygan, WI. Planned opening date is November 15th, 2022. All Town residents will be able to use the facility.
- 4. The Town of Sheboygan Park Shelter, 3805 County Road Y had a new concrete floor installed recently. The previous floor had drainage issues and had sunk over two inches. The floor is now to grade and the drainage issues in the shelter have been resolved.
- 5. In our April newsletter, I had indicated that our new website would be ready in one month. The board decided to hire a General Code to review our ordinances which consists of editorial and legal analysis. This has caused a delay in rolling out the new website. We also decided to allow bill paying through our web using credit and debit cards. The updating of our ordinances is still not complete and our online bill pay will not be ready until after the first of the new year. We decided to go live with our new website without the ordinance update and bill paying. Ordinances still will be on the site, but may have updates and changes when the codification process is complete.
- 6. The Town hired a new Administrative Assistant, Keri Grimmer. Please welcome Keri in her new position when visiting the Town hall. The Town has also hired a new part-time Ordinance Enforcement Officer, Steve Wimmer. Steve currently works as a Deputy for the Sheboygan Sheriff's Office. Please welcome Steve to the Town in his new position.
- 7. On Saturday, December 10th, 2022, between the hours of 10:00 a.m.and 12:00 p.m. we are having an open house in our Sheboygan Town Hall and Community Center. Our address is 4020 Technology Parkway, located north of Lake Country Academy School. Cookies and beverages will be provided as well as guided tours of our facility. Please plan to attend the open house to become more familiarized with your new Town Hall and Community Center.
- 8. Regarding the 2023 budget, we are proposing no increase in for the Town's portion on the tax levy. Our team has worked very hard to ensure we are providing excellent service to our residents while making sure our levy does not increase. Thank you to Steve Corbeille, our Financial Consultant, Jamie Hilbelink, and Peggy Fischer for the great job they did in preparing the 2023 budget.
- 9. In closing, I would like to thank our Town Board Supervisors, Jim Schwinn, Tim Winkel, Pat Schmidt, and Brad Lambrecht for their dedication to the Town. Thank you to all our members on the Sanitary Districts, Plan Commission, Park Committee, and Board of Zoning for the great job they do. A huge thank you to all the Town employees who do a great job throughout the year. Thank you to all our residents for the privilege of serving you.

# DOG LICENSING 🐶

Dog Licenses expire December 31st of each year. Licenses obtained after March 31st will be charged a \$20 late fee in addition to the license fee of \$10 for neutered or sprayed dogs and \$20 for unaltered dogs. You must bring an unexpired rabies certificate in order to obtain a dog licenses. Please remember, as a dog owner, you have the responsibility to license, vaccinate, keep control and pick up after your dog. Violation of any of the above can result in fines.

### **PROPERTY TAX PAYMENTS**

Payments for taxes can be made at the Town Hall office, 4020 Technology Parkway, until January 31st, 2023 by check only. The Town Hall office cannot accept cash. You can make cash payments at any of the following Wisconsin Bank and Trust Locations:

Overpayments made at the Town Hall office will have refund checks mailed within two weeks.

**Burning Hours and Burn Barrels:** Fall is here and so are the leaves. No person shall burn any wood, grass, leaves, rubbish or other combustible material upon the streets of the Town at any time, nor shall any person burn any wood, grass, leaves, rubbish or other combustible material upon any lot or lands located in the Town, except between the hours of 4 pm and 9 pm of each day, but at no time shall a fire be built within fifty feet (50') of any structure, building or pile of lumber, nor shall the smoke or heat aided by such combustion be an annoyance or discomfort to the neighborhood or traveling public, except recreational fires shall not be located within twenty-five feet (25') of a structure or combustible material unless contained in an approved manner and are specifically excluded from the time limitations set forth in this Ordinance.

# **SNOW PLOW ETIQUETTE**

Snow Emergencies: If a snow emergency is declared, it will be posted on our website and local media will be notified. There is no parking on any Town roads at any time during a snow emergency.

Snowplow Markers: Snowplow markers are NOT allowed within two feet of the pavements edge. Markers within two feet of the pavement will be removed!

Please stay back 500' from the snowplows! They are unable to see you due to the blowing snow!

Do not shovel or blow snow into the road: Per WI State Statutes, it is illegal to place snow in the roadway when cleaning your driveway. Please be courteous and help keep our roads clear!

Garbage containers must stay in your driveway: Please do not put your garbage containers in the road. You can be fined for having items in the roadway.

# **SANITARY DISTRICTS 2 (WATER) & 3 (SEWER)**

Please remember: NO WIPES DOWN THE PIPES. Even if a product says it is flushable, it should not be flushed. Unless it is toilet paper, it should not be flushed.

#### ALL OF THESE ITEMS NEED TO GO IN THE TRASH CAN:

Diapers, flushable, disposable, cleaning or baby wipes, paper towels, cloth towels, feminine hygiene products, and facial tissues.

Putting theses items down toilets may plug sewers and cause raw sewage to back up into your home!

#### **Sump Pumps**

When was the last time you checked your sump pump? Your sump pump can be your basement's best friend, or it can be the Town sanitary sewer system's enemy, or both! If your sump pump is large enough to operate properly during heavy rains and is being discharged appropriately to your yard or storm sewer, then it is helping to reduce basement backups and surcharging the sanitary sewer system. However, if your sump pump can't keep up with the flow of water during heavy rains or if the sump pump is illegally routed to your laundry tub or sanitary sewer pipes, then it is everyone's enemy.

Undersized and/or illegally connected sump pumps can overfill the Town's sanitary system considerably increasing the risk of causing basement backups of raw sewage into homes. Did you know the Town also has to pay to handle the millions of gallons of excess rainwater in the sanitary system annually? The unnecessary amount of water increases operational costs and puts strain on the sanitary sewer equipment. Ultimately at the cost to you, the Town resident.

By checking your sump pump, you can reduce the potential for a wet basement in the future and help keep your neighbor's dry as well. With spring rains coming, now is a great time to check before the rains hit and it is too late.

Water hardness in the Town is 23 grains per gallon. This number is used to calibrate your water softener. Hard water is caused by elevated levels of calcium and magnesium that water collects as it journeys from rain to underground aquifers and is a natural result of the hydrologic cycle.

#### **Garbage Pick-Up Rules**

- Your cart should be within 18 inches of the curb with the arrows on the lid pointing to the street/curb. Carts
  cannot be placed on the street. If there is snow, please clear an area in the terrace, or leave the carts at the end
  of your driveway.
- To avoid damage to property, place the cart at least three feet away from mailboxes, lampposts and other fixed objects.
- Place your cart on as level a surface as possible, but away from low hanging tree branches.
- Place carts at least three feet away from each other.
- Close lids prior to pick-up. Lids should be closed on the carts for driver identification and in order to stop material from spilling or blowing away.
- Carts not properly placed will be tagged and not picked up.
