NEW BUSINESS – ENDEAVOR FITNESS

Carmine Avantini met with the applicants and discussed the future potential for Huntington Square. Avantini explained the proposed façade may set the tone for future improvements to the center adding that the applicants will repair and reuse the existing brick columns on the entire building. Hardy Plank, aluminum louvers and some EFIS at the top as an accent material. The variety of materials will give a more modern image to the center. The only lighting change will be the addition of wall sconces to the brick pillars of the façade. The applicant indicated that lights from the windows on the façade will help provide additional illumination to the parking lot. Manufacture detail sheets will have to be submitted for all new light fixtures, for administrative review and approval. The plan indicated that the striped parking lot islands closest to the building will be replaced with landscaped islands containing eight (8) Bradford Pear trees as well as other landscaping enhancements. The parking lot will be patched, re-sealed and striped to provide a fresh look.

Avantini is recommending approval for endeavor fitness conditioned upon compliance of Andy Gerecke, Building Official email dated 05/16/2013.
