2. Pledge of allegiance

4. Minutes of the January 27, 2022 meeting were read. Debra Maryyanek made a motion to approve the minutes. Robert Titus seconded the motion. All voted in favor.
5. Public Comment: None.

6. Update on social media:

- a. Robert Titus has put an ad into the Northeast Magazine regarding Veterans submitting their names for inclusion on the Wall of Honor
- b. The committee will be posting requests for DD 214 submissions on facebook.

7. Update on fund raising and account information:

- a. Elizabeth Dunay provided an update on the current status of funds. As of December 31, 2021, our account has a balance of \$22,421.59. The January 2022 bank statement was not available at the time of the meeting.
- b. Deb Maryyanek spoke about holding a lasagna dinner on May 14, 2022 as a fundraiser. The committee will discuss this event at the next meeting.

8. Review of Wall of Honor submissions:

- a. Bob Titus verified information for five names that were submitted to him at the last meeting.

- b. Liz Dunay discussed three names that were discussed at previous meetings:

- (1) Douglas Migliosi
- (2) Conrad Chenard
- (3) Arthur Mikulski

Liz Dunay was able to verify information for Douglas Migliosi but not for Chenard and Mikulski.

Deb Maryyanek made a motion to include the Zachary Waitkus and Douglas Migliosi on the Wall of Honor, Phase 4. Bob Titus seconded the motion. All voted in favor.

- c. The committee discussed including names of Civil War and Revolutionary War veterans on the Wall of Honor, Phase 4. Liz Dunay has already started researching names of these soldiers and will get documentation to verify their service.

John Whetton made a motion to collect names from the Revolutionary and Civil Wars but discuss their placement on the Wall at a later date. Chris Paradiso seconded the motion. All voted in favor.

9. Old business: The group discussed purchasing bricks from Bricks are Us. Cost will be \$28 per brick. The inscription will be included in the cost with up to three lines per brick. We will use the form from Bricks are Us for patrons to submit their inscriptions.

10. New business: Rich Shaffer discussed purchasing the stone for Phase 4. Mark Boucher presented detailed information about the stone to include type of stone, size, shape, and placement of the names on the stone. Rich Shaffer stated that the approximate cost of the stone, if purchased now, will be \$4,400. The group tabled will finalize the details regarding the stone purchase at the upcoming March 24, 2022 meeting. A final vote will be conducted at that time.
