First Selectman Mary Mitta called the Special Town Meeting to order at 6:30 pm in the Veteran's Meeting Room of the Charles Warren Memorial Town Hall. Approximately ten electors and those eligible to vote in Town Meetings attended. First Selectman Mitta led the assemblage in the recitation of the Pledge of Allegiance.

Beth DaDalt nominated John Locke Sr. as Moderator of the Town Meeting. Richard Hartenstein Jr. seconded the motion. After a voice vote, John Locke Sr. was named Moderator of the Town Meeting.

Beth DaDalt made a motion to waive the reading of the call of the meeting duly posted in the Office of the Town Clerk on May 30, 2019, and posted in the Journal Inquirer on May 31, 2019. Richard Hartenstein Jr. seconded the motion. After a voice vote, Moderator Locke declared the motion approved.

Theda Moore proposed the following motion:

**“I move that the Town of Stafford elect Michael Delano Trustee to the Annette Hyde Colton Fund.”**

Beth Dadalt seconded the motion. After a voice vote, Moderator Locke declared the motion approved.

Gary Moore proposed the following motion:

**“I move that the Town of Stafford appoint Christina Algozzini Spallacci to the Hyde Park Commission.”**

Beth DaDalt seconded the motion. After a voice vote, Moderator Locke declared the motion approved.

Alex Moore proposed the following motion:

**“I move that the Town of Stafford approve a transfer of \$28, 800.00 from Account # 20-320-4855 to Account # 20-245-8600 for the Ambulance Lease Payment.”**

Brandon Moore seconded the motion. After a voice vote, Moderator Locke declared the motion approved.

Alex Moore proposed the following motion:

**“I move that the Town of Stafford approve a transfer of \$211,295.00 from Line Item # 20-03-030-310 to the Town Improvement Fund.”**

Gary Moore seconded the motion. After a voice vote, Moderator Locke declared the motion approved.

Richard Hartenstein Jr. proposed the following motion:

**“I move that the Town of Stafford adopt an Ordinance setting the Hours of Voting at Referendum from 6:00am to 8:00 pm with the following language:**

**It is hereby approved and resolved as follows: Whenever the Town of Stafford holds a referendum on any matter that is properly before the Town’s legislative body, the polls shall be open for voting at said referendum from 6:00 am to 8:00 pm at a polling place to be designated by the Board of Selectmen.”**

Beth DaDalt seconded the motion. After a voice vote, Moderator Locke declared the motion approved.


Richard Hartenstein, Jr. proposed the following motion:
