RE: Items/Materials Prohibited from Discharge into Sanitary Sewers

Most sewer users are well aware of what they can and cannot put into the sewer system. We sincerely thank those of you who are diligent for your cooperation. To those who are unaware this letter is intended to educate you and request your help so that we can keep Stafford's sewer system flowing smoothly.

The following items should not be introduced into the public sewer system, either directly or through a kitchen waste disposal unit:

Aquarium Gravel/Sand/Stone Disposable Toilet Bowl Scrubbers Plastic Bags/Objects
Bones Egg Shells Prophylactics/Condoms
Candle Wax Fire Place Ashes Sanitary Napkins/Tampons

Cat Litter Gloves - Latex/Rubber Seafood Shells

Cigarette Butts

Cooking Grease/Oil/Lard

Hair Clippings/Pet Hair

Syringes/Needles & Tip Guards

Wipes - Baby, Cleaning, Sanitary

Dental Floss Non-Dissolving Tissue/Toilet Paper Wood Objects

Diapers, socks, rags, or cloth Paper Towels Waste Food Products

The above and similar items will cause blockages that could back up into your home or cause environmental damage. While most of these items seem obvious you might be surprised how often they turn up, and the expense that is incurred to remove them or replace damaged pumps and equipment. Highlighted items may not be as obvious and as a result cause significant operational problems. A simple step you can take to reduce the amount of grease that goes down the drain is to wipe down greasy dishes with paper towels before washing them.

Never put any of the following liquids into the sewer system:

Antifreeze Gasoline/Kerosene Paint Thinner/Turpentine
Corrosive/Acidic Material Lubricating Oil Solvents Cleaning/Degreasing

Explosives Medicines Strong Chemicals

Flammable Material Paint

These items may interact with other chemicals in the public sewer system causing damage to the sewer infrastructure and creating dangerous conditions for sewer workers.

Also, it is unlawful to have sources of rainwater or groundwater connected to the sewer system. As a reminder here are examples of illegal connections:

Groundwater	Stormwater/Surface Water
Sump Pumps	Yard Drains
Footing Drains	Roof Leaders
Curtain Drains	Downspouts
French Drains	

The best way to deal with 'clean water' is to discharge it over land away from the road.

Water treatment backwash is also prohibited from discharging into the sewer system. Many "whole house" water filters and water softeners have automatic backwash features and this discharge should be directed into a dry well or simply onto your lawn.

Again thank you to the majority of you who are already complying with these guidelines. Thank you in advance to those of you who may have been unaware but are in the process of complying.
