The Town of Stafford, Connecticut is seeking sealed bids for furnishing all labor, tools, materials, and equipment required for the Replacement of Westford Avenue Bridge Over Baker Brook (Bridge No. 134007). Bids will be received by the Director of Public Works, 1 Main Street, Stafford Springs, Connecticut 06076 until 10:30 A.M., local time, on Thursday, March 16, 2023. The bids will be publicly opened and read in the Veterans Room at the Town Hall, 1 Main Street, Stafford, CT 06076 at 11:00 A.M.

**CONTRACTOR SHALL BE PRE-QUALIFIED BY THE DEPARTMENT OF TRANSPORTATION FOR GROUP No. 8 – MINOR BRIDGES CONSTRUCTION OR GROUP No, 8A – BOX CULVERTS.**

Each Bidder must deposit with his/her bid a certified check, or a bid bond, for not less than ten percent (10%) of the bid as provided in the Information for Bidders.

The attention of the Bidders is called to the requirement for minimum wage rates to be paid under this Contract.

No Bidder may withdraw their bid within one hundred twenty (120) days after the actual date of the opening thereof.
