TO: The Honorable Deborah Figgs-Sanders, Chair, and Members of City Council

**SUBJECT:** A resolution approving a supplemental appropriation in the amount of \$3,000 from the unappropriated balance of the Art in Public Places Fund (1901) to the City Development Administration Department, Arts, Culture, and Tourism Division (100-1777); and providing an effective date.

**EXPLANATION:** The Public Arts Commission approved an appropriation of up to \$7,500 be used for restoration and conservation after extensive review of the condition of the Elder Jordan sculpture at its January 9, 2024, meeting. Staff received 3 quotes and chose the original fabricator, American Bronze Foundry with a quote not to exceed \$3,000, to travel to the site, clean the sculpture, apply new patina to sculpture, seal with several coats of wax and drill a weep hole in hat.

Specifically, at the end of November 2023, both the artist Jon Hair, and American Bronze Foundry president, Charlie Wambold reported mineral building up on the surface, the protective coating gone, and the patina wearing in areas of the sculpture. Ashley Burke, Public Art Consultant, reported the same conditions in her December 2023 Public Art Condition and Maintenance Report.

**RECOMMENDATION:** Administration recommends that City Council approve the attached resolution approving a supplemental appropriation in the amount of \$3,000 from the unappropriated balance of the Art in Public Places Fund (1901) to the City Development Administration Department, Arts, Culture, and Tourism Division (100-1777); and providing an effective date.
