

**CITY ORDINANCE SECTION 17-227 APPLICANT PROCESSING FEE**

Each applicant shall furnish all the information required by the forms as well as pay a **non- refundable** processing fee as set by the Mayor's office, which accurately reflects the administrative costs involved. The applicant shall have the right to appeal a decision to deny or revoke a permit. The appeal shall be on a form provided by the City Clerk and must be filed with the City Clerk within ten days of the decision. The decision of the City Administrator or designees shall be final.

It shall be unlawful for any person to engage in the business of a phrenologist, astrologer, palmist, soothsayer, fortune teller, character reader, spirit medium, absent treatment healer, or mental healer, or any occupation of a similar nature for hire in the City without first obtaining a **City business tax receipt**.

**CITY ORDINANCE SECTION 28-6. INVESTIGATION OF APPLICANT**

If the Police Department finds that the applicant meets the requirements of this Chapter of the Code 28-6, it shall issue a Fortune Teller permit to the applicant. The Police Department will **refuse to issue a fortune teller permit** to an applicant for any of the following reasons:

- (1) The applicant has been convicted of any offense involving the commission of a **felony** within the **past five years** or a **misdemeanor** withing the **last three years**.
- (2) The applicant is on parole or probation for a felony or misdemeanor; is covered by a diplomatic immunity, or is less than eighteen(18) years of age.
- (3) The applicant has been designated as a sexual predator.
- (4) The applicant has submitted false or materially misleading statements in the application.
- (5) If an applicant has been **arrested** prior to or **subsequent** to the submission of his initial application or application for renewal, said application shall be **held in abeyance** until a **prosecutorial decision or a judicial determination has been rendered**.
- (6) The Permit shall be valid until the end of the fiscal year of the City and shall expire on the last day of September following the issuance; however, permits issued or renewed during the months of August and September shall expire on the last day of September of the year following their issuance or renewal. The permit must be renewed each year.
- (7) Upon the issuance of the permit, the fortune teller shall obtain a photo identification permit card from the Police Department.
- (8) The permit is the property of the City of St Petersburg and is not transferable to any other person. It shall be surrendered to the Police Department.
- (9) If you change employers while your permit is valid, you must resubmit you application with the new employer and pay a fee of \$2.50 for a replacement /change fortune teller permit.
- (10) A license holder shall make application for a renewal of the permit at least 30 days but no more than 60 days prior to the expiration of the permit.
- (11) Permits may be revoked of the permit holder is found to have violated any of the criteria after the issuance of the permit.
- (12) Pursuant to Florida Statute 119.071, your social security number has been requested for identification purpose only. The information will not be used for any other purpose.
