A RESOLUTION APPROVING THE PURCHASE OF 94 PARK BENCHES FOR THE ST. PETE PIER™ FROM LANDSCAPE FORMS, INC. AT A TOTAL COST NOT TO EXCEED \$145,000 UTILIZING THE NATIONAL COOPERATIVE PURCHASING ALLIANCE REGION 14 ESC CONTRACT NUMBER 07-53; AUTHORIZING THE MAYOR OR HIS DESIGNEE TO EXECUTE ALL DOCUMENTS NECESSARY TO EFFECTUATE THIS TRANSACTION; APPROVING A SUPPLEMENTAL APPROPRIATION IN THE AMOUNT OF \$400,000 FROM THE UNAPPROPRIATED BALANCE OF THE GENERAL CAPITAL IMPROVEMENT FUND (3001), RESULTING FROM INTEREST EARNINGS ON THE DEBT PROCEEDS FOR THE ST. PETE PIER™ PROJECT TO THE PIER APPROACH PROJECT (15377) TO FUND THIS PURCHASE AND OTHER FURNITURE PURCHASES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City desires to purchase park benches for the St. Pete Pier™ utilizing the National Cooperative Purchasing Alliance Region 14 ESC Contract Number 07-53 ("NCPA Contract"); and

WHEREAS, pursuant to Section 2-219(b) of the Procurement Code, the Mayor or his designee is authorized to utilize competitively bid contracts of other government entities; and

WHEREAS, Landscape Forms, Inc. has met the specifications, terms and conditions of the NCPA Contract; and

WHEREAS, a supplemental appropriation in the amount of \$400,000 from the unappropriated balance of the General Capital Improvement Fund (3001), resulting from interest earnings on the debt proceeds for the St. Pete Pier™ Project to the Pier Approach Project (15377) is necessary to fund this purchase and other furniture purchases; and

WHEREAS, the Procurement and Supply Management Department, in cooperation with the Engineering & Capital Improvements Department, recommends approval of this award to Landscape Forms, Inc.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of St. Petersburg, Florida, that the purchase of 94 park benches for the St. Pete Pier™ from Landscape Forms, Inc. at a total cost not to exceed \$145,000 utilizing the National Cooperative Purchasing Alliance Region 14 ESC Contract Number 07-53 is hereby approved.


BE IT FURTHER RESOLVED that the Mayor or his designee is authorized to execute all documents necessary to effectuate this transaction.


